PLAYER CODE OF CONDUCT RULES AND WAIVER

SPRINGFIELD GOLF CENTER REQUIRES BOTH THE JUNIOR MEMBER AND THE PARENT OR GUARDIAN TO SIGN THE FOLLOWING RULES OF CONDUCT AND LIABILITY WAIVER AGREEMENT. PLEASE SUBMIT AN EXECUTED HARD COPY WITH YOUR JUNIOR MEMBERSHIP APPLICATION.

RULES OF CONDUCT

- Players and Parents are responsible for their behavior and actions at Springfield Golf Center. We all desire to have fun, develop in golf, and be as successful as possible, but we must do so in a positive manner.
- Players are expected to follow all rules and guidelines; proper golf attire, etiquette & behavior is mandatory.
- Players are expected and required to behave lawfully at all times. Unlawful or inappropriate behavior may result in immediate suspension or termination of his or her Junior Membership.
- Hazing and bullying are prohibited. Players must never behave in a violent or aggressive manner toward others, including use of foul or abusive language toward, and physical contact with, other golfers.
- Players are not permitted to make remarks about race, religion, gender or ability. Players are not permitted to send harassing emails or text messages to other players or post similar inappropriate comments about other golfers on the internet.
- Damage to personal property, and damage to any of the facilities of Springfield Golf Center, will not be tolerated.
- The use of mobile telephones during golf and/or golf clinics is not allowed unless in an emergency.
- The use of cameras or video-taping devices is not permitted at any time unless authorized by those in the photo or video. Players may not circulate or post photos or videos of other golfers/members on the internet or otherwise without permission by those in the photo or video (and their parents if such persons are under 18 years of age).

WAIVER

1. Assumption of Risk – As the parent or guardian of the above named minor or dependant, I assume full responsibility for the decision for my child/dependent to participate in Springfield Golf Center’s Junior Golf Membership/Enhanced Junior Membership program(s). I acknowledge that participation by my dependent in the activities listed above may entail known and unanticipated risks, which could result in physical injury, death or property damage. I understand that such risks cannot be eliminated without jeopardizing the essential qualities of the activity. The risks may also occur as a result of my dependant’s own actions, inactions or negligence, as well as actions, inactions or negligence of others, weather conditions, condition of equipment, condition of the facilities and grounds, national disaster, and any first aid emergency treatment which may be administered. There may also be other risks that are not foreseeable at this time.

2. Release – As part of the consideration for my dependant participating in the activity identified above, I release, discharge, and hold harmless Springfield Golf Center, any director, officer, employee, or any person acting in any capacity on their behalf (hereinafter collectively referred to as “SGC”) from all demands, causes of action, suits, contracts, agreements, obligations, covenants, defenses, costs, liabilities and judgments, whatsoever, known or unknown, suspected or unsuspected, in contract or in tort, in law or in equity, which I might have against the SGC, arising from my child/dependent’s participation in the Programs.

3. Waiver and Indemnification – I hereby waive all claims and demands against SGC for any loss, damage, injury (including death) or claim of any kind arising from, related to or caused by my dependent’s participation in the Programs and agree to indemnify, defend, and hold harmless SGC from all loss, liability, damages, costs, and expenses (including actual attorney’s fees) arising from or related to same.

4. Photography/Video – In permitting my dependent to participate, I understand that my dependent’s photograph/video may appear in publicity or brochures marketing SGC programs and facilities. I understand that there are no rights granted to me or my dependents to inspect or approve photographs/video prior to publication.

5. Term-I have read this Agreement and agree to be bound by its terms. This Agreement shall be effective for all golf activities in which my dependent participates throughout the entire 2013 calendar year. I freely execute this document.
