Terms and Conditions

All fees are payable 1 month in advance.

4 weeks notice is required for any changes to bookings or if your child is leaving or moving setting.

All sessions are subject to availability.

Minimum Booking



Our enrolment requires a minimum booking of two 8-hour sessions a week.

Sole Provider

Please note that we have chosen to operate on a Sole Provider Policy as we believe that children benefit from as much time as possible in their secure attachment with our staff and children.

At Luans Little People therefore we do not accept children who are also attending another Early Years Ofsted Registered Setting unless a child requires specialist additional support.

Funding

We will be offering our funding on a stretched hours basis.

This means the funding sessions are to be used across 50 weeks of the year and entitles each child on 15 hours funding to the equivalent of 11.4hours per week.

This can be taken over one full day and a half day.

Children eligible for 30 hours funded (Preschool only) will be stretched over 48 weeks and receive 24 hours a week. (2weeks closure at Easter and Christmas)

This can be taken over 3 full days.

To claim funding you will be required to provide a code, this code will require refreshing every 3 months.

Funding for eligible children from 9 months old

This funding will begin from September 2024

Children will receive funding from the term after they turn 9 months old.
