

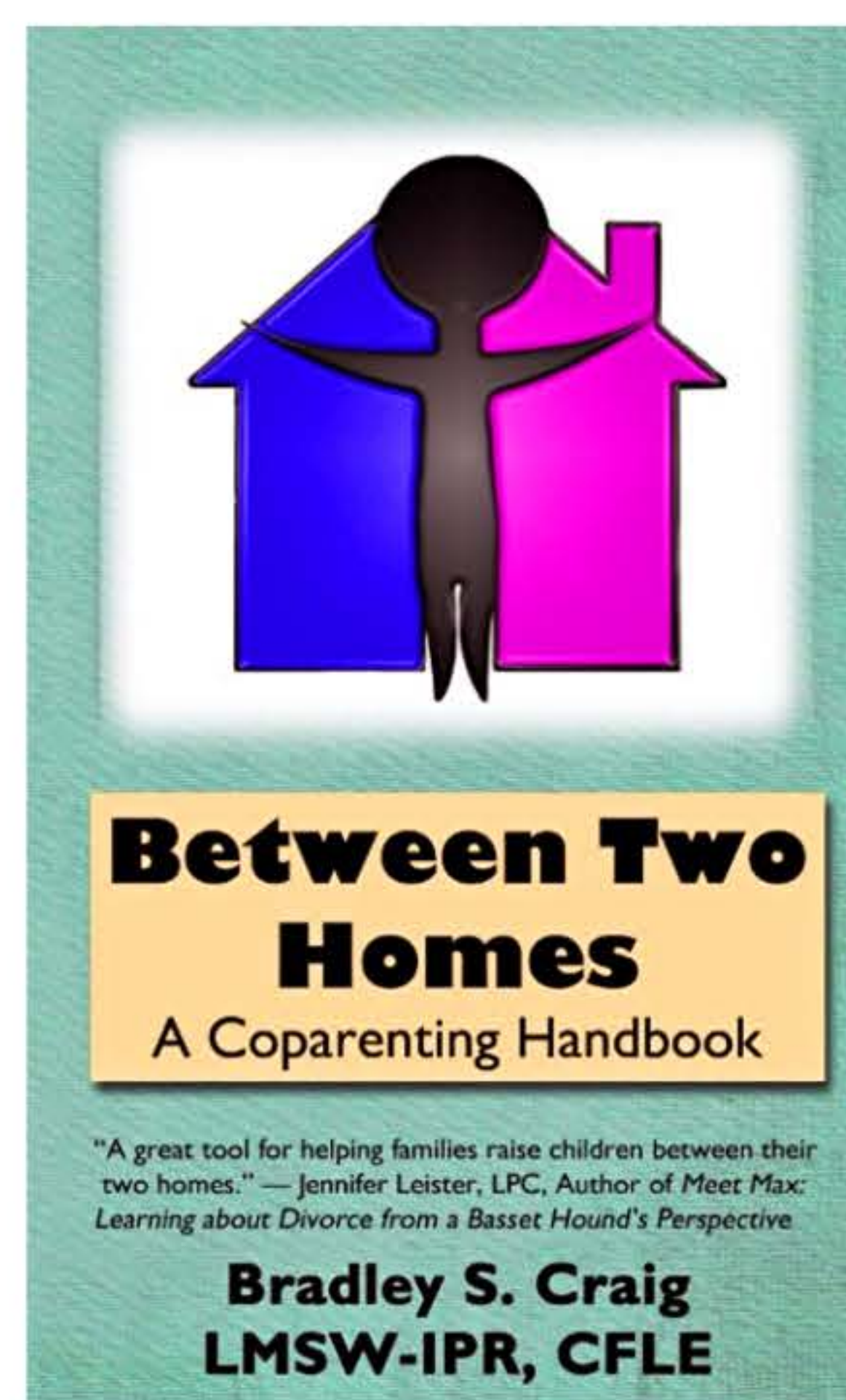

Coparenting Consultation

- The licensed professional provides the parents with coparenting focused education and aids in communication.
- The service aims to promote negotiation and better understandings of coparenting issues.
- This process assists in designing a coparenting plan that outlines current and future details regarding how parents are going to raise their child between their two homes.
- Services can be voluntary or court ordered.

Coparenting Coaching

- The licensed professional meets with a parent individually to promote the parent's coparenting skills.
- The service can assist the parent in improving communication with their coparent.
- This process offers suggestions to improve the situation with their child's other household.
- The licensed professional helps the parents recognize behaviors that may cause more conflict or make life more difficult for their child growing up between two homes.
- Attorneys refer to this service when their client may benefit from insight into how their actions may lead to consequences in a family law case.

Parenting Facilitation

- The licensed professional provides case management to high conflict parents.
- The service offers a problem-solving intervention to parents raising children between homes who may benefit from assistance in working together to keep their children free from the parents' conflict.
- The process provides training regarding problem solving, conflict management, and parenting skills.
- The parenting facilitator works to educate parents, meets jointly with both parents to develop an ongoing plan, monitors communications, and assigns tasks for parents as needed such as homework.
- This service requires a court order signed by a judge outlining the duties of the parenting facilitator and often the parenting facilitator serves as an extension of the court.
- The service is non-confidential.

Parenting Coordination

- The licensed professional offers a hybrid of coparenting education and mediations skills to explore possibilities for problem solving and developing methods of collaboration in coparenting.
- This confidential service is similar to parenting facilitation, without the case management aspect.
