

To participate in the Botox Savings Program and save on your treatment costs, please follow these simplified steps:

1. Start Enrollment

- Visit the Botox Savings Program website at BotoxSavingsProgram.com
- Directly click on "Enroll Now" on the homepage.



2. Complete Eligibility Questions:

- Immediately after clicking "Enroll Now," you will be prompted to "Answer Eligibility Questions."
- Fill in the required details regarding your Botox treatment, personal information, insurance, and treating physician.

3. Submit Documents for Reimbursement:

- After your Botox treatment, collect the following documents for reimbursement submission:
 - Office Superbill: Acquire this from the office where your treatment was provided.
 - Insurance Explanation of Benefits (EOB): Obtain from your insurance company after submitting your chart notes and superbill.
 - Specialty Pharmacy Receipt: Include this receipt if a specialty pharmacy was used.

Additional Information:

Obtaining the Explanation of Benefits (EOB):

- Submit Chart Notes and Superbill: Send the chart notes and superbill from your Botox treatment to your insurance company to receive your EOB.
 - Insurance Processing: Your insurance will process these documents and provide an EOB.
