If Client uses Artist for less time than booked for, the price will be adjusted accordingly. However, Client must pay for a **minimum of 1 hour** even if Client uses Artist for less than 1 hour.

**\*A 50% retainer fee is due at the time of booking and is non-refundable.** The retainer may be paid with a check (payable to Any Time Any Face). The day will not be reserved for the Client until the retainer is paid.

**Cancellation:** If the Client cancels for any reason the retainer is non-refundable. If the event is rescheduled within a reasonable amount of time the deposit will be credited. If the event is cancelled within 24 hours of start time, payment is due in full.

**Should the Artist get sick,** the retainer will be refunded and every effort will be made to find a replacement.

**Rain date:** If your event is not rain or shine please be aware that availability can not be guaranteed without a 2nd (non-refundable) retainer to hold the rate date.

**Travel time:** If round trip travel miles are > 40 miles from Englishtown, NJ 07726 (as per mapquest) to the location of the event the Client understands that they will be charged \$2 per each additional mile.

**Overtime:** Any time beyond the time booked will cost \$125.00 per hour, to the nearest minute.

When asked to paint children and adults the children will be painted first.

**Breaks:** Artist will have paid breaks of 5-10 minutes every two hours.

**Returned Checks:** There will be a \$30 fee for returned checks, plus the amount of the check.

**Parking:** Parking must be provided for the artist near the event location, so equipment may be unloaded. The Client will reimburse artist for any parking fees.

**Removal:** Face paint can be removed with mild soap and water. Some paint will leave a residue which can be removed with a little baby oil or makeup remover. Glitter tattoos & Airbrush tattoos can be removed with baby oil.

**Limitation On Artwork:** Artist will not paint on any part of the body that is not legal to expose, or anyplace she does not feel comfortable painting. Artist will not paint any design or wording that is obscene, offensive or defies good taste. Artist will not paint any designs she is not comfortable painting.

**Extreme Adverse Working Conditions:** Artist has the right to cease painting and leave without refunding any monies if there are extreme adverse working conditions and the Client fails to remedy the situation after it has been brought to the Client's attention. Adverse conditions included but not limited to: destructive, violent, or extreme inappropriate behavior of a child or adult; illegal activities; dangerous conditions.

## Liability Statement

Artist is not liable for allergic reactions to paint/ink/adhesive. Children with skin allergies or sensitive skin should either not participate, or have the Artist perform a patch test at the beginning of the party. For safety reasons, artist will not apply paint/ink/adhesive to children under 2 years of age. For sanitary reasons, artist will not apply paint to anyone who is or appears to be sick or suffering from: cold sores, conjunctivitis; any infectious skin condition, eczema, or open wounds. Artist will use reasonable care, but is not responsible for damage to clothing or property. The Client agrees to pay for any accidents or injuries caused by pets or guests, and/or any damage to Artist's equipment supplies caused by pets or guests.

**Artist will not supervise children.** Their behavior and safety is the Clients' and /or Parents' responsibility. Artist cannot see other children and what they are doing while she is painting. Please supervise all children of all ages.
