Rocky Mountain Refuge provides shelter (including means) for those homeless individuals with a terminal illness in need of hospice care. Rocky Mountain Refuge opened a pilot project in early 2022 and was able to stay open for most of the year. They provided housing and custodial care for 12 individuals who were unhoused or housing insecure and needed hospice care. Of those served, 70% died while in our care and 30% were discharged. Of those discharged one discharged himself from hospice care and the rest were discharged to hospitals.
