STATE AND LOCAL RULES

1. The exhibit competitions of the Colorado River Fair shall be open to all residents of the State of California's 54th District Agricultural Association (DAA). The 54th DAA is all of the portion of Riverside County east of the Coachella branch of the All-American Canal and east of a line due north from the northern most point of the Canal, and those specified in rule #2 in so far as they conform to the rules and regulations set forth in the Exhibitor's Handbook.
2. **Non-Livestock Entries** are open to the legal residents of the 54th DAA; Palo Verde, CA; Parker, Poston, Quartzsite, Cibola, and Ehrenberg, AZ.
3. Exhibits may not have been entered in any previous 54th DAA fair.
4. Unless otherwise noted, exhibits must have been home produced or completed by the exhibitor during the twelve months immediately prior to the opening of the 2024 Fair.
5. Any entry which is, in the opinion of fair management, offensive to the public or a safety hazard will not be displayed.
6. Presentation of a completed entry form shall be deemed acceptance of all rules both local and State. Acceptance includes permission to use your name, photograph, and entry in publicizing the Fair.
7. Entering exhibits does not constitute free admission to the fair.
8. Exhibitors may not remove an exhibit before the Monday following the fair. If an exhibitor or his/her designee cannot pick up the entry on time, contact the fair office at 922-3247. Unclaimed exhibits become the property of the fair.
9. Entries may be made only in those divisions and classes appearing in this Exhibitors Handbook. Fair management reserves the right to refuse exhibits entered in violation of Local and State Rules. A copy of the State Rules may be obtained at the Fair office 591 N Olive Lake Blvd. Blythe, CA 92225.
10. The Fair will take reasonable precautions to insure the safety of exhibits but the 54th DAA assumes no responsibility for loss, theft or damage which may occur from any cause. Upon this condition only are entries accepted into the fair.
11. The CEO of the Colorado River Fair 54th DAA has the final and absolute right to interpret these rules and regulations and arbitrarily settle and determine all matters, questions and differences.

JUDGING

1. Two forms of judging the entries take place.
 - American System– To rank exhibits against one another and award one first place, one second place, etc. This system may rank exhibits 1st to 6th place.
 - Danish System – To compare each exhibit on its own merit against the judging criteria and award as many first place, etc. as merited.
2. Judging criteria is provided under the individual department/division sections.
3. Open adult, young adult, and junior divisions are judged using the American system.
4. 4-H and FFA divisions are judged using the Danish System.
5. Blue Ribbon Kids and 4-H primary divisions are not judged but the exhibitor receives a ribbon.
6. The judge has the authority to;
 - Disqualify or transfer to the correct class any exhibit that does not meet the requirements of the division or class in which it is entered.
 - Disqualify an exhibit that is not clean when appropriate or shows signs of wear.
 - Make no award if the exhibit does not merit one.
7. Disqualified entries will not be exhibited.
8. The judge's decision is final. Fair Management may not request any changes in the judge's rulings (2016 State Rules page 7).

AWARDS /PRIZES

1. Entries placing 1st – 6th will receive a ribbon.
2. Best of Show winners will receive a monetary award from the Friends of the Fair.
3. NEW FOR 2024 - 3 awards will be given from the Peggy Abbs Memorial Fund. Recipients will be chosen from the Juniors division.



Entering Exhibits

1. Entries must be made on a Non-Livestock Department entry form provided by the Fair. The form is on the last page of this handbook. The handbook is available online at www.coloradoriverfair.com, the Fair office, the Chamber of Commerce, and the library.
2. The form **must** contain:
 - Exhibitor's first and last name.
 - Exhibitor's contact information (address and phone number).
 - Birth date if the exhibitor is entering Junior or 4-H classes.
 - The division and class number for each item being entered.
 - A description of the entry (e.g. chocolate chip cookies, carrots, strawberry jam, etc.).
 - The exhibitor's signature.
 - The signature of a parent or guardian for junior exhibitors.
 - The signature of the leader or teacher for 4-H or school entries.**Entry forms without the above information will not be accepted.**
3. The form has lines for up to 9 different entries. The same form can be used even if entering different divisions and classes.
4. If entering more than 9 items, use another entry form. **Do not** put division and class numbers in the blank areas of the form.
5. The division number indicates the department being entered and the appropriate age/classification of the exhibitor. Make sure you enter the correct division number.
6. The class number describes what the exhibit is. Make sure you enter the correct class number. The number of entries allowed per class can be found in the department specific rules.
7. When entering more than one (1) item in a class you must use the division and class number twice on the entry form. Do not write down the division and class number and put a 2 in front of it or behind it. **Every exhibit must be entered individually.**
8. Exhibits entered in the **any other than the above** class must **not** fit in any of the classes provided in the division. For example, if 2 photographs of birds were entered in the class for bird photographs you may not enter a photograph of a bird in the any other than above class. Misuse of the any other than the above class will result in disqualification of the exhibit and it will not be displayed.
9. Completed entry forms are typically due on February 23, 2024, in the Fair office a month prior to the fair. The actual date is available in the department specific rules in this handbook.

10. Completed entry forms can be mailed, or hand delivered to the Fair office. The Fair's address is 591 N, Olive Lake Blvd, Blythe, CA 92225.

BRINGING YOUR EXHIBITS TO THE FAIR

1. Non-perishable exhibits (e.g. photography, fine arts) are typically brought to the fairgrounds exhibit building 2 to 3 weeks prior to the fair's opening.
2. Perishable exhibits (e.g. baked goods and floriculture) are typically brought to the fairgrounds exhibit building the Tuesday before the fair opens.
3. **The specific dates and times are located in the department specific rules for each department.**
4. Exhibitors will receive a claim check for each exhibit brought to the fair. The claim check will allow you to pick up your entry the Monday after the fair closes. If you are unable to pick up the exhibit yourself, give the claim check(s) to the person who will be picking the exhibit up.
5. Exhibits may not be removed from the exhibit building until the Monday after the fair.
6. The specific date and time the exhibits may be picked up is located in the department specific rules for each department.

AGRICULTURE

Rules:

1. The exhibitor is responsible for maintaining perishable exhibits in a **fresh** condition for the duration of the fair and replaced as necessary. Failure to comply with the rule may be considered reason for disqualification of the exhibit and forfeiture of award. When fruits and vegetables spoil, Fair management has permission to dispose of them.
2. **Exhibits are to be displayed on a plate.** Leafy greens (lettuce, cabbage) require 1 head per plate. All other fruits and vegetables require 3 per plate.
3. Unless otherwise stated, the type of fruit or vegetable desired for exhibit will be the uniform commercial grade rather than overgrown.
4. **Each exhibitor may have 1 entry per class except ANY. 3 different entries are allowed in ANY**

3. If space becomes short, a screening jury must be set up to examine all entries to determine which entries shall be placed on display. The screening jury's decision is final.
4. No wet work will be accepted.

FINE ARTS CONTINUED

5. Exhibits, other than sculpture, will not be accepted unless they are **framed and securely wired for hanging.**
6. WATERCOLORS, PENCILS, INK AND CHARCOALS, AND ANY OTHER WORK ON PAPER MUST BE UNDER GLASS.
7. Paintings must be labeled securely on the back in the upper right hand corner, and sculpture on the bottom, with the following information.
 - Name and Address
 - Division and Class Number
8. Sculptures must be 3 dimensional and made of sturdy material (stone, metal, wood, pottery)
9. Two different entries per class may be entered.

RULES:

1. Photography must be the work of the entrant. Processing, developing and matting may be done professionally.
2. Photography must have been taken within the last two (2) years.
3. If space becomes short, a screening jury will be set up to examine all entries to determine which entries shall be placed on display. The screening jury's decision is final.
4. Photos must be matted on material at least the weight of poster board. Commercial photo mats, foam board, core board and poster board may be used. **Construction paper or picture frames may not be used.** The mat must be firmly affixed to photograph. Please use rubber cement or something similar. Rolled tape will not hold for the duration of the show and the Fair will not be responsible for re-affixing photos that have fallen from their matting. Mounting will be judged on neatness and suitability to photograph.
5. Photographs entered must be at least 5" x 7" in size and may not exceed 16" x 20" in size.
6. 2 exhibits per class

Description of classes offered

1. People at Work/Play - One shot, what are they doing? Tell the judge about these people visually.

PHOTOGRAPHY CONTINUED

2. Children/Families – To be a winner, it should make a visual statement. More than 1 person must be in the picture.
3. Landscape – It is the sky, mountains, trees, valleys, meadows, canyons, streams, lakes, rocks, etc. and how they relate to each other. It can have an animal(s), but that shouldn't be the subject or have attention drawn to it
4. Seascape – The subject is the sea, not the fish.

11. Action - Something should be doing some serious moving here. Running, racing, jumping....Moving !
12. Sunrise/Sunset – The desert has amazing sunsets and sunrises. Use them.
13. Portrait of Adult – Posed picture of person(s), especially the face.
