- PHD, Masters, or Bachler's or Associates & 5 years of work-related experience where 30% of your job duties are required to manage safety, health, or environmental responsibilities. Resumes, copies of your degree and three letters of support from present or past employers validating your experience are required.

- **MILITARY EXPERIENCE:** Army, Marines, Navy, Air Force, Coast Guard, Space Force, National Guard and Reserves: If you have held any of the following Military Occupational Specialty Group You qualify for obtaining the CEHSP:

- **OTIEC or TRADE UNION EXPERIENCE:** Must have an Advanced Professional Certificate, Professional Certificate in General Industry or Construction from a leading OSHA Training Institute Education Centers or Labor Union / Trade School or have achieved your Certified Safety Health Official (CSHO) from a leading OSHA Training Institute Education Centers or Labor Union / Trade School or have achieved your Certified Safety Health Official (CSHO). Resumes and three letters of support from present or past employers validating your experience are required.
