PROPOSED AND PRINCIPLE TO RULES AND REGULATIONS

INTUE PROPERTIED

MOTION 1: The making and creating of an execusive or unusually loud noise within any grounds owned or controlled by the Sunset Lake Association as heard without measurement or heard and measured in the manner prescribed in Section 3 (a) and (b), is hereby declared to be a violation of the Eulocand Deputations of Sunset Lake Approximation except when made under and in compliance with Section 4.

SECTION 2: No person shall operate any type of vehicle, whehine, device, instrument, or carry on any other setivity in such a manner as would be a violation of Section 1.

DACTION 38

- (a). The noise may be measured on a decible or sound level mater of standard decign and quality operated on the WAR weighting scale.
- (b) Excessive or unusually lood noise shall be that which is in excess of 30 decibels on the "A" weighting scale in intensity at a distance of 25 fout from the private property line from which the source is located, or the source itself if located in a public area.
- (a) Provided, however that a violation of this rule may ester without the above measurements being made.
