ANNUAL MEETING on OCTOBER 19th, 2006!

ADDING CHEMICALS TO THE LAKE

This year we've experienced problems with an unusual amount of moss on the surface of the lake. Mostly this was due to hot temperatures and lack of rainfall. Please do not try to treat this yourself. Members are not allowed to throw copper sulfate or other chemicals in the lake without permission from the Board of Directors.

WEED PROBLEM

The weed problems have been discussed and the board is looking into what options can be taken to help control the weeds. This will be talked about at the annual meeting.

SEPTIC SYSTEMS

Regular inspections are done on the Sand Filter and Aeration septic systems. **Chlorine tablets need to be in your bottles or tubes at all times.** This is the responsibility of each member. Let's protect the lake, our public health and property values by remembering chlorine. Please remember that you need to let the office know whenever you have anything done on your septic system.



FALL BRINGS LEAVES

It's that time of year when leaves start falling. Generally the Board waits until after Thanksgiving to do leaf inspections. Because of problems encountered in the past, inspections will be done earlier. Remember to rake your leaves as often as possible to prevent them from going into the Lake.

A leaf fire can get out of control very easily so please be careful. Please do not burn your leaves in **or** on the edge of the road.

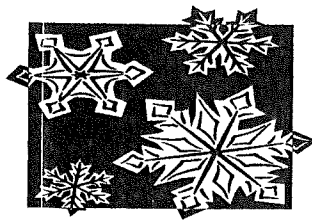
If you would need someone to take care of the leaves for you, please contact the office for referrals.
