- III. Approval of 2021 Minutes, Secreatary Joe Kovacs asked for a motion to approve the 2021 Annual Meeting Minutes. Motion made by Sue Muschong, Seconded by Jerry Winterland, motion passes
- IV. President's Remarks -- Joyce Munie
 - * Thanks for letting me serve. Thanks for Sue and all remaining board members and thanks to all the members that stepped up to run for this election. Reminder to everyone to keep up on your leaves and also to keep up on the chlorine. These are both crucial to maintaining the health of the lake. Currently we are lowering the lake to work on the tower. This is for our continued maintenance of the dam / spillway and mechanical systems.  - *Also we are asking for a ByLaws Change to have the minutes from the Annual Meeting to be approved and therefore made available at the next monthly meeting
 - *I want to personally thank Harold Bly for his service to the Board. He has made the lake safer by patrolling and helping members understand the rules.
 - * Also a big thank you to our Administrator of Leases--- Amy Walkenbach
 - * As we count ballots, the member that recives the least amount of votes will complete Thane Johnson's vacated seat ending Nov 2023. The other 3 will have 3 year terms

V. Finance Report - Sue Muschong Good morning Sunset Lake,

Financially Sunset Lake is very healthy excluding Fireworks. At the end of September we collected \$141,605.31 in Operating Income and have paid out \$75,425.41 in Operating Expenses. Leaving \$66,179.90 for the last quarter. The work that is being done now is on the Spillway Tower and we have accumulated just over \$111,0000.00 in funds which is more than enough to cover the costs. If anyone is interested The September Treasurer's Report and 3rd Quarter Budget report are on our Website. As always if you have any questions or need further information, please call me. Today I also want to talk about the Spirit of Sunset Lake and it's journey these last 5

years. Joyce and I are the last 2 Board members who were part of this journey. Our journeys started in early 2018 when we were appointed to the Board along with other Board members. It was a stormy time in Sunset Lake's history. Our monthly meetings

(2018 thru 2019) were full of angry members, who had no problem shouting at us, calling us liars and swearinf at us. Meetings lasted well past 9 pm. Every month we wonder what the next meeting would bring. Our main motto was Transparency with that we would gain respect & trust of the Lake's members.

We kept going one step at a time trying to heal the Lake's soul and bring peace to our members. As a Board in 2020 we started to see the wounds heal and meetings were quieter with less members feeling the need to come. The first meeting that was just under a hour we were kiddy.
