CAMP at Newfound Lake Park agrees to rent to GUEST, site number\_\_\_\_\_ from May 1<sup>st</sup> through October 15<sup>th</sup> 2024. The Rental Term shall be on a day to day basis which may be terminated at any time by the Park for violation of park rules.

### **GUEST agrees to the following terms and conditions:**

If your RV is older than 10 yrs, your booking is contingent on us approving the visual condition of your RV. To obtain approval, simply send pictures of your RV to info@camp-nh.com. Failure to do so could result in you being turned away upon arrival.

Camping has inherent risks associated with outside activities. We are not responsible for injuries or damages occurring as part of the inherent risks of any camping environment, YOU MUST READ ALL RULES BEFORE SIGNING THIS WAIVER. This property is privately owned. The camper accepts camping privileges with the understanding that he or she does hereby release Camp at Newfound Lake, it's officers, family members, volunteers, fellow campers and employees of all liability for the loss or damages to property and injury to his/her person arising out of his/her use of its camping facilities and agrees to indemnify the campground, its officers, family members, volunteers, fellow campers and employees, against any claims resulting from loss or damage to property or injury to the person(s) or visitor(s) of any member of the camper, arising out of the use of its camping facilities and any activities, games, or events sponsored by The Park. I agree to pay for any damages by my party to campground property, sites, buildings, facilities, equipment or loss of equipment which may occur. I also agree to immediately report any accident, injury or property damage to the manager or staff. If a hazard or dangerous situation exists on the premise, the said camper will notify the management or staff immediately. I also agree to take full responsibility for myself and all the people in my party, including minors and visitors, and will require them to read and comply with all campground rules and regulations as posted in the office or on the grounds, as well as the terms and conditions as set forth in this registration.

Cancellations made 7 days or more prior to your arrival date will be fully refunded less a \$25 cancellation fee. Reservations cancelled within 7 days of your arrival date are non refundable.

Holiday Weekend reservations must be cancelled 14 days prior to your arrival date to receive a refund, less \$25 service fee. Holiday Reservations cancelled within 14 days of your arrival date are non-refundable.

Holiday reservation dates may not be changed or moved within 14 days of your arrival date.

Failure to check in by 11am the morning following your scheduled arrival date is considered a no-show and your site will be made available to others.

No refunds for no-shows.  
No refunds for weather.  
No refunds for early departures for any reason.

Anyone staying longer than 29 days will be metered. Payment of metered electric services must be paid by check or cash , no credit card payments for this service.

**GUEST agrees to the following cancellation and refund policy:**

Cancellations made 7 days or more prior to your arrival date will be fully refunded less a \$25 cancellation fee. Reservations cancelled within 7 days of your arrival date are non refundable.

Reservation dates cannot be changed within 7 days of your arrival date. If you wish to arrive earlier or extend your booking, simply book the additional days.

Holiday Weekend reservations must be cancelled 14 days prior to your arrival date to receive a refund, less \$25 service fee. Holiday Reservations cancelled within 14 days of your arrival date are non-refundable.
