

SYNOPSIS:

This supplementary report will detail observations made by Reporting Officer MOIS at the scene of an ongoing homicide investigation from 303 North 54th Street in Omaha, Douglas County, Nebraska, on Thursday 13MAR08 beginning at 1752 hours. Victims were identified as Thomas HUNTER (white male, DOB 12JUN96) and Shirlee K. SHERMAN (white female, DOB 07APR50).

DETAILS OF INVESTIGATION:

On Thursday 13MAR08 at approximately 1752 hours, Uniformed Officers of the Northwest Precinct were dispatched to 303 North 54th Street in Omaha, Douglas County, Nebraska, in reference to a make an investigation regarding two deceased parties located inside the residence. Upon arrival, officers located the reporting party identified as William J. HUNTER (white male, DOB 21DEC44) who reported that he had arrived home at approximately 1740 hours and upon entering the residence located his housekeeper Shirlee SHERMAN (white female, DOB 07APR50) deceased in the main level hallway. HUNTER stated he then located his son, Thomas HUNTER (white male, DOB 12JUN96), deceased in the main floor formal dining room area.

Uniformed officers then conducted a protective sweep of the residence and located the aforementioned victims, SHERMAN and HUNTER, victims of apparent stab wounds. Omaha Fire Department Medics #34 were also dispatched to the scene and pronounced both SHERMAN and HUNTER deceased.

Uniformed officers then contacted Sergeant Rochair JENKINS of the Criminal Investigations Bureau, Homicide Unit, and advised of the known circumstances regarding the apparent homicides at 303 N. 54th Street. Reporting Officer MOIS was then assigned by Sergeant JENKINS to assist with the scene investigation at that location.

Due to the unknown circumstances regarding the deaths of the two victims to secure a court authorized search warrant for the residence of 303 N. 54th Street, its detached garage, and the three vehicles located on the property. Reporting Officer did prepare an affidavit for a search warrant for the aforementioned residence and surrounding property. The warrant signed by Douglas County Court Judge WHITE at approximately 2030 hours, on Thursday, 13 March 2008. Reporting Officer arrived on scene, 303 N. 54th Street, at approximately 2046 hours, at which time he was briefed by Sergeant JENKINS regarding the known circumstances at the time.

Reporting Officer MOIS, Officer SULLIVAN, and Crime Lab Technicians TOSONI, LOVE-ZACH, and HOFFMAN entered the residence at approximately 2110 hours and made the initial walk through.
