## Bloomdale Village Council Meeting Minutes June 27th, 2023

## Opening

The regular meeting of The Bloomdale Village Council was called to order at 7:00PM by Mayor Stephen Schafer.

## **Members Present**

Julie Dean, Bethany Vincent, Robert Clark and Tom Miller all answered roll call. Jamie Robinson & Kathy Simon were absent.

Bob Clark moved to approve the June 13th minutes & Tom Miller 2nd, all approved.

16-R-23 was read by Bethany Vincent concerning the Eagleville Joint Ambulance District to rescind the previous resolution (15-R-23) and rejoin. Bob Clark made a motion to rescind and rejoin & Tom Miller 2<sup>nd</sup>, all approved.

17-R-23 was read by Bethany Vincent to create a joint ambulance district. Bob Clark made motion to accept and Julie Dean 2<sup>nd</sup>, all approved.

18-R-23 was read by Bethany Vincent to authorize the mayor to enter into a contract to have a part-time cop. It is being tabled due to no law enforcement here.

The fire siren is functioning and working on both sides last week.

Billy Mareches has a contract with North Baltimore's auto aid, they want to update signatures & nothing will change. Steve & Diane will have to sign it so he can then sign it and get it to Cygnet to also sign. Bethany Vincent made a motion to sign the auto aid renewal and Julie Dean 2<sup>nd</sup>, all approved

The remote monitor for the front of the grass rig is installed & fully functional.

Medicare enrollment application was approved and put on Diane's desk.

Nobody on council received anything from Elmwood Schools or 120. Mid County 120 sent a letter to the sheriff's office to do away with the mutual aid agreement at the school so Bloomdale will no longer get called for EMS calls there. Billy is going to try to go to the next school board meeting on 7/10 at 5:30PM to discuss it.

The equipment truck has everything removed and is in the south end.

Jeff Dennis has updates. CSX purchase agreement for the park was sent back to the CSX rep. They have a 60-day due diligence period but he's hoping to get it done before then.

The Post Office, Senator Brown put him in touch with someone at the Post Office where he could email about the feasibility study.

Wood Co. Sheriff's Dept services, discuss packets previous provided. On that note, Sheriff Mark Wasylyshyn is supposed to be at our first meeting in July to discuss coverage in Bloomdale throughout the week/weekend. Hours, price and to answer any questions if we decide to use them.

We are required to send the remainder of the insurance proceeds to Laware's within 60 days of finish.

Justin Good wanted to know if during the town cleanup, old carpet can be dropped off. Yes, they are acceptable.

Megan Leathers also wanted to know about who will be redoing some of the parking line spaces north of SR18 that were tore up by Columbia Gas. She knows her area won't be an ODOT issue, so she wanted to know if it'd be Columbia Gas or the Village of Bloomdale. Not the village's responsibility.

Bob Clark did some research on cameras. It'd be \$2,000 for 4 cameras that he's looking at. Could get a light and motion sensor light too if we want to. We'll table it until the next meeting when Diane is here.

Bob Clark got a hold of American Timber out of Norwalk, Ohio. 30ft polls to put up streetlights in the village. What they have is Class 5.

Doug Finney will have something to Steve by the end of the week.

Sidewalks will be started tomorrow and start to be poured on Saturday.

Bethany Vincent will be going to the next township meeting to discuss the mausoleum on Bloomdale Road.

No updates on the walking path.

Bethany wants to figure out Verizon reception in town and how to improve it. She will try to get answers.

Bob Clark made a motion to pay the bills and Julie Dean 2<sup>nd</sup>, all approved.

Julie Dean moved to end the meeting at 7:59PM.
