WISCONSIN PINTO HORSE ASSOCIATION 2024 MIDWEST HORSE FAIR INFORMATION & RULES

In order to be considered and accepted for participation with WPtHA Midwest Horse Fair Demonstration, each exhibitor/owner must meet the following requirements. Please read this over carefully.

- •Owner and/or exhibitor must be a <u>current</u> Wisconsin Pinto Horse Association member and current PtHA member.
- •Each participating horse must be a <u>current</u> registered Pinto with the PtHA.
- •Each participant and their horse must arrive by Thursday 9 pm, and remain at the Midwest Horse Fair through 5 pm on Sunday.
- •Each participant should make an effort to attend a brief WPtHA/MHF meeting on Thursday evening (time to TBA) to receive final instructions on the Breed Demonstrations, sign-up for a shift in the Hospitality Booth and other pertinent information.
- •Each participant will work a 2-hour shift in the WPtHA Hospitality Booth to provide information about PtHA, WPtHA and the Pinto breed.
- •Participants are encouraged to help with set-up and take-down of Stall & Hospitality Booth decorations on <u>Thursday evening and Sunday evening after 5 pm</u>.
- •All participants will keep the Tack/Feed Stalls and Hospitality Booth areas clean and neat.
- •All participants will provide required information to the WPtHA/MHF Committee Chair in a timely manner as requested.
- If selected, each Owner/Exhibitor will be required to pay a stall fee for their horse.
- •All fees will be paid for by January 24th of that year. If fees are not received by this date, you will not be able to participate. Checks payable to WPtHA.

If your application is approved and you are chosen to participate, each participant/horse will have the opportunity to practice in the arenas where the demo will take place (Times TBA.) There will be 2 Breed Demonstrations scheduled sometime on Friday, Saturday or Sunday (Times/Days TBA) Breed Demo dates/times will be communicated to the participants by the WPtHA/MHF Committee Chair as soon as information is available. Participants will have their horses groomed and utilize equipment and attire appropriate for their selected ability (i.e., Western, Hunt Seat, Halter, etc.) and be ready for the Breed Demonstrations at the time determined by the WPtHA/MHF Committee Chair. Each participant selected will receive 2 MHF Weekend Admission Wristbands <u>per horse</u>. Any other wristbands required will be at the participants' expense. All necessary feed, housing, food, etc., will be at the owner/exhibitors' own expense.

All participants are strongly encouraged to read the Official Rule Book of The Pinto Horse Association so as to abide by the rules therein and understand that their horse/pony is subject to the constitution and rules of WPtHA and PtHA.

ANY CANCELLATIONS WITHIN 14 DAYS OF MIDWEST HORSE FAIR WILL REQUIRE A VETERINARIAN CERTIFICATE OR WISCONSIN PtHA BOARD APPROVAL TO BE ELIGIBLE FOR ANY REFUND.
