**FAITH**, noun [Latin fides, fido, to trust; Gr. to persuade, to draw towards any thing, to conciliate; to believe, to obey.

**TRUST**, Confidence; a reliance or resting of the mind on the integrity, veracity, justice, friendship or other sound principle of another person. He that putteth his *trust* in the Lord shall be safe. Proverbs 29:25.

persuading; the act of influencing the mind by arguments or reasons offered, or by any thing that moves the mind or passions, or inclines the will to a determination.

ASSU'RANCE, The act of assuring, or of making a declaration in terms that furnish ground of confidence; as, I trusted to his assurances; or the act of furnishing any ground of full confidence. Whereof he hath given assurance to all men, in that he hath raised him from the dead. Acts 17:31.

ASSU'RE, To make certain; to give confidence by a promise, declaration, or other evidence; as, he assured me of his sincerity.

HOPE, A desire of some good, accompanied with at least a slight expectation of obtaining it, or a belief that it is obtainable.

**CONVICTION**, The act of proving, finding or determining to be guilty of an offense charged against a person before a legal tribunal; as by confession, by the verdict of a jury, or by the sentence of other tribunal, as in the summary convictions before commissioners of the revenue.
