LendersConnect is an online small business lending community accessible via web or mobile device, featuring opportunities for peer-to-peer dialogue, live networking, educational sessions, mentoring partnerships, access to industry resources and more, available to **more than 3,000 SBA lending institutions nationwide**.

With a typical event, all the networking, engagement, and sponsor interaction is confined to the time when the event starts and ends. *LendersConnect is a natural extension of the regional SBA Lending conferences so you can keep momentum going* via smaller, more frequent touchpoints, continuing and expanding on conversations and new connections, lowering your marketing and acquisition cost and *building new revenue streams*.

Ongoing community engagement can include a mix of different sponsorship strategies including sharing thought leadership content (blogs, videos, resources, links to your podcasts, etc.), hosting networking events and virtual meet-ups, and even some healthy competition via a community game, trivia, live polling, and Q&A. These are all ways you can *remain engaged* to continue growing and strengthening your network.



THE PLATFORM



The platform, accessible via web or mobile, includes the following



Rotating Banner Ads display on the left navigation of the web platform and at bottom of the mobile platform. Ads display for 7 seconds before moving to the next. Ads must be submitted as 950px wide by 380px tall in jpg or png format. Sample banner ad:



Announcements display any LendersConnect announcements to users and will be displayed as notifications on mobile devices – announcements will be made in advance of sessions beginning, or other real-time SBA announcements, etc.



The **Newsfeed** enables all users to interact via a social media type "wall" similar to Facebook or LinkedIn. Sponsors can post contests, questions, invite users to a presentation Zoom meeting, etc. to engage with users, such as this example sponsor's contest at left.

Networking displays a list of all users which can be searched and filtered by name, company, category, location, etc. Inviting users to connect with you will give you access to their contact information and direct messaging.

Live Stream will show the session that is occurring live right now, if applicable.

Sponsor Partners includes a listing of all sponsors with highest level sponsors listed alphabetically first, followed by all others listed alphabetically. Keywords are searchable by users to find what they are looking for – see more about Sponsor profiles on the next page.

Resources includes educational materials, cheat sheets, SBA contact lists, website links, videos, etc. Sponsors can provide approved items to the resources list, based on their level.


The **Schedule** shows all LendersConnect scheduled sessions as well as those hosted by our sponsors. Sponsors may provide a listing of their hosted Zoom meetings or webinars to us for inclusion in the schedule.

User Lists & Contact Information

Users/members will belong to different groups, which could include association affiliations such as "Georgia Lenders Quality Circle", industry categorization such as "Lender – 7(a)", "Lender – CDC", Job Classification such as "C-Level Execs", "SBA Department Manager", location or region, etc. to help you target your prospects. Once connected to a particular contact (similar to LinkedIn), you will have access to their contact information, ability to direct message, etc. You can also export user lists at any time to Excel files and easily upload them to your email platform for direct marketing.

Discounted Rate for EY Conference Sponsors

Number of users/members included with your sponsorship. Users can be from within your company or gifted to clients. Promo Codes for Client Registrations

Speaker or Panelist Opportunity

Provide thought leadership to our membership base by participating in one of our LendersConnect monthly general sessions or weekly Manager Exchange sessions, which are free to all members. Partner and Supporter sponsors may participate in at least one session per month.

Promotion before Monthly Sessions

Prior to each monthly session starting, sponsor ads and logos will be displayed. Partner sponsors may provide a video ad/promo or static slide. Supporter sponsors will receive logo promotion.

Opportunity to Host your OWN Session(s)

Be seen as an expert in your field, advertise your own Zoom sessions, etc. Partner and Supporter sponsors may add their own sessions to the LendersConnect schedule. Submit session details, registration/access information to lendersconnect@eventfullyyourz.com and we will add your session(s) to the ongoing schedule within the platform.

Access to Job Board Posting

Partner sponsors have access to post unlimited job openings for free, interact and video chat/interview candidates directly within the platform. Great for recruiting lenders in a remote working environment. Contributor and Supporter level sponsors can post jobs for \$50 per posting plus \$50/month use of live interview room.

Monthly Email

LendersConnect will send an email out monthly to all members, advertising upcoming sessions and any other pertinent SBA lending news. All sponsor logos will be listed on each email with link to your website. Partner sponsors will also receive up to two featured articles showcasing your company (you can provide a video message, a narrative article, images, reference documents, etc.). You choose the month to coincide with your current promotions, based on availability (no more than 2 sponsors will be featured within one email).

Multi-Year Discount

Partner and Supporter sponsors receive a discount as shown on page 1 when registering for 2 or more years. Registration must be prepaid, and multiple discounts cannot apply. Existing EventfullyYourz conference sponsors registering for multiple years will receive the same already discounted price for subsequent years.
