1. The Dog described above is a purebred Wirehaired Pointing Griffon eligible for registration with the American Kennel Club and the North American Versatile Hunting Dog Association. 2. The Dog has received the appropriate vaccinations and worming, and has been examined by a veterinarian as noted in the health record provided by the Breeder at the time of sale. Buyer's initials \_\_\_\_\_

3. The Buyer agrees to have the Dog examined by a licensed veterinarian within three (3) days of the date of purchase. If an illness or other defect, excluding internal parasites, is found by the veterinarian at that time, the Buyer will provide a written diagnosis from the veterinarian to the Breeder. The Breeder may request a second diagnosis to confirm the first diagnosis. The Buyer then has the option of returning the Dog for a full refund of the purchase price or keeping the Dog and treating the illness or defect. Buyer's initials \_\_\_\_\_
4. The Buyer agrees to provide appropriate shelter and veterinary care throughout the lifetime of the Dog. The buyer has been provided with appropriate guidelines for the care and feeding of the Dog and agrees to follow those guidelines. The Buyer agrees to return the Dog to the Breeder if any difficulties or changes of circumstance occur which prevent the Buyer from providing appropriate shelter and veterinary care for the Dog. 5. The Buyer agrees that the Dog will not be kept exclusively outside in a yard or kennel. The Buyer also agrees to keep the dog in a securely fenced yard or other enclosure and will not allow the dog to be outside unaccompanied in an unenclosed area at any time. The Buyer further agrees that the Dog will not be transported in the open bed of a pickup truck and understands that the safest method of transporting the Dog is in a secure crate inside a vehicle. 6. If at any time throughout the lifetime of the Dog, the Buyer becomes unable or unwilling to keep the Dog, the Buyer agrees to inform the Breeder immediately. If the Buyer has another suitable home in mind for the Dog, the Dog may be placed there, providing the Breeder approves of the new home, and the new owner is willing to agree to the terms of the Breeder's sales contract. Otherwise, the Dog must be returned to the Breeder. Buyer's initials \_\_\_\_\_
7. If the Dog is purchased as a show and/or breeding prospect, the Dog at the time of sale, in the Breeder's opinion, is free of any major faults and shows promise of being able to complete and AKC breed championship. While, at this time, the Dog appears to be of show quality in the opinion of the Breeder, many things can change as a puppy matures. There is no guarantee that the Dog will complete a championship or be breedable as an adult. The Buyer agrees that he/she is purchasing the Dog primarily as a companion and will treat the Dog as such throughout its lifetime, regardless of its ultimate showing or breeding ability. 8. If the Dog is purchased as a show and/or breeding prospect, the Buyer agrees to have the Dog's hips and elbows x-rayed by a qualified veterinarian between the ages of 24 and 30 months and to submit those x-rays to the Orthopedic Foundation for Animals for evaluation. The Buyer also agrees to have the Dog's eyes, thyroid and K-Locus status tested. The Buyer agrees to provide copies of all health test results to the Breeder. The Buyer understands the importance of appropriate health testing prior to breeding. Buyer's initials \_\_\_\_\_
9. Should the Dog fail to pass any of its health clearances or for some other reason be deemed unsuitable for breeding, the Buyer agrees that the Dog will be spayed or neutered. Buyer's initials \_\_\_\_\_
