<u>Sheriff Department</u>: Deputy Nedo introduced new Deputy Gutierrez. Danks had a question concerning trespassers. Deputy Nedo suggested to obtain pictures.

Landfill Report: The PT employee hired will become FT and train as an operator with a pay raise from \$12 to \$13.50 per hour, with board approval. All haulers are up to date. Lagoon haulers have had extra runs due to snow. The new cell is having problems. The DEQ is involved. The scales are not working correctly. Customers are paying by the yard. Repairs will take place on the weekend, which will be billed as overtime. Rainmaker will have a demonstration for the board on water-to-water system. Rainmaker claims it can turn leachate into drinking water. The demonstration did not work. There is concern about PFAS in the water system with leachate being deposited by deep well injections.

County Road Commission: No representative present.

Ambulance Report: Beau Williams reporting. The new ambulance is almost ready to go.

Numbers are up 10 percent. The new 202 charging station is not working. Class is almost done.

There is a possibility of 4 or 5 employees from the class. Mileage reimbursement changed from .34 to .58 per mile. They are looking for an incentive program to retain employees. The Marihuana class in Traverse City had some interesting points. An employee with a medical
