<u>Landfill Report:</u> Reported by Gary Girardin. A part time employee quit for health reasons. Permits were obtained for the injection well. They will drill in August. Cost will be 3 million dollars.

<u>County Road Commission:</u> Reported by Williams. Concerning the east side of McIntire Road, the County would pay half of the cost to fix the road if the Township will pay half. There is not enough money to do this. Extra brine was applied to the hill on the road. The bridge on Greasy Creek Road is not safe.

<u>Fire Report:</u> Reported by Donna Stehle. Truck No. 212 had a DOT inspection. It is in need of repair costing \$12,800. Repairs will be made as it is cheaper than replacing it with a new truck.
