Call to order

Public Comments: Discussion was had in regards to the recent resignation of Drain Commissioner (this does not affect Loud Township). Lawn maintenance schedule was also discussed, Williams clarified the schedule of the newly appointed contractor. Mrs. Zavita brought up a possible Blight issue with a business within the township- this item was moved to new business in the meeting.

Sheriff Department: Deputy Morrison was present and answered a public question relating to the HUNT team.

Landfill Report: Given by Rep. Gary Girardin, The price of tire disposal will be going up to \$4/tire soon. The price of disposal for items with Freon will also be increasing due to scrap prices dropping.

County Road Commission: Ken Werner, Commissioner was present. A new tool for patching has been purchased. Road Commission has hired a new employee. Pocahantas Road was discussed as there is an issue due to a resident attempting to fix the road.

Ambulance Report: Given by Beau Williams. The ambulance service is now having issues with A/C units in rigs. A fraudulent unemployment claim was attempted but, deterred by the administration. ARMC has stopped replacing supplies for the services so costs will increase in

Fire Report- Report given by Elva Duncan. The Fun Run fundraiser is scheduled September 12, 2015. An Ice Cream Social will be held July 18th at the station. A 50/50 grant from the DNR for wildfire gear is being completed by Dave Utt. The department is having issues with the repeater located in Hillman.

Unfinished Business:

911 signs- Hubbard reported that signs and posts have been ordered and all shipments should be received shortly.

Playground Ground Cover- Hubbard reported that she will be checking again on delivery date of mulch.

Cemetery Mowing- Discussion was had in regards to paying resident Paul Klein for his volunteer mowing of the Township cemetery when there was a lack of services being provided. The decision was made to send him correspondence thanking him for his efforts.

Unpaid Invoice- Williams brought to the attention of the Board an unpaid invoice from Oncite Services, LLC for lawn services. *Motion to pay the invoice for the amount of \$225.00 was made by Klein, 2nd by Hubbard. Motion carried unanimously.*
