- a. Playground- The Auxiliary would like to move the money for the playground to our account to help pay for equipment. We will accept the check.
- b. Credit Card -Rippee reports that the bank will require 2 years of balance sheets, income sheets, budget and meeting minutes. - d. Sink & Faucet Replacement Quote- Gilchrist mechanical was called to provide a quote, with no reply. Sarkozi was contacted. Some communication was had, but a quote has not been obtained.
- e. NMI Technology Payment- We have paid the last quarter of the year for virus protection and one month for back up service.

**New Business:**

- a. Trash Bags -Bear Packaging was contacted for pricing. The price is \$26 per box for 33-gallon bags. This is a \$2 increase from our previous order. Delivery charge is \$9. *A motion to purchase up to \$1400 in trash bags for township citizens to purchase at \$26 per box was made by Williams, 2<sup>nd</sup> by Chinavare, motion carried unanimously.*
- b. Snow Removal Bids -We will not seek bids this season and stay with the same service as last season.
- c. Consolidated Nine Day Early Voting -The Clerks met this week to discuss the early 9-day voting. We have to submit a plan to the State of Michigan. The board will need to approve the location that we have chosen to hold the early voting. We have decided on Linsey Rogers as the Chairperson for early voting.
- f. *A resolution to conduct and administer an early voting site at Briley Township Hall, 12423 Jerome Street, Atlanta, Mi 49709, was offered by Chinavare, supported by Stehle. Followed by a roll call vote: Williams: YES, Chinavare: YES, Rippee: YES, Stehle: YES.*
