**January Meeting Highlights**

**Rebekah Carlson** gave a rousing invocation that set the tone for YCRCC for the busy year ahead.

**David Fennell** spoke at the meeting and reported that only he and **Megan Dahle** (both Republicans) are the only candidates running for the Dist. 1 State Senate Seat.

**Tom Pessoa** recommended that everybody do a ballot track to confirm their ballots are counted. He explained how to do this. He also recommended that we become involved with ballot harvesting. He said some churches will have ballot boxes, and some churches will start registering voters.

Motions were approved to fund mailing No Party Preference mailers, Primary Slate mailers, and to fund up to the max limit of \$5000 for several GOP candidates including **Dalila Epperson** who is a Monterey Co. Republican running for State Assembly, Dist. 30. **Dalila** started a Mom's Group to let parents know what schools are doing to children. **Renick House, John Floe,** and **Eric Early** will also be funded.

improve or diminish a measure's odds of passage. Her misrepresentations resulted in the mess that California is in.

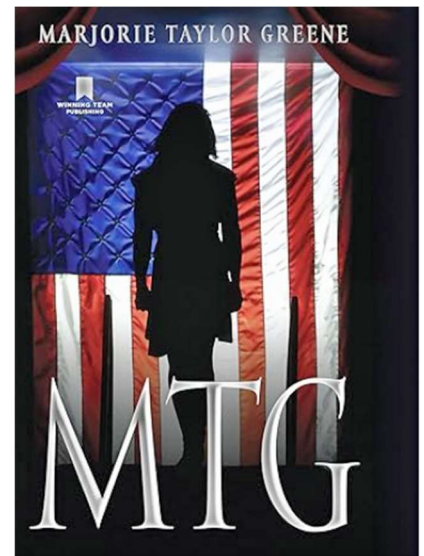

This measure, if passed, will create \$97,000,000 in bonds for the Marysville Joint Unified School District to sell to investors. When interest is taken into consideration, the actual cost to taxpayers will be at least \$194,000,000. By a special online vote, YCRCC



approved \$1800 for **NO ON S** signs.
