Privacy Policy

- 1. This privacy policy applies between you, the User of this Service/Website and "Got your back London Ltd". The owner and provider of this Service/Website is Got your back London Ltd, a limited company registered in England (company number 14385756). Got your back London Ltd is a data controller and takes the privacy of your information very seriously. This privacy policy applies to our use of all Data collected by us or provided by you in relation to your use of our Service/Website.

Definitions and interpretation

- c. a reference to a person includes firms, companies, government entities, trusts and partnerships.
- d. "including" is understood to mean "including without limitation".
- e. reference to any statutory provision includes any modification or amendment of it.
- f. the headings and sub-headings do not form part of this privacy policy.

Scope of this privacy policy

- 4. This privacy policy applies only to the actions of Got your back London Ltd and Users with respect to this Service/Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links it may provide to social media websites.
- 5. For purposes of UK GDPR, Got your back London Ltd is the "data controller". This means that Got your back London Ltd determines the purposes for which and the way your Data is processed.

Data collected

- 6. We may collect the following Data, which includes personal Data, from you:

How We collect Data

- 8. We collect Data in the following ways:

 - b. data is collected automatically.

Data that is given to us by you

9. Got your back London Ltd will collect your Data in several ways, for example:

- a. When you pay for a product or service through our payment gateway
- b. When you sign up to a newsletter
- c. When you use the Website
- 10. in each case, in accordance with this privacy policy.

Data that is collected automatically

- 11. To the extent that you access the Website, We will collect your Data automatically, for example:
 - a. We automatically collect some information about your visit to the Website. This information helps us to make improvements to Website content and navigation and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.
 - b. We will collect your Data automatically via cookies, in line with the cookie settings on your browser. For more information about cookies, and how We use them on the Website, see the section below, headed "Cookies".

Our use of Data

- 12. Any or all of the above Data may be required by us from time to time in order to provide you with the best possible service and experience when using our Service/Website. Specifically, Data may be used by us for the following reasons:
 - a. To process your payment.
 - b. To provide you with secure access to your account.
 - c. To send you our newsletters.
- 13. in each case, in accordance with this privacy policy.
- 14. We may use your Data for the above purposes if We deem it necessary to do so for our legitimate interests. If you are not satisfied with this, you have the right to object in certain circumstances (see the section headed "Your rights" below).
- 15. For the delivery of direct marketing to you via e-mail, we'll need your consent, whether via an opt-in or soft-opt-in:
 - a. soft opt-in consent is a specific type of consent which applies when you have previously engaged with us (for example, you contact us to ask us for more details about a particular product/service, and We are marketing similar products/services). Under "soft opt-in" consent, We will take your consent as given unless you opt-out.

- b. for other types of e-marketing, We are required to obtain your explicit consent; that is, you need to take positive and affirmative action when consenting by, for example, checking a tick box that we'll provide.

Data retention

- 21. Even if We delete your Data, it may persist on backup or archival media for legal, tax or regulatory purposes.

Your rights

- 22. You have the following rights in relation to your Data:
 - a. Right to access—the right to request (i) copies of the information We hold about you at any time, or (ii) that We modify, update or delete such information. If We provide you with access to the information We hold about you, We will not charge you for this, unless your request is "manifestly unfounded or excessive." Where We are legally permitted to do so, We may refuse your request. If We refuse your request, We will tell you the reasons why.

- b. Right to correct- the right to have your Data rectified if it is inaccurate or incomplete.
- c. Right to erase- the right to request that We delete or remove your Data from our systems.
- d. Right to restrict our use of your Data the right to "block" us from using your Data or limit the way in which We can use it.
- e. Right to data portability- the right to request that We move, copy or transfer your Data.
- f. Right to object the right to object to our use of your Data including where We use it for our legitimate interests.
