- ◇ A staff mentorship program.
- ◇ Participation in the garden program that provides fresh vegetables for the houses.
- ◇ Classes in relapse prevention, nutrition, meditation, and daily living skills.

REMMSCO is an acronym for "Reidsville, Eden, Madison, Mayodan, Stoneville, & County."

REMMSCO substance abuse recovery homes offer temporary, recovery-focused housing to men suffering from addictions who are residents of many counties in North Carolina. When REMMSCO was first established, we served residents from the cities in our acronym, in Rockingham County, NC.

## Our Recovery Homes

### The Franklin House

The REMMSCO house on Franklin Street is for men with six months of sobriety. It was acquired in 1992 and came to be used in 2022 as a three-quarter house when it became apparent that there was a need to provide a transitional environment for the men completing their stay at Glenn's House. This home, nestled in a wooded lot, can accommodate up to six residents at a time. There are four large bedrooms, two full baths, a formal dining room, a common living area, and full kitchen. There is a spacious front porch conducive to sharing time with visitors and other residents.



### Glenn's House



The REMMSCO recovery home is for men who have completed detox. It was established in 1981 by a group of concerned people in the local recovery community who wanted to make sure that there was a place for men who needed a structured environment to recover from substance use disorders. It has since been named Glenn's House in honor of a former Board member. Since its inception, hundreds of men have passed through these doors. Those who were ready to receive recovery have been able to transform their lives. The men's house can accommodate nine residents. There is a common living area, a dining room, and a full kitchen. A quiet room and a study are available upstairs where residents can sit and read, meditate, or concentrate on their recovery work. The covered porch on the front of the house is also available for socializing, relaxing between tasks, and visiting family and friends.

## Our Main Office



The Williams Annex houses the main office for REMMSCO, Inc. This multi-purpose building was constructed adjacent to Glenn's House in 1990 with a generous donation from R. E. "Pinkie" Williams, a long and passionate supporter of those desirous of recovery, along with funding from the Kate B. Reynolds Charitable Trust. This 2800 sq. ft. building is used as a library, a gathering place for AA and NA meetings and events, a meeting place for residents and their sponsors, as well as for fundraisers, Board meetings, classes, and resident recreation.
