Minister of Environment and Climate Change Strategy:

Further to our email of September 14, 2017 "Stop Bowser Ocean Sewage" is requesting that the Regional District of Nanaimo (RDN) Bowser Sanitary Sewage Service with a Marine Outfall be designated as a reviewable project pursuant to the Environmental Assessment Act (SBC 2002) Section 6 since we contend that:

- cumulative effects from the project will have significant effects on shellfish and SARA eelgrass communities
- will constitute a significant health risk for contact recreation and consumption of shellfish
- has, even before being substantially started (per EAA subparagraph 6 (1) b), had a significant adverse socio-economic effect since consultation has not been done with the "Impact Community" (please consider the attached letter to Minister Selina Robinson with a petition representing the widespread concerns of ~ 17% of RDN Area H stakeholders, and information from our September 15, 2017 meeting with Honourable Scott Fraser http://img1.wsimg.com/blobby/go/192c8eb8-c92a-478c-ac0b-9b9928dee475/downloads/1bqiq1k7d_85747.pdf)
- the designation of the project as reviewable is in the public interest since there is still an opportunity for Government to change from conventional marine sewerage to green on-land disposal options consistent with the RDN's sustainable development regional growth strategy.
