Assessments are collected monthly and are due on the 1st day of each month. A late payment fee of \$15.00 is assessed to those accounts that are paid after the 30th day of the month for the Master Association. Ferguson Glade Assoc. will charge a \$15.00 late payment fee after the 16th. Note: Smithy Glen & Finch Terrace Assoc. will charge a \$25.00 late payment fee after the 16th.
