- A. Clubhouse Tandem Window Repair Proposals: Tabled for further review.
- B. Remove Fallen Tree Branch Proposals: Common Area Behind 136 Seekright Drive: Treasurer Randy Wojcik motioned to remove the fallen tree branch by Hanson Tree Care, LLC for \$375. This action requires permission from Coventry Elementary School to access the tree branch. The motion had a second, and it was passed.
- C. **Repair Two Marquees Proposals**: Director Gary Cusack motioned to have The Sign Shop repair two marquees for \$2,291. The motion had a second, and it was passed.
- D. Ray Lawson, Electrician, Light Repair Invoice: Vice-President Ruthanne Gray-Grabowski moved to pay Ray Lawson, the electrician, \$3,310 for light repairs. The motion had a second, and it was passed.

## IX. NEW BUSINESS

- A. **Annual Meeting Date Conflict with Veterans Day**: Secretary Jiselle Anderson motioned to change the annual meeting date to November 13th, 2024. The motion had a second, and it was passed.

- D. Purchase and Deliver Large Rock for Harvest Lake Recreation Area Driveway: Director Gary Cusack motioned to purchase a large rock with delivery from Rock Quarry for \$645. The motion had a second, and it was passed.
- E. Clubhouse Pool Pump: The topic is tabled for further review.
- F. Mulch Proposal: The topic is tabled for further review.
- G. **Community Day**: The Beautification Committee has requested April 20th from 9 a.m. to noon as CHOA's scheduled Community Day date, with a rain date of April 27th. Vice President Ruthann Gray Grabowski motioned to approve the requested dates. The motion had a second, and it was passed.
