a. Minutes of the May 19th, 2020 Regular Board Meeting: The item has been tabled for correction.

b. A motion to amend the agenda adding a review of the last year's minutes.

MSC by Directors Diane Yates, Keith Wright and carried (3-0). The Board directs Brandy to review the last 12 months of minutes. Chairman Marsha Maraviov, Directors Diane Yates, and Keith Wright: Yes-3; No-0; Abstain-0.

PROGRESS PAYMENT REQUEST:

a. Set Backflow Protection Testing and Repair Fees: Section 8.8D of the Ordinance gives TCWW the authority to bill for charges accrued for testing and maintaining backflow preventers. Craig recommends adopting a \$3 per month per inch fee to offset costs.

MSC by Directors Keith Wright, Diane Yates and carried (3-0). The Board approves a \$3 per month per inch for backflow devices. Chairman Marsha Maraviov, Directors Diane Yates, and Keith Wright: Yes-3; No-0; Abstain-0.
