The meeting was called to order by Chairman Diane Yates at 2:00 p.m.

a. The State Water Resources Control Board Increase in Requirements: The requirements will be phased in. The Board of Supervisors have asked to have the district exempt from this requirement. The SWRCB wants to measure the creek, diversion that is using 10 acre feet or more. Craig informed the Board the district is already measuring our water. Need to budget \$6000-10,000 in the future.

b. The Division of Dam Safety Increase in Fees: Craig informed the Board the dam fees will be increasing from \$9500-\$10,500.
