#### PROGRESS PAYMENT REQUEST:

- a. Discuss possible dates for long range planning workshop: The Board discussed a date to hold the workshop. It was agreed to set the date for March 21, 2016 at 9:00 a.m.
- b. Shane McDonald Grade 3 Water Treatment Plant Operator License: Craig informed the Board Shane has passed his Grade 3 Water Treatment Plant Operator test.
- c. Payments from the USFS: Craig informed the Board we received the last large payment from the USFS totaling approximately \$49,000; still waiting for the last \$3000 payment. The monies were deposited into Cal Trans account instead of the district's checking account.

- d. PERS Termination and Lump Sum Payment Options: Craig recommended the district not send any money towards paying off the unfunded liability because it is too close to the contract termination. Funds will be moved to LAIF. No action needed.
- e. Audit 2015: Craig informed the Board the audit is being held up because PERS has not provided the information that Don Reynolds needs.
- f. Application to Dept. of Drinking Water for Treatment Plant Upgrades: Craig informed the Board the application if complete less the audit for 2015.
- g. Form 700 Conflict of Interest: Craig informed the Directors that Form 700 needs to be filled out and given to Ora so she can send it to the Trinity County Clerk. Form is due by March 20, 2016.
- h. Flint Michigan-lead issue overview: Craig gave the Board some information on lead. No action needed.
- i. Billing Issue Book I for the first week of 2016: Craig informed the Board there was a billing issue on Book I of \$1.25, error has been fixed.
- j. Water Service Hoffman, S. 14-43-60 N. Oak St.: Craig informed the Board the property is located behind the dam. Former applicant needed an easement from Mr. Hoffman.

- k. Inflow and Infiltration issue at Trinity County Fairgrounds: Craig informed the Board there was a problem with Pump Station #2 during the flood. An average flow is 75-100 gallons a day; during the flood it was 1300 gallons. Eighty percent of the infiltration was coming from the Fairgrounds. Craig and Shane did a smoke test. Craig will be sending a letter to the Fairgrounds.
- 1. State Water Board Extends Water Conservation Regulation: Craig informed the Board the State Water Board has extended the water conservation regulation until further notice.
