CALL TO ORDER AND ROLL CALL:

The meeting was called to order at 2:00 P.M.

CONSENT CALENDAR:

a. Minutes of the August 16th, 2022, Regular Board Meeting:

MSC by Directors Mary Bowers, Daniel Bowman, and carried (4-0). The Board approved the consent calendar as corrected. Chairman Diane Yates, Directors Daniel Bowman, Mary Bowers, and Kenneth Wiley: Yes-4; No-0; Abstain-0.

COMMUNICATIONS/CORRESPONDENCE:

a. Communication with Trinity County Planning Dept: Craig updated the Board on the emails between himself and the Planning Department. No action taken.

PUBLIC COMMENT/PUBLIC DISCUSSION:

PROGRESS PAYMENT REQUEST:

a. Update on all pending grants: The LWCF grant restrooms are 100% complete, fencing is 75% complete, large trails are 75% complete, small trails are 90%, tables and benches are 50% complete. We have spent \$464,049. We have progress payment #2 submitted for \$227,138. (50% cash match).

From our planning grants, we have received \$161,501 over the last month or so and have processed those payments and forward payments to PACE engineering. To date on the wastewater planning grant, we have incurred invoices for \$33,544. On the water treatment planning grant, we have incurred invoices for \$270,990. We have received \$40,907.00 from the wastewater grant and \$279,411.00 from the water treatment planning grant.

PROGRESS PAYMENT REQUEST:

b. Discussion on Standby Fees: Craig informed the Board about the standby fee increase from \$3 to \$22. The Board discussed a new standby fee.

MSC by Directors Kenneth Wiley, Daniel Bowman, and carried (4-0). The Board approved a change in the standby fee from \$22 a month to \$10 a month. Chairman Diane Yates, Directors Mary Bowers, Daniel Bowman, and Kenneth Wiley: Yes-4; No-0; Abstain-0.

- c. Discussion on Customer Deposits for Meter Installations: Craig discussed with the Board including the customer deposit into the cost of meter installation. The Board directed him to return next month with a policy draft. No action taken.
