## Terms and Conditions for OI 96er Eating Challenge

### Introduction

Welcome to the OI 96er Eating Challenge, hosted by Local Smoke BBQ ("we", "us", or "our"). By participating in this eating challenge, you ("Participant" or "you") agree to these Terms and Conditions (the "Terms"). Please read them carefully.

## **Eligibility**

- Participants must be at least 18 years of age Proof of age may be required.

### **Health and Safety**

- Participants agree to stop eating and notify staff immediately if they feel unwell during the challenge.
- Participants are encouraged to eat responsibly. The challenge is intended as a bit of fun and should not be seen as encouragement to engage in dangerous or harmful eating practices.
- Your health is our priority. The challenge is intense and not for everyone. Please consider your physical condition and dietary restrictions before participating. Eating beyond your capacity can pose serious health risks.

## Waiver and Release

Participants must sign a waiver and release of liability before participating in the challenge, agreeing to release Local Smoke BBQ from any claims related to injury, loss, or damage that may occur as a result of participation.

## **Prizes**

## **General Conditions**

- We reserve the right to cancel, suspend, or modify the challenge if any fraud, technical failures, or any other factor beyond our control impairs the integrity or proper functioning of the challenge.
- We reserve the right to disqualify any individual we find to be tampering with the entry process or the operation of the challenge or to be acting in violation of these Terms.
