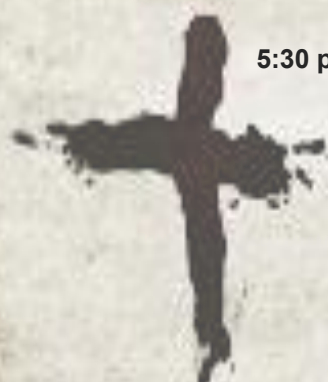

Church Council Corner: February Report

Greetings to you all.

Seems like time is just flying. The advent season of waiting with great anticipation for the Son of God to appear is done. Next thing you know it will be the beginning of Lent - which this year begins on February 14th - St Valentine's Day. A day most of us relate to love and commitment to another. Saint Valentine was a 3rd century Roman Saint, and actual Clergyman or Priest, who ministered to persecuted Christians. He himself was a martyr to those less privileged and downtrodden. What a symbol of unconditional love and commitment.

As we now prepare for the season of lent - a time of introspection and contemplation - it's fitting we review the last few months in our congregation and prepare for the next season.

Hopefully, you know by now that we are in conversation with St. Stephen Lutheran Church looking at our future(s) and possibly a consolidation of our 2 congregations. A consolidation in very simple terms is best summarized in the following equation:

$$\mathbf{A \text{ (Good Shepherd) + B (St. Stephen) = C (New Congregation)}}$$

During our conversations, we have often used the example of this process being similar to dating. Dating means getting to know each other better - both the good and sometimes not so good - traits and characteristics about each other. Dating involves sharing, being vulnerable at times and requires compromise too. It generates many feelings - happiness, excitement, fear and anxiety. But really - what a better time to start dating than now - Lent and St Valentine's - Feb 14th!

To assist our 'dating process' and 'getting to know you' period, Good Shepherd has formed a small task force to work with St Stephen (who also has a task force). We have drafted a couple of helpful documents to share with you and they will be made available here in the newsletter but also in print for you to take with you at church. One is a timeline of events leading up to today, and the other is a FAQ (frequently asked questions). We will also make sure there are members available every Sunday for any questions or to listen to your comments or feedback. So, as we move forward in our 'dating' with St Stephen, let's keep in the forefront of our minds the goals of this relationship. To build a strong vital church that is able to support the people of the Greater Wausau Area by building up our mission, giving, support, inclusion and love to those who join us every Sunday, or those who just come to visit. Building this relationship will take time, vulnerability, patience and strength. All of which we have shown we already have and know how to do and do it well! And when we feel any doubt just remember "God's Got Us"!

Frequently Asked Questions - Edition 1 (January 25, 2023)

1. Does St Stephen Lutheran Church have similar Values (ie: Music, Worship, Sunday School, Women's Groups, Men's Groups, Youth, Softball, Care for the Community, etc)?

Yes, which is why we are partnering together. They also have strengths we do not have, as we have strengths they do not have.

2. What is their financial position?

We are in the process of gathering and sharing this information with each individual task force. As we learn more, we will share pertinent information as we are able.

3. What building will be physically used and how does it provide for size, parking, ADA accessibility?

This will take further discernment and discussion. While that is happening, we will work on opportunities to visit and worship in both spaces. The buildings, however, should not hold us back in this journey. There is also no reason in the near term that any building needs to be sold.

4. If we sell the building(s) where does the value go? Who owns the land/buildings? What happens to the furnishings and equipment inside?

The synod does not own the buildings or lands, and they will not get any of the money, unless we direct the monies to them specifically. The buildings and goods proceeds; should they be sold would go to support the new congregation.

5. Will Angie and Kartika have positions?

Yes - their positions are vital and needed for the work of the new church - and will not be replaced by any other existing staff. They will remain if they agree to do so. The staff from St Stephen are also needed and will remain if they all agree to.

6. What is the timeframe to be considered?

Once formal proceedings begin for a consolidation, meaning each congregation has held a special congregational meeting and votes to proceed, the best 'guesstimate' is 6 months - 1 year.

7. Will this allow us to grow?

Yes! A consolidation will provide all of us with the opportunity to THRIVE NOT JUST SURVIVE! Combining all resources, talents, money and energy will allow for further growth and outreach.

8. Why are we doing this instead of looking for another Pastor?

On their own, both congregations were going nowhere and not effectively using the gifts God has given us. God's Grace is leading us to this journey so we can be faithful stewards. There are more physical ELCA congregations/buildings than the greater Wausau area needs, or can support. Combining resources, talents and strengths will support renewed growth, outreach and Ministry to the whole Wausau Area.

9. Next Steps: (These are not in any specific order and more info will come when we get to each specific step)

- Task force formation and then meetings to discuss financial standing, buildings, bylaws, vision, mission and compatibility
- Synod sponsored Pastoral coaching along with Synod guidance for every step.
- Congregational meetings to vote to proceed
- Legal steps to transition from individual identities to a new combined identity
- Holy Closure for each individual congregation after thoughtful Legacy Building
- Ceremonial Worship to close GS and SS, open a new congregation and installation of the pastor

Timeline Review

April 29, 2023 - First meeting with Synod Leadership and Greater Wausau Area congregational leaders

June 21, 2023 - start of monthly Presidents meeting

November 8/16, 2023 - Approached by Immanuel Lutheran Church/Met with Immanuel council - they were solely interested in a traditional 2-point parish arrangement (Option 1)

November 8, 2023 - Approached by St Stephen Pastor and Council President with interest to start conversations about consolidation (Option 2)

November 18, 2023 - Second Synod meeting with Greater Wausau Area leaders
St Stephen and Good Shepherd met together with Synod leaders to discuss possible consolidation option

December 12, 2023 - informed the council in a closed session as St Stephen requested us to keep it confidential. The council was in full support of Option 2.

December 17, 2023 - Informed the Good Shepherd congregation at a Town Hall meeting generically of the 2 options and they supported Option 2 of consolidation

December 27, 2023 Request for follow up meeting with St Stephen and they asked for a task force to be formed

January 18, 2024 - First joint task force meeting and SS gave permission to publicly share

January 21, 2024 - Annual meeting and public sharing of St Stephen and Good Shepherd in discussions

January 25, 2023 - Good Shepherd Task Force first meeting to plan. Members are Kay Walters, Paul and JoAnn Grewe, Jennifer Holcomb, Mike and Laurie Sturzenegger. JoAnn has agreed to serve as main contact person.
