Breeder Obligations

- The breeder has followed good breeding practices and verifies that both the sire and dam are AKC registered Siberian Huskies. The breeder acknowledges the AKC National Club Guidelines and the Kennel Club health standards for the breed and certifies that the sire and dam are sound breeding stock. The AKC and DNA profile numbers for both parents will be provided to the owner on the puppies AKC certificate. Breeder insures that each parent has been Embark tested for genetic disease and all test results are normal and available to the purchaser.
- The puppies have been reared in a home environment, socialized since birth and have been wormed at 2,4,6 and 8 weeks of age. The puppy is a minimum of 8 weeks of age and has been weaned. The puppy will also receive his first shot at 8 weeks prior to leaving the breeder.
- The puppy will be examined by a vet prior to release and will be accompanied by a certificate showing that the puppy is believed to be in good health. The purchaser is strongly advised to have the puppy checked by their own vet within three days of collecting the puppy. If the vet certifies that there is any problem which makes the puppy unfit for sale, provided the puppy is returned in the same condition as when it was sold, and within three days, the breeder will take the puppy back and refund the full purchase price. The breeder will not pay expenses incurred in the return of a puppy nor accept any claim for distress caused by the return.

- The breeder has inquired of the purchaser his or her past experience with dogs and in particular with this specific breed and on the basis of the information received is willing to place a puppy with the purchaser. Every puppy is an individual and the breeder cannot be held responsible should conditions, genetic or otherwise, develop later in life.
- The breeder will microchip each puppy prior to release. The breeder will register the kennel contact info along with the new owner's information with each microchip. The microchip paperwork will be provided to the buyer.
- The breeder will establish each puppy with a medical record with Vetco mobile clinics. This service provides economical pet care and vaccination packages. Breeder will transfer the puppy's medical records to the buyer if they choose to continue care with this provider. A hard copy of the paperwork will be provided at time of transfer.
- The breeder acknowledges that they have registered the Litter with the AKC and will provide the owner with a copy of the litter certificate. Each puppy will be pre registered with the AKC and given the kennel name (unless requested otherwise) and a "limited" registration status. The breeder will complete the AKC registration once the buyers have chosen a "call name" for the puppy and notified the breeder of the chosen name. The owner will then receive the puppy's AKC certificate directly from AKC. The limited registration restricts the puppy from being able to reproduce and the breeder will be recorded as co-owner on the AKC registration until proof of spay/neuter from the owner is received. Upon receipt, the breeder will release all ownership rights to the puppy.
- The breeder will provide a Facebook page for puppy owners to communicate with.

Purchaser Obligations

- The purchaser will be responsible for vaccinating the puppy at 12 & 16 weeks and will limit the puppy's exposure to other dogs until the final vaccination. The puppy will then receive vaccinations on an annual basis. Breeder recommends making the first appointment for puppy at time of deposit to avoid delays for immunizations.
- The purchaser acknowledges that the puppy will need a rabies shot at 16 weeks and a year later. The second rabies shot will need to be renewed every 3 years.
- The purchaser agrees to neuter or spay the puppy by one year of age. Upon submitting a copy of the veterinarian bill to the breeder, the breeder will release full ownership in the AKC registry to the puppy owner.
- The purchaser agrees that the puppy will be registered for a dog license in the county they reside in and that this license will be maintained for the life of the dog.
- The purchaser acknowledges that they have done their research on the breed and feel that a Siberian Husky is a good fit for their lifestyle. The purchaser acknowledges that huskies require lots of attention and exercise and agrees to provide an environment with lots of both.
- The purchaser agrees that the dog will be kept in appropriate conditions for its welfare and health. It will be fed on a suitable diet for its age and condition and have appropriate exercise. It will receive all necessary veterinary care to maintain its physical good health. The dog will be kept under appropriate control and will not be neglected or maltreated in any way. The purchaser attests that he or she has not been banned from keeping a dog or any other animal by any legal court order.
- The purchaser agrees to keep the breeder's contact information listed on the microchip as a secondary contact for the life of the dog.
- If circumstances occur where it becomes necessary to re-home the dog, the breeder must first
 be notified. The Purchaser agrees to not surrender, abandon, rehome or sell the dog without giving the breeder an opportunity to take back ownership.
