Dear Honorable Judge Leslie Kobayashi;

My name is Rene' Powers, investigative reporter and friend of Anthony Williams. I come to stand before you through my words and seek to have them heard as they are intended. Many times **written words are misconstrued** due to the receivers interpretation and it is imperative you know my intent is honorable, peaceful and foremost with concern for the law.

Anthony Williams is a man before you seeking his freedom. **Freedom** is a word also misconstrued many times as freedom means so many different things to so many people. It meant a lot to the Chinese when they came to America in the early 1800's, and to the Irish when they too came to America in early 1800's and the mixed nationalities who were brought here by force to work as slaves over the centuries. Many nationalities have suffered because of mans creation of statutes and codes to represent their own beliefs at the time they are in power. Statutes and codes can represent racism and intolerable control over people at different times in history. It takes centuries, even lifetimes, to right some of the horrendous wrongs caused upon the people under the color of law. How freedom in action looks is dependent on the ideals, knowledge and experience of the actor within it. One thing all who come to America and who were born on America have in common is the ideal of their Freedom, the idea that they will be free to speak, act and live as long as they do no harm to others and are **honorable** in their lives and intentions.

**Honorable**, another subjective word in print. Honorable to one man may be quite dishonorable to another, such as the discrimination of woman, even their killing in some cultures neigh for the only crime of showing indifference to abuse at the hands of their husbands. Abuse at the hands of anyone, any man or woman is intolerable in America, but subjective in other countries as their culture. I listened as Anthony taught many men and women about the culture of America, the Constitution and law. He exclaimed over and over that no matter how a man wants his opinion to be fact under law that doesn't make it lawful. One man's opinion is not enough to usurp the real law and the Constitution put in place to protect us from that usurpation. Anthony many times spoke of opinions being used against men to

wrongly put them behind bars, apparently he knows something about that. ***The United States Constitution*** is not a living organism yet it too has been misconstrued many times in order to strip a man or woman of their freedom. Anthony has been stripped of his freedom.

A wise woman said these words when asked about the Constitution at a hearing for her appointment to a District Court in Hawaii;

***"The Constitution is a permanent framework for the principles of American law. I do not agree with the perspective that the Constitution evolves as society interprets it."***

This is The Responses of Your Honor Leslie E. Kobayashi as then Nominee who was to be a United States District Judge for the District of Hawaii to the Written Questions of Senator Jeff Sessions. I would pray that as the woman who answered in that manner you will reflect on why Anthony was denied the mention of the Constitution within his defense in Florida? Why would a man be denied this principled law? A society of bankers and foreclosure mill attorneys have been allowed to usurp basic property rights and gain support of Judges across America, but in Florida, where Anthony was denied the Constitution, a non-fiction documentary of these facts is laid out in the book "People v Money" and it is devastating to learn that our judiciary has been taken into these dark waters. It is my prayer your court will allow Constitutional arguments of Anthony to prevail and be heard.

I met Anthony Williams in 2014. Someone who knew of Anthony thought he would make a valuable interview for listeners who have been victims of foreclosure mills. Anthony agreed to be a guest on my radio show. He shared his fight for his own freedom from false charges and how he was building his services to help those who were victims of financial crimes. Anthony shared his story about being set up by dishonest Prosecutors who stole his freedom a few years previously and how he had to battle using law to walk out of the prison a free man. The story would have been shocking to me had it been an anomaly, but there are too many stories that mirror this event. Anthony shared concrete facts proving he was framed by the FBI.

Law enforcement attempted to use fingerprints of another man, one that was much older than Anthony, in fact, if those fingerprints had been his he would have been 17 days or so old when they were taken. Anthony cross examined the expert fingerprint witness brought forth by the Prosecution and when he asked them to look at the date on the slide and read it aloud the truth came out. The judge heard they were not his fingerprints and it was a set up. Awfully big fingerprints for an infant? Yes, but that did not stop the extradition from Hawaii to stand once again to face more false charges. Anthony beat those too, he was innocent but another man without knowledge of the law may not have successfully stood without a BAR member and defended himself under the law like Anthony. In Anthonys last few years of the battle the facts and his evidence have been silenced.

In covering Anthony's story it became evident to me that getting him behind bars is the priority. Who are those benefitting from him behind bars? It may be argued the potential victims of his services are benefitting because he is off the streets, but in reality, had he not been circumvented from doing his services he would have completed his intent to stop foreclosure mill fraud and injustices against people through what we know may be corruption behind the offices. This is a man who uncovered exactly how pervasive the theft of Titles in America have been. This is a man who uncovered the crimes and has been punished for it.

Many clerks and officers of the court have been arrested for taking bribes to commit a crime that hurts civilians. I have covered many of these stories and find county clerks and law enforcement officers lie many times to the judges, how does a judge know that fraud upon the court is present? It may be present and not recognized because the actual one standing in innocence is not the one in the public servant seat but the one who attempts to end the public servant crimes against the people. Many judges are now awakening to the truth that many times an innocent man is not believed merely because an officer of the court is speaking against him, when in fact that man is doing his best to share his lawful knowledge.

Please hear Anthony your honor. Had Anthony not discovered the fingerprints planted by law enforcement he would have been forever planted in that jail in Hawaii once before, as a convicted pedophile, that in itself is a horrible crime, but no more horrible than to be framed for it in the first place. **( I followed another story in Orange County California: Judge Goethals removed the entire District Attorney's office of over 240 employees, in the Scott Dekarri murder case because they fabricated evidence, also finding Tred Files hidden for 15 years by the Sheriffs. In your own jurisdiction many times court officers abuse their positions to hurt innocent civilians, some literally rape women and seek favors for their freedoms.)**

Discernment of facts is predicated in law and so many times Judges find they are being used by public servants, or witnesses who are compromised and lie to save their own freedoms, and I pray this court finds reason to discern the law not the biased evidence against Anthony standing accused and without a full defense, without the use of the Constitution and his full evidence in facts. Not everyone in public service has good intentions, not every man helping others has good intentions, but I found that Anthony's search for justice for all people lays in good intentions and is why he lays his head currently in a jail cell, justice stopping Financial Crimes doesn't pay well for the criminals committing the crimes. Anthony was known to remove people from his team, like his team in Hawaii who stopped letting use his company name while he was incarcerated. Some of those team members worked without his authorization and did many unethical things while he was incarcerated, things he had to find out about because of the harm they caused. He was in the midst of receiving many phone calls detailing the problems others caused using his name when I met Anthony. After the first radio interview Anthony and I kept in touch as many viewers heard about what people calling themselves his company team members did to people and they called me exclaiming how he had helped them stay out of jail, get out of jail as innocent men, save their homes and changed their lives by helping them stop hating what happened to them and start learning law.

Before you Judge Kobayashi is a man who loves the law, from what I observed he literally lives and breathes it and his joy comes from teaching others about law and helping them retain their freedom, is that why it is so important to keep him in a cell? He is a man born under the law and yet brandished as a false prophet for simply knowing law. Anthony has not hurt other man or woman, they went to him for help, some did not get the help they believed they should have as their paperwork was denied and they lost their homes as they fought to give their evidence of financial crimes against them, evidence Anthony was hired to help get onto the record of the court offices. I also saw him deny helping those he found were lying to him and actually losing their property due to their own responsibility. He helped those wronged, but not those wronging others or looking to unjustly enrich themselves.

Anthony's services were not able to be completed for many clients at the end of my journey with his story and they were angered as they were stripped of their equity and homes, many of them spoke to me. After the people shared that they were not able to finish their filings and save their homes I attempted to tell Anthony to quit taking clients because too many were not seeing justice, Anthony refused to stop helping and in my opinion that is what landed him behind bars, he continued to do his best in belief that the law would prevail and paperwork would get filed. Clients were left with unfinished filings and losing their homes, but in my experience and research it is our system who lets homeowners down, who leaves them with unfinished business resulting in the theft of their homes. The law is clear, the Bill of Rights is clear and even the Magna Carta, the Magna Carta is the anchor for the American Bar Association and a foundation for property rights yet, when I have heard Anthony share this basic concrete law he lands him behind bars.

Does Anthony appear arrogant and cause law enforcement who come upon him to lose their tempers? Yes. I have witness of that too, but the loss of tempers usually comes from the officers lack of knowledge of the law they are assuming to enforce and Anthony's perceived arrogance for knowing it. Anthony knows law, he is assertive in it and if someone perceives it as arrogance is that not an opinion? And, in law it is not empathy or opinions that matter it is law and as such, regardless of his perceived arrogance he does know the law. Knowing the law should not be a crime and angry clients emotions are not legal grounds for arrest unless the grounds are due to the one providing the service. Many who claimed to do services on Anthony's behalf may have done some bad things knowingly and with intent to enrich themselves, but Anthony himself continued the path to end the financial crimes not commit them.

I heard Anthony chastising others over the phone regarding their unauthorized use of his paperwork and name and believe he seriously was put in a very bad place because others were greedy. Anthony's only greed is the need to free us of Foreclosure Mill Attorney crimes, bank crimes. When one cannot perform a service because public service offices refuse to do the lawful job and block that service that cannot be held against the man attempting to complete his service. If Anthony is allowed to fully testify, without interruption or violation of free speech he will show Your Honor his knowledge and facts. Isn't it the concrete evidence and law he shares that matters rather than the compelling testimony of others who may actually be testifying to cover their own actions, their own dislike for Anthony's ability to out-law them and based on opinions under the color of law rather than the actual law? Out-law is another term misconstrued, Anthony is not an outlaw, he is a man who outs-laws for the good of the people and public at large, he is not a threat to the people he is a threat to those committing financial crimes.

Law, a very complex and misconstrued word as well. We see through Anthony's case a breakdown of the law as he has been handcuffed, muffled and left without a defense. The Constitution itself was taken from him as a defense. Are you aware that the Head of the Florida Bar actually admitted in testimony on the record, on the stand, that there is no license to practice law in Florida? In fact there are no licenses to practice law, there are business licenses behind a BAR membership and Anthony's evidence was shown as fact and shown he had not only a license to conduct business but he also had the blessing of the mortgage compliance division of our government, yes, his paperwork was authenticated and authorized for use. This may not be evidence you heard, but it is concrete fact. As I followed the case Anthony was stripped of his witness and strength to stand as a man before the bench as those acting under the color of law stole his freedom, why? When did knowing the law, the Constitution and the Bill

of Rights become a crime? It became a crime when those who have the ability to act under it abuse those rights and strip a man of his basic freedoms just because they can, and he is a threat to their financial stream.

I come before you to tell you that prior to his arrest in 2015 I was witness that he held identification authorized by the FBI and used as he traveled, even on the airlines. I watched as Anthony and law enforcement officers talked rationally over law and helping people. Then, there were more times Anthony was treated with intimidation and threats against him for discussing law and his rights. One instance was when I traveled with him in 2014 to Florida. I went to cover the story of his work in Florida with homeowners and to get first hand testimonials. It was in the Los Angeles airport I witnessed him having a do not arrest and do not detain identification that was permitted by the FBI.

As we got to the security check inside the Los Angeles International Airport Anthony stepped up to the agent showing his identification and the agent looked up at him sideways. The man told Anthony he could not use that identification because it wasn't a US ID. Anthony explained that it was an authorized governmental identification and he was authorized to use it and furthermore they could verify it very easily with a simple call to the FBI. The agent had a dumfounded look upon his face as he argued in disbelief and said he had never seen that kind of identification and opined it could not be real. At that point Anthony was taken to the side with the ATA and other armed agents and was detained. As he was being taken aside he told them he knew they were doing a job to keep the people safe and that the simple call to the number on his identification would solve the issue, the agents discussed making the call. I proceeded through security and as I passed the agents discussing Anthony they were all mocking him and literally laughing out loud at what they opined was his fake identification, one agent literally was laughing in Anthony's face. I continued on to stand waiting on the other side of security, in eyesight and earshot of the incident. Anthony actually filmed the event on his phone.

As the laughter and mocking attitudes of the agents continued Anthony's identification was taken to the airport security by one agent and he handed the identification to what appeared to be a homeland security officer, I heard them both laugh and discuss how they were to call the FBI and confirm the identification of Anthony Williams. I watched as the officer making the call was seemingly transferred a few times and then I heard him read the identification number and name and then his face took on a blank stare as his mouth opened wide. The officer began nodding in a manner as if he forgot how to speak. The man uttered words I could not hear and then I heard him say, "okay, thank you". At that instance Anthony smiled back at the agents, he was kind and said he held no malice against them but that they needed to learn the law. The law, yes, that word once again, and said that people were to be treated respectfully even when detained, at which the agents litterally begged not to be seen as detaining him and he taught them the law that clearly showed them that he was detained. I heard Anthony say he was confident that this incident would be a learning experience for all of them. Again, a teaching moment found at a time when anger could have clearly been Anthony's response, instead he thanked them for making the call to the FBI and we went on to board the flight to Florida.

Today, I write this letter as Anthony once again is behind bars. I last interviewed Anthony during his short release in Florida before he was again taken into custody 2 weeks later and has stayed ever since. When he was released a freeman the Prosecutors retried him and he was stripped of his evidence, the Constitution too. Literally denied uttering anything about the Constitution, how is that lawful? It is law that shall free him, but is still being mocked and it must end with you Judge Kobayashi, the woman in

the robe and holding a gavel that yields the power to end this wrong. Anthony has helped many people, I have been witness to it. While on that trip to Florida people stood and hugged him, embraced him and thanked him, some of those same people would end up without their homes because of criminals being allowed to act under the color of law and not protecting their property rights. What I watched and observed over the following year was a degradation of the men and women surrounding Anthony. He began having those who I believe were planted in his life to help entrap him, to insight anger by telling untruths about him to those he was seeking to do services for, those who were then left without paperwork finished because clerks in the county offices refused them. I watched as people he trusted used him to possibly help themselves and in my opinion make deals for their own benefit. Arrests based on lies to entrap another are not legal, I believe even the law backs that belief and would cause any judgment obtained through fraud upon the court to be rendered void. Yes, I learned that from Anthony Your Honor. Anthony made mistakes by trusting people too much.

In my research as an investigative reporter I can assure you that forces in badges and inside law offices stealing the private properties of the people wanted Anthony off the streets, he was helping too many save their freedom and end the debt collections against them as their private properties were stolen by false claims. He knows the law and he told me over and over again that the law is on the side of the men and women, they just need to know it, not the perceived law but the natural law. Anthony taught me that law created by man cannot supersede natural law or the Constitution. He taught me it is men who write statutes and codes, they are not law. Statutes and codes create income for municipalities and do so for enrichment of a few in a perceived authority, without justification and it is not lawful. But, those who act under natural law know the difference between law and acting under the color of it. The man I know, Anthony Williams has the intentions to help everyone, but in so doing he was stopped by those who are enriched by usurping the law.

During the years I reported on Anthony's story I was shocked to learn how simple the law really is. My perception of law was based upon those who benefit financially from a narrative that preempts law and builds coffers and prisons where innocent people are traded as futures in the securities market. The United States has the largest incarceration rate in the world where many men and women are behind bars under victimless crimes. Procedures and legalese are not something your average man or woman will know, the disadvantage comes from not knowing our rights and learning them through the eyes and interpretation of the rules of a judiciary that has become so powerful that just knowing ones rights can be a prison sentence. I watched as people paraded into Anthony's circle who I could see did not have good intentions, in fact they appeared to seek to get Anthony in compromising positions, and that was when I knew Anthony was being severely targeted.

I covered Anthony's story because he had been instrumental in assisting homeowners in removing false paperwork from the records and helping them place lawful paperwork in their place, paperwork I personally saw county legal counsels approve. Anthony claims knowledge of the systematic fraud that foreclosure mills and banks use and he told me that to stop the theft of one's property a homeowner had to reverse the damages, and lawfully do what will undo their fraud upon the records. Anthony stood up to those within the records offices who were not helping homeowners, they were making money by helping the foreclosure mill attorneys not homeowners. As time went on the clerks began getting more and more hostile, actually creating chaos and refusing documents that were recordable and lawful, threatening to arrest homeowners who were there to show their evidence of Title fraud on their homes.

It appeared to any competent man or woman it was because Anthony was involved that the homeowners were refused their rights. In refusing those rights the clerks blocked Anthony from completing services he was paid to perform, in essence, the lawful paperwork was denied filing based on bias and anger at Anthony for helping save private properties. It is not Anthony's service that failed those angered at not getting help from the clerks and courts, it is the systematic reliance foreclosure mill attorneys have on the courts to act for them in lieu of homeowners. It is baffling that those helping save property from criminals are arrested while the actual criminals stealing millions of titles are walking free.

I have written many articles on the offices I call crime scenes of America, the land records, and much of what I uncovered of the Financial Crimes Against Humanity were due to what Anthony Williams taught me, he taught me to follow the money trail and not to believe anyone just because they are in a perceived position of power because at the end of the day it is really the people who are to be protected and it is the job of the government to do just that. He told me to have faith in truth prevailing and law working in my favor. It is tough to have this faith because over the last 14 years I have personal experience in being a victim of financial crimes and have witnessed many innocent people go to jail and spend years there before being freed as innocent. I have witnessed homes being given to attorneys through fraudulent paperwork and false claims of representing banks and using just hearsay as families are made homeless. I have witnessed the death of people kicked from their homes because they felt they had no life left. I also witnessed a man do his best to help all of these people. That man is Anthony Williams.

I believe that if Anthony is made a freeman again he will honor the law and his life will continue to be one of intent to stay free. He has experienced some of the most egregious violations of rights that any man can experience, yet I still know he shows his big smile and holds his believe in Yahweh, the God who he told me over and over again he believes is using his life to help show that every man deserves their life to be secure in the knowledge that our elected representatives, and those appointed, will uphold the law, not act under the color of it.

Thank you Your Honor for your time to reading this letter. This letter is written on my first hand knowledge of facts as I know them and with intent to help free a man who knows the law, stands upon it and loves America. He is a veteran, he took a stand in uniform to protect America and I truly believe his intentions have and continue to be to live under the law. Everyone makes mistakes, but the law knows mistakes are not intentional and the law is specific and honors the freedom of every man, woman and child. No man should lose his freedom simply because he knows the law. Who does a man knowledgeable in law threaten but a man who wants to break it for his own unjust enrichment.
