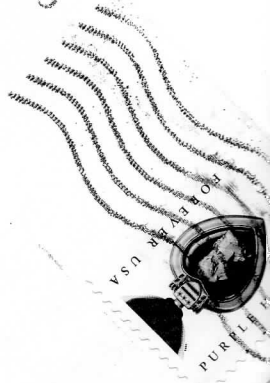

Hello Rudy, I wanted to make you aware of a couple things before I get going. Right now I am only allotted 100 email credits per month that i can use until i get my financial situation right with the government. I'll explain more on that at a later time. I am in the process of having all my financial matters settled. The prison authorities have interfered with my ability to do so at the behest of my prosecutor. Yes, these people are driven by a satanic force. I cannot say it any other way or characterize it any other way. I want to believe in people and believe that the authorities within our government really have the ability to be people of integrity...but they're not for the most part. The staff who run the CMU unit have no integrity at all. It's just as simple as that, and, I'M BEING NICE...REALLY NICE when I say that. I will delve into that more and tell you more about this unit as well. First, let me say that I will be writing you a lot of letters in the coming weeks until I can purchase more email credits. I think you will have to have time to internalize all the stuff I'm going to say to you. No, I don't want you to be an information conduit for me for the Bundy's or anyone else. I am interested in getting to know you and being a part of whatever you have going on from inside and once i get out. I think you are a person of integrity and a real soldier for the right cause. I think you have balls and a spine and wear a cowboy hat proudly. I love wearing my cowboy hat as well !! PROUDLY !! I call myself a "Cowboy, Surfer, Trucker." That's going to be the name of my next business. Because that's what I am at heart. If you can please email Ashley Jones for me and let her know I need her mailing address to write and email her, I would be most obliged. The way it works in this CMU unit(or the BOP for the matter)you have to have someone's mailing address in order to have email or phone contact with them. The same with Mr. Philpot. I am interested in how i can help you advocate for political prisoners or those wrongfully convicted, such as myself. I'm with you on your belief about lawyers. I have come to the same conclusion about the federal "Justice system" as a whole. None of these people have an ounce of integrity or honesty within them. They're as honest or dishonest as they want to be. I think Mr. Philpot is the best I can do. I think he is a man of integrity. I know something about him and a man named MARCUS MUMFORD of Salt Lake City, Utah. These guys have moxie. They take no flack. They're the real deal. n o

I went into the U.S. Marine Corps when i was 17, in July of 1976. I spent (3) years in the Marines. I became a paramedic because i love the profession. My problem was I was not right on the inside. I have had so many things to deal with in my life and i make no excuses for my conduct. I made decisions that I have to live with. But today is a new day. It is my goal to make amends for the life that I have lived in the past. Yes, I was a forger and a thief. I cannot say otherwise. Today, I don't know the person i was. I can't, for the life of me, figure out how i could have lived as i did. With regard to my present case. I was maliciously prosecuted. I am sending you a copy of a lawsuit filed about (10) years ago. It will give you the play-by-play as to what happened to me that brings to to where i am now. In sum, the FBI thought they could squeeze me for information, and, at the same time, turn me into a "snitch" and punish me because I fought them all these years. I did not involve myself in wire fraud. I tried to run a business with this Anita Jenkins lady. She got mad at me over a girl friend I had. It was my fault. I saw all this coming but I didn't part ways with her. She's all i had at the time to run my business. I can tell you more but i think you want to know about where i am today. Also, ask me any questions or for whatever information you want or need from A and I'll answer. ME

While i have been incarcerated I have developed several business that will truly aide society as a whole. Unfortunately, i will have to wait until i get out to implement my ideas. Even then, I will sell my intellectual property and not run any businesses. I do want to own an air ambulance company as well as an ambulance company. I want to own several business that i believe can make a difference in the social engineering of this country. The one thing that is key to all of this is the idea of tapping into the spirituality of people, whether they know they have it or not. I have been the gambit of "religion." I have found more lies than truths in my quest. The one thing i do believe in is a "power greater than ourselves" that is good and wants the best for us. I believe we have been done a disservice by the religious community as to what they project "GOD" to be. I really believe in "the believer" NONE THE LESS, people such as yourself who believe in Jesus Christ and stand by your beliefs. It's easy to say one thing, read one thing, hear one thing, and do another. I'm not as jaded as i sound. I believe that there has to be what people term as a "God", I just believe that I don't know exactly what [h]e [is] and I know that we have a friend in the power of the spirit who calls our name and looks after us divinely. I can tell you many stories on that accord.

I applaud your "view of the world" through the King James Bible. It is my philosophy that if people would live after the Bible, the world would be a better place, as far as Christians and other religious sects go. I am not a fan of the Old Testament. I believe it to be a farce. I hope that I don't offend you. That's not my intention. I am just being honest with you. I believe that there is some truth in the Bible, but I don't believe in the Judeo-christian concept as divine. I can provide you with the reasons for the way I believe the way i do today, but what I believe in today is the good in people. If Jesus is your rock and he is your salvation, I applaud that and get behind it. I have come to know many things that I believe to be absolute. I would like to share some of my beliefs if you would want to hear them. The truth is I'm not trying to argue, debate, or challenge anyone's religious or spiritual beliefs. If a person, such as yourself, believes the way you do about Jesus, I'm right beside you to hold you up. All I can say is I am at PEACE TODAY with my beliefs. I truly belief that we are called for a purpose. As the Bible says: "many are called, but few are chosen." Society at large sees Jesus as this genie who is sitting up in the sky playing chess with their lives. They first have to ask themselves if they hear "the still small voice" as we are taught about in the biblical scriptures. The still small voice has called me. I don't understand it by a long shot. But it has conveyed upon me the ability to know that truth will guide us in the direction we need to go. People will come in and out of our lives. There is a purpose for that. To me, these are the experiences that we are supposed to have. Allow me to switch gears back to what I was saying about the still small voice. I have had the privilege of being allowed to live and first understand the pain and suffering I have caused others. Most of it not of a criminal nature, but a moral one. I let people down who were my friends. I let people down who loved and cared for me in a genuine way. My trek has taken me to the far corners of my being. Today, I am motivated to do good for others. One of my aspirations is to do massage work for geriatric patients in nursing homes. I want to certify as a massage therapist for that purpose. The apostles were said to be taught by Jesus to serve others. Jesus was said to wash the feet of his apostles. This is a teaching circumstance in how we can bestow kindness unto others and reap the rewards of the pleasure that they take in being comforted. When people get old they know what it's like to be forgotten. It's a hollow feeling. The spirit has kept me in a place where I'm never lonely, no matter what's being done to me or where I am. I don't want to rattle too much. Let me know your thoughts and we can compare notes. It is hard to find people in the world like you, Rudy, and me as well. I have to atone for the living of my past. I am fortunate to be given that opportunity. I will tell you a little about my businesses now. As I said because of my incarceration I am not allowed to run or manage a business. I have come to understand that it is not smart for me to ever be involved in the management of a business again. I can be an owner, but the most realistic thing for me is to sell my intellectual property and let someone else run it. I am in the process of negotiating the sale of my intellectual property once I have a forensic financial investigation done on my assets, property, finances. I will then submit the investigation to the Court for certification. At this time I am working to find another lawyer to handle this project. I will be asking 500 million dollars for my IP once the attorney engages my buyer. I have a buyer for that number now. It's worth much more than that. I will also retain some residual compensation to the tune of about 100 million per year. That's just one...I have several that are even more profitable. So I have to do everything by the numbers. I am at the point right now of sale. I will be able to help many people. I will explain more as it unfolds. I will ask Mr. Philpot to handle this matter with the other attorneys in New York City. It is quite exciting. For me it's an accomplishment and a chance to show the world I was not only capable of living a criminal life. My story can help others to achieve their dreams as well. People can start over and do the right thing. IT HAS TO BE IN YOUR HEART. I wanted to say that I have a friend by the name of ALAN DAVIS, of Golden, Colorado. He is a devout christian. His wife works at the Colorado Christian Academy. He is a retired Air Force officer. 

I want to do now is fill you in on the CMU. I will take it a little at a time so you can ask me questions and i can answer. But before I do where is Forney, Texas ? From the map it looks like it's east of Dallas somewhere. I was trying to remember if I've driven through there when I drove truck for Atlas Van Lines ? I know where Seagoville is and i think it may be close to that. It says Forney has a population of about 5,000. Just curious. I have some relations in Dallas. I actually plan on buying a house there and I will have offices there once I am released. I have BIG PLANS in Dallas. Hopefully Forney is somewhere close to Dallas. I really love Texas and the people. I like the cowboy lifestyle but I'm also a surfer, ride motorcycles, ski, run, exercise, do all kinds of stuff in nature. I really miss surfing and motorcycle riding in the desert. I used to live on the back of my bikes. O.k., the CMU is truly an evil and diabolical conception. I am familiar with the guy who conceived this place by the name of Leslie Smith. He's dead now. When i was at the ADX Maximum in Florence, Colorado, he was the "SIA"(Special Investigative Agent)for the prison. He made his bones turning gang members into snitches to testify for the government in the prosecutions against the Aryan Brotherhood, Mexican mafia, etc.. Actually, I never had a problem with that. He was doing his job and the gangs he was targeting needed to be stopped. I get all that. Actually, Smith was not that dishonest of a guy, but he was a real underhanded, mean-spirited guy who lied to me on several occasions. I knew he was trying to mislead me when he spoke to me. I didn't have respect for him for that reason. Smith recruited staff of the BOP who are of his ilk. He recruited mean-spirited contemptible people who just are both anti-social, occupationally handicapped, and social misfits. The only life they have is the BOP and doing the bidding of the BOP. This unit is funded with about 27-30 million dollars a year to watch over roughly (80) people between Terra Haute, Indiana, and the CMU-Marion, Illinois. They put people like myself in this unit to keep me from being about to fight my criminal case or maintain any of my financial or property assets on the outside. Their goal is to destroy my contacts in the community so I have nothing left. They lie to the public and claim otherwise. This unit is ran by staff who lie to you constantly and think they are dealing with intellectually inferior people who don't see and understand what it is they're doing. They retaliate against me for utilizing the administrative remedy process or court filing by writing me what are known as "incident reports" to take away what little I(we) have in this unit. I just had this done to me last month. I have been written these I/R's to keep me in this unit and to hinder my ability to speak on the phone or email. That way they can interfere with my mail and decide if mail they want to go out, goes out, and the like. For instance, I was written a bogus I/R in February, 2017, for asking my lawyer in Reno, Nevada, to send my files to this lawyer, Dennis Hartley, in Colorado. There is no rule violation against that !! This is what they've done since i have been in this unit since November, 2010. The DHO found me guilty because he was put up to doing that by unit staff. Now he has to answer for this in Court. Everything associated with the CMU is scandalous and satanic. Again, the staff of this prison, by and large, have no scruples whatsoever. They will do what they are told. They don't care about right or wrong unless it affects them. I am about to bring huge lawsuit on this prison, the CTU, and all those involved in what they did to me. I'm sure Mr. Philpot will have a field day with what he's about to find out. If you are interested in a copy of my complaint that I file for your reference, please let me know. Basically, this unit was designed to shut people up once they were getting flack about the unit being designed for terrorist prisoners. We have these guys in here. For the most part they are mentally ill zealots that have no religious format to their terrorism. They are TERRORISTS. make no mistake about that. I have no problem with the BOP staff controlling terrorism. But that's not what they're doing. Congress must know that this unit is not being operated the way it's supposed to. I have no reason for being here other than my prosecutor and judge are doing what they can to try and thwart my ability to have my malicious prosecution overturned. No matter what they do the truth is coming out...and it's ready to happen right now. The jig-is-up on note. In the coming weeks you will see what I'm talking about. Please let me know what else I can provide to you. Please let me know how I can help and assist you. I look forward to hearing from you. Be well to you and Erin. that
