Hello Rudy, peace and love to you and Erin today. I decided to write to you (via snail mail) as opposed to email as I will run out of credits if I tried to email all this information. I truly understand how busy you are. You are only one person trying to divide your time to so many people. Each person has wants, desires, needs, help, problems, etc.. Each person believes that their problems are atypical and need the help the most...and right now- I get all that. Let me say a few words here about the situation with my mail. In that regard you suggested that I write you a letter for "public consumption" and when you get the time and opportunity you will upload the same to YouTube. That's a great idea and one that I would truly appreciate in the first instance. There is one hurdle involved in that idea that I wanted to share with you and see if you can assist in a small way to that end. The prison staff here, specifically the "Intelligence Research Specialist", Kathy Hill, who works with this "CTU Unit" in Martinsburg, WVA., dig into their bag-of-tricks at every opportunity to mess with a person like me. I am not the only one but I'm going to talk about me in this letter. This "Bag of tricks" is their unofficial "Playbook" they utilize to cause grief and dissent for people like me that has no penological reason or otherwise connected to it. In sum, they do it BECAUSE THEY CAN. The hope, here, with them, is that I will get tired of them treating me like this and I'll succumb to their program. That isn't going to happen and will only make me more vigilant and zealous in my legitimate pursuits to bring justice to my situation.

O.k., the deal here is they're now employing the tactic of sending my mail back. I haven't received mail from certain people in over a month now. Specifically, lawyers that I needed to hear from regarding my pending appeal in the Tenth Circuit. This IRS-Hill and case manager-Gary Burgess lie repeatedly and constantly about the status of the mail. I asked Hill the other day about my mail not getting to me and she came up with some nonsense about the mail she receives is the mail I receive. That's not true. I could use some colorful words here but will not. Your latest email confirms what has been going on to that extent. I will send you a letter for you to put up for public consumption. If I might ask you can you ask that the person who replies will also email you so you know that they replied to me? That way the prison cannot send my mail back and I don't know about it...which is what they're doing now. Just a thought. I wanted to reiterate that I have no desire to harm you, mislead you, or otherwise. I'm sure many prisoners would do such a thing to you. My mistake in the past was not trying to extend myself to professional individuals. I tried to help prisoner's families and I trusted this Anita Jenkins as well. Things happen that go wrong sometimes, but she was mad at me over another girl. I was wrong to have had a relationship with her in that way. I should have been more professional myself. But I don't use or abuse people. As you will see from my text, below, this is the kind of relationship I am looking for:

Greetings, My name is Monty Akers. I am a prisoner currently serving a federal prison sentence for (1) count of wire fraud that I did not commit. I am in the process of having my malicious prosecution overturned. There is information concerning my person on the internet that describes me as a "con man" or somebody who has used and abused people I enlisted to help me. None of what is said about me is true. I can prove that each and every last word of what has been said about me is untruthful. I am looking for an assistant who can work with my attorney to handle my clerical needs. My needs include: obtaining information from the internet and sending it to me, contacting lawyers when need be, handling emails coming to and from me, and phone calls from me from my place of confinement, which is Marion, Illinois. My lawyers would be the ones to employ you and handle all financial matters. I will not be involved in any financial matters whatsoever. You would work directly with my attorneys for all compensation. I am looking for an honest and reliable assistant. This opportunity will benefit us both in many ways. Please respond to me at the address below and tell me about yourself. I will then contact you and we can discuss this entire matter. I look forward to hearing from you. Kindest regards, Monty Akers

This is what I have come up with. Tell me what you think? I'm sure you can rephrase it or re-write it for content or otherwise. Again, what I am concerned about is that the prison will send the responses back without me knowing about it. If the prospective contact can email you as well and just let you know they answered me we would have a tracking on that as well. Again, tell me what you think? I truly appreciate your help and assistance. I tried to keep it as short and concise as possible. Tell me if you need more information. Respectfully, Monty Akers
