

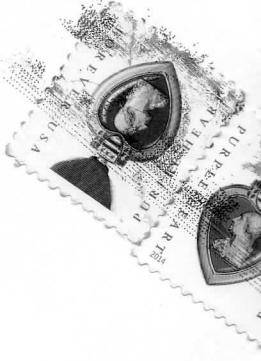

FACTS

- 1) SEPTEMBER 2011, START PUBLISHING BOURBON BYSTANDER (BOURBONBYSTANDER.COM & FACEBOOK/BOURBONMO) HIGHLIGHTING POLICE, JUDICIAL, MUNICIPAL CORRUPTION IN CRAWFORD COUNTY. I HAD ALSO PUBLISHED THE "BULLETIN" IN JEFFERSON COUNTY, ST. FRANCIS AND WAYNE COUNTY SINCE AUGUST OF 1996. IN 2009 I STARTED A YOUTUBE CHANNEL, YOUTUBE/BULLETINMAN.COM.
- 2) IN THE SPRING OF 2012, THE CRAWFORD COUNTY SHERIFF DEPARTMENT LED BY A PAUL SATTERFIELD CONDUCTED A RAID ON MY SEASONAL EMPLOYERS FOR OVER 20 YEARS, WHICH YIELDED SOME LED BUNKS. THEY CLAIMED TO BE ILLEGAL. I WAS ALSO MADE AWARE OF THE 2006 "MURDER" OF AN ALLEGED DRUG DEALER NAMED I BELIEVE TO BE (BEAN SHOT IN THE HEAD TWICE, MEMORY IS NOT WHAT IT USED TO BE) KELLEY BEANOT BY THE CRAWFORD COUNTY SHERIFFS DEPARTMENT. SO I DECIDED TO RUN FOR CORONER, I LEASED AN APARTMENT FROM LARRY MASREANS WHOSE BUSINESS HAD BEEN TARGETED BY THE MHP AND ECSD, WHO WERE NUMEROUSLY FEATURED IN MY VIDEOS OF (NOTE MY 9-12-11 MO HIGHWAY PATROL, PROFESSIONALS IN PRINT AND ON THE WEB.
- 3) IN AUGUST OF 2012 AT THE COUNTY FAIR, I WAS APPROACHED BY A SEAN SATTERFIELD (A LT IN THE HIGHWAY PATROL SOMEHOW RELATED TO PAUL AND SGT FOLSON & CAPT. METTENS SUPERVISOR OFFICER IN THE MHP) AND WARNED TO SHUT-UP OR I WOULD BE SILENCED!

- 4) ON AUGUST 17 2012 I POSTED "THE PARTY IS OVER" VIDEO WHICH HIGHLY UPSET THE POWERS THAT BE. I WAS GOING TO LEAD AN OCCUPATION OF THE COURT-HOUSE ON CONSTITUTION DAY SEPTEMBER 17TH. GIVING THEM 4 WEEKS TO ACTUALLY HONOR THEIR OATH.
- 5) ON AUGUST 22ND, SGT. FOLSOM AND CPT. MORTON WERE COMMANDED TO MAKE CONTACT WITH ME. THEY FOUND ME AT MY OFFICE/PERMEXIT RESIDENCE IN FRANKLIN COUNTY. THEY ASKED ME TO COME OUTSIDE AFTER TALKING TO ME FOR ABOUT 30 MINUTES. SGT FOLSOM ANNOUNCED HE WOULD BE SEEKING A SEARCH WARRANT BASED ON THE SMELL OF MARIJUANA. CPT. MORTON ADMITTED IN DEP'S HE DID NOT SMELL ANY POT. I AND MY WIFE WERE DETAINED OUTSIDE MY OFFICE FOR OVER 41 HOURS WHILE FOLSOM WENT JUDGE SHOPPING. HE CAME BACK WITH A WARRANT FROM JUDGE DAVID HOUXX BUT WITHOUT THE FRANKLIN COUNTY SHERIFF (IN VIOLATION OF RSMO: 043.200) THE SCOPE OF THE WARRANT WAS TO SEIZE MY COMPUTERS/CAMERAS. THE LAST LINE WAS POT! THESE ACTIONS IN EFFECT STOLE MY PRINTING PRESS AND COMPROMISED MY SOURCES OBTAINED BY MY SERIES OF ADS PUBLISHED IN THE LOCAL PAPERS, WHICH ASKED PEOPLE WHY HAD PROBLEMS WITH THE POLICE? OVER 200 PEOPLE CONTACTED ME IN THE SPRING OF 2012. MY 16TH BIRTHDAY BULLETIN WAS IN ONE OF THE COMPUTERS WHICH REMAINS UNPUBLISHED, OF COURSE I WAS HAMMING HANDED & POINTING FINGERS.

- 6) LATE AUGUST 2012, I POSTED HUMEROUS VIDEOS OF PHONE CALLS I MADE TO MHP HQ IN JEFF CITY DEMANDING SGT. FOLSOM BE FIRED (HE WAS AFTER THE 9/11/12 FOR ONE WOULD IMAGINE FOR NOT FINISHING THE JOB." (MURDER). T.T. 10/9/13 P.254255
- 7) ON 9/7/12 I FILED A WRIT OF HABEAS CORPUS SEEKING THE RETURN OF MY PUBLISHING EQUIPMENT WITH THE MISSOURI SUPREME COURT. UNKNOWN TO ME THE COURT REJECTED IT FOR LACK OF A FILING FEE \$ 70 (DESPITE ARTICLE 1 SEC 14 MO. CONST. JUSTICE SHALL NOT BE FOR SOLE, DELIBERATE OR DELAY) AS OPPOSED TO FAKING ME OR CALLING ME, THE CLERK WROTE A LETTER RECEIVED THE AFTERNOON OF 9/11/12.
- 8) 9/11/12 JUDGE ~~AT~~ HOWARD ISSUED AN ARREST WARRANT (SGT FOLSOM DESPITE HIS RELUCTANCE TO SERVE IT, WAS OBLIGED BY LT. SATTERFIELD TO FINISH WHAT HE STARTED. P.274, Taped TRANSCRIPT). FOLSOM AND MERTENS CAME UP WITH A RUSE (LIE) TO LURE ME INTO THEIR AMBUSH. THEY CHOSE AN MFA GAS STATION ABOUT 2 MILES FROM THE OFFICE AFTER MAKING SURE THE MFA HAD NO CAMERAS. THEY CALLED ME UP AND TOLD ME THAT THEY HAD BEEN ORDERED BY THE COURT TO RETURN MY EQUIPMENT. I TOLD THEM I WOULD BE BRINGING SOMEONE WITH ME AFTER TRYING TO FIND SOME PASTOR "FRIENDS" UNSUCCESSFULLY. I CALLED MY EX-WIFE TO HAVE HER RECORD THE MEET OVER THE PHONE. I ALSO STARTED MY VIDEO WEAR WATCH WHICH PROVIDED A VIDEO ACCOUNT AS WELL AS AUDIO.

8) CONT. UPON ARRIVAL 9/11/12, 1:13 PM, SGT Folsom & Cpl. Meeters ARE PARKED ON THE NORTH END OF THE PARKING LOT. THEIR "BACKUP" TWO FBI AGENTS AT THE SOUTH END, WHO WERE ASKED BY THE GUTTER REPAIR MEN TO BACK UP SO THEY COULD WORK ON THE GUTTERS (Folsom THOUGHT THEY WERE THERE TO BACK ME UP. T.T. PAGE 369) I PULL AROUND IN FRONT OF Folsom AND MEETERS CAR WITH MY HATCHBACK FACING THEM TO LOAD MY COMPUTERS.

9) I EXIT MY SUBARU, WITH MY LAWFULLY CARRIED LEGALLY OWNED 9mm IN HIS ARMY RETINATION HOLSTER STRAPPED TO MY LEFT HIP. EVEN THOUGH I'M RIGHT HANDED, I HAVE TO PUT IT ON THE LEFTSIDE TO STRAP MY SEATBELT. SGT. Folsom UPON SEEING MY WEAPON ~~HE~~ IMMEDIATELY QUESTIONS MY RIGHT TO HAVE MY GUN (VIOLATING ART 1 SEC 23 MD. CONST, "YOUR RIGHT TO A FIREARM SHALL NOT BE QUESTIONED") Folsom THEN ORDERS ME TO THE GROUND AS I'M GETTING DOWN HE SHOOTS ME TWICE IN THE HEAD. MEETERS FIRES TWICE THOSE BULLETS IMBEDDING INTO THE GAS STATION WITH 6 PEOPLE INSIDE. THE LAST BULLET Folsom SHOT ENTERED THE BASE OF MY SKULL EXITED OUT THE OTHER SIDE AND INTO THE GROUND. I WAS GOING DOWN TO THE GROUND. Folsom ADMITTED AT TRIAL HE WAS NOT IN FEAR FOR HIS LIFE (~~HE WAS NOT IN FEAR FOR HIS LIFE~~) THUS HAVING NO LEGITIMATE REASON TO OPEN FIRE!

Folsom POS IN PARAGRAPH # 6 "Weinhaus THEN PASSED AND BEGAN TO SHAKE AS IF HE HAD A COLD CHILL. I THEN ORDERED WEINHAUS TO GET HIS HAND OFF THE GUN" NOTE THAT TBO IS NOT ON THE TAPE. "Weinhaus Refused to Comply AND STATED YOU'RE GOING TO HAVE TO SHOOT ME" THE TAPE SHOWS THAT I WAS GOING TO THE GROUND AND IT IS DISPUTED AS TO WHAT I SAID. I HAD AN AUDIO REPORT WHO WAS NOT ALLOWED TO TESTIFY BY MY OWN COUNSEL, MY COUNCIL ALSO FAILED TO CALL THE FBI TO TESTIFY AFTER THE P.A. TOOK THEM OFF HIS WITNESS LIST ONCE THEY WERE DEPOSED. CUNNINGHAM FBI Special AGENT TESTIFIED TO MHP INVESTIGATES (12-261-015-012) "WHEN WEINHAUS STOPPED (AFTER WALKING TO THE REAR) WAS STANDING IN A BIASED POSITION WITH HIS RIGHT SIDE EXPOSED TO AGENT CUNNINGHAM'S VIEW" (THAT WOULD BE THE SIDE THAT Folsom & MERTENS CLAIM THE GUN WAS HOLSTERED) AGENT CUNNINGHAM "SAW ~~WEINHAUS~~ ^{WEINHAUS} POSITION HIS HANDS TO HIS FRONT WAISTBAND" NOR HE MENTIONED OF A HOLSTERED WEAPON, NOR ANY ATTEMPT TO DRAW IT!

IN SGT. FOLSON REPORT TO THE MHP CONTROL NUMBER 12 236 008 011 PARAGRAPH #5. HE ONCE AGAIN CLAIMS THAT HE HAS PAPERS TO SIGN TO GET HIS COMPUTERS BACKS (NOT ON TAPE) "I IMMEDIATELY RECOGNIZED THAT WEINHAUS WAS NOT RESPONDING TO MY CONVERSATION" (ON TAPE WE EXCHANGE GREETINGS AND CONVERSE ALL THE WAY UP TO THE SHOOTING) "I THEN CONTINUED TO APPROACH THE REAR OF WEINHAUS VEHICLE WITH THE FILE FOLDER IN MY HAND. FROM THIS VANTAGE POINT I COULD SEE THAT WEINHAUS WAS STANDING WITH HIS BODY BIASED WITH HIS RIGHT SIDE OUT OF MY VIEW. I WAS ABLE TO SEE BOTH HANDS WERE EMPTY. NOTE THE FBI AGENTS MAKE NO MENTION OF ANY GUN! DESPITE HAVING A CLEAR VIEW OF MY RIGHT SIDE. IN ADDITION TO THE STILL SHOT 1/29TH OF A SECOND THAT REFLECTS THE HOLSTER ON MY LEFT SIDE! FOLSON GOES ON TO REFER TO THE GUN BEING ON MY RIGHT SIDE THROUGH-OUT HIS REPORTS - DEPOSITIONS - TRAIL TESTIMONY
