As I have mentioned, it is time to produce an essay that reveals how millions of people are being prosecuted where NO LAW JUSTIFIES IT. Because

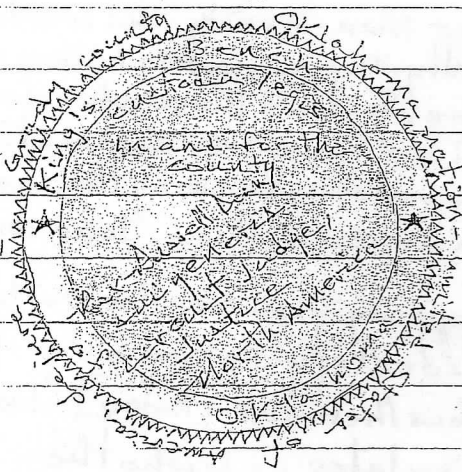


