"SURVIVOR'S GUIDE TO PRISON" by Monty Akers 

It has been awhile since I did a composition for my friend, Rudy Davis. Rudy is a busy guy and has a lot on his plate. Sometimes it is hard for people to realize what is going on around them that can feel just like being in prison sometimes. For me, the most humiliating thing is being at a disadvantage. People will get cocky when they have you at a disadvantage. Little do they know what that outcome may end up being. You can't warn people like this because they are literally like machines. And when I say "machines" not in the sense of working like a Swiss watch or well-oiled machinery, but worthless slagheap denizens of humanity. Let me explain. People don't speak much about prison personnel in our society. They are people that live in the shadows, a subculture that has no roots and has nothing to compare it to. Granted, we need prisons and there are some decent people who work in prison. I've known a few. I've also known some really bad ones. People that cannot be counted as part of the human race. I'm going to talk about a couple of those MONSTERS today. But before I do, let's inject some "spiritual understanding" at the forefront of this talk.

Most people have a belief in one form of religion or spiritual understanding. The common denominator is that there are people who make mistakes and we all, as part of the human family, have to some degree or another fell short of what we intended in our lives. Sometimes our life stories are not told as they should have been. In any event it is important to take responsibility for the actions that we decided to take. Sometimes we cross paths with an individual who goes beyond the capability to reconcile their being as "human." The one I want to speak about today is a person by the name of KATHERINE SIERVELD. This person is one for the ages. Sierveld has worked in the Bureau of Prisons as a "legal advisor" ~~SINCE~~ she graduated from law school in 2008. She's never held a position in a law firm and never practiced in court. Her career has been being assigned to what's known as the "Communications Management Unit" in the Federal Bureau of Prisons at Terra Haute, Indiana. Sierveld's job description is to advise BOP staff on BOP Policy and procedure. Little did anyone know that Sierveld obtained this position when the CMU's first opened. Sierveld is a professed Zionist Jew. She has been involved in every form of skullduggery known to man in violating BOP Policy, lying, deceiving, and cuddling up to my prosecutor in Kansas, Kim I. Flannigan, who's birth name is Kim M Berger. AUSA-Berger enlisted Sierveld's help back in 2009 when Berger was told I would be transferred from the ADX-Max facility to the CMU-Marion in doing what she can to destroy my professional and personal contacts in the community. Then she calls my prosecutor, Kim I Flannigan (the name she goes by now) and can't wait to get an "atta-girl" for doing that- She is truly a wretched person.

I can sit here all day and speak about the acts and actions of Katherine Siereveld which, I might add, I will do in a separate editorial. Now I want to bring in the concept of "Survivor's Guide To Prison." The Katherine Siereveld's of the world are like bouncing balls that go nowhere and then you're wore out. My friend recently produced a documentary for the cinema about life in prison called "Survivor's Guide To Prison." It teaches society as a whole what is happening around us that we have no idea is going on with us. I recommend this film to everyone. The actor, Danny Trejo, and my friend David Arquette, collaborated on this movie. Society has been plagued with crime from the beginning of time. I, too, have been a part of the problem. But what I am not liking is the truly good and decent people of our society will suffer as a result of the Siereveld's who are allowed to forward an agenda in order to cover-up for people who are more vicious, as I said, than Hitler. I also want to make it clear I am no fan of Hitler's or the Nazi movement or white supremacy or any of that. I believe in being proud of who you are and your race. I am white and I'm proud of the white culture as I am with people of different cultures as well.

But then you have people who commit crimes like pedophilia, rape, murder, child pornography getting a slap-on-the-wrist and sending them on their way. You have prison officials, here at Marion-USP, mismanaging funds and projecting to the public that we have these programs in the CMU which we do not have. What this boils down to is a wide diversity in right and wrong ? What can be done about it ? Something can be done but you need a lot of media attention. That's my goal for the future. Once people have incentive to to right the wrongs, that will happen. Nothing happens faster than in America when people want something to change in a big way. So I will make it a point to make an economic incentive for each person to help change our society. I'll bet if a person was paid \$250,000 a year to change society they would do it. In that we begin to under how we survive the prison that has been build around us.
