. My name is David Hinkson and I have a degree in Naturapathe; and I have been a political prisoner since 2003. I was targeted and put into prison by the FDA because they did not want me to manufacture my health products that I talk a little bit about in the next paragraph.

FIRST PROJECT (OF SEVEN)

1. In the past I built a very successful health food supplement business called WaterOz; that was processing different heavy metals like Copper, Zinc and Calcium in to a health supplement. As Copper is normally very toxic and if made wrong it is an extreme poison, when I put this new Copper product into a form that was now non toxic and did the clinical studies working with 1,000 U.S. Doctors and with the Doctors that worked with for Doctors Without Borders in Russia and the Ukraine we had some very interesting results. For example I was able to remove the common cold in about two to three hours; Aids only took 20 days; T.B. took one 15 treatment a day over two days using a Nebulizer. Then I discovered that if enough of this Copper product is consumed to raise the Blood Serum levels it would hundred percent remove all Nitrogen Breathing Pathogens/Viruses and even Parasites (River Blindness and Malaria). Copper (unlike Silver) can cross the Blood Brain Barrier and the Spinal Fluid Barriers and this means that it can even be used to stop and treat conditions like the Brain Eating Ameba that there is currently no cure for. I have a lot to tell you about all of these concepts and I have overseas contacts that can verify what I'm saying in this email as I even had many overseas customers. Note that Copper also is a co enzyme that allows most all proteins to digest. Many diseases that there are no cure for are known to be caused by the improper digestion and assimilation of proteins. During these tests we even had a case of Sickle Cell disappeared; I never finished my clinical testing on other diseases like M.S. and/or M.D. but I believe Copper might also help these conditions.

I was giving a lecture on Infectious Diseases in Xharcove Ukraine to over 150 Russian Speaking Doctors in November of 2002 (when they said I was here doing crimes) in attendance was the Surgeon General of the Ukraine and Belarus and my interpreter was Roman Ponomarenko (who is now working in the Senate in the Ukraine). The reason that I'm writing you this letter is that my factory that was making these health products mysteriously burned down about eight months ago, and I know that you would be interested in having this Copper product freeze dried and pressed into the form of a pill that could be used for defense purposes against pathogen attacks of all kinds as we could now stop all biological attacks, while even curing the common cold. I named this green energy device the GALT Motor/Transformer. This GALT device runs very cool and therefore has a very low heat signature; while at the same time creating a lot of electrical energy; while at the same time creating Torque on it's rotating shaft. The reason that this device is so effective is that it can run the magnetism in this Transformer Torrodial Core concept at full saturation; and I believe that this has never been achieved before. This means that we can now put over 40,000 Micro-Henries into a one inch Torroidal Steel Core; and this means that a GALT 1 (one inch core) can create over 88 KW (and is only physically only 9" wide X 9"); and this GALT 1 has a 3/4" shaft that also produces about 5 horse power at the same time it is creating this electrical energy. This GALT can be used to replace the Nuclear Reactors in all of the Nuclear Submarines, Aircraft carriers and all other Nuclear Reactors everywhere in the world; and it could also be use to power torpedoes with endless range; it can also be used to replace all Jet Engines even in fighter air craft. Part 1

. My name is David Hinkson,

I'm writing this email for the purpose of introducing myself. I have an overall business plan that I would like to share with you after you in the next few emails. I appreciate your time in reading my emails.

The reason that I'm writing these emails is that I want to take the time to explain just one of my 10 different green energy devices that I actually made work and I even have a picture of it lighting a light bulb; and I know that the U.S. Navy could really use this right now to solve some of their logistic and defense problems. But before I get into what this device is capable of, I would first like to take the time to tell you a little bit about my self so that you might understand where I'm coming from and what I have achieved in my life.

SOME BACKGROUND HISTORY: I grew up in Long Beach California and my love was racing my dirt bike. By age nine I was rebuilding motorcycles and had my own complete repair shop. In 1971 my family moved to Ouray Colorado.

When I was just seventeen years old I talked to the U.S. Navy Recruiter in Montrose Colorado and found out that I could join the U.S. Navy if I first passed my GED. I got permission from my parents and thus traveled to the Western State College (in Gunnison CO) in 1973 and took this test. I had not taken any prep courses to prepare me for this test and was therefore not really prepared but I got a very high score and passed. I then went down and took the Navel exam for mechanical and electrical aptitude, getting a very very high score and was thus offered the program of becoming a jet mechanic. I then after boot camp went to Millington Tennessee and took the ADJ training program; and while in this class they asked if anybody wanted to volunteer to take the course on Helicopters and I volunteered.

I therefore ended up being permanently stationed at Norfolk VA, HSL-30 and my designation was ADJ; and I started out maintaining SH2F Helicopters that were used daily in search of Russian Subs. As I was disappointed in the fact that I was really only doing maintenance, I volunteered to be a Plane Captain so that I could fly Anti Submarine search missions.

As I had friends that were trained in Anti Submarine War technology and I had a lot of interest in anything electrical or mechanical I ended up studying all of there text books for this designation.

During this period of time I went and visited the G E technicians who resided in a trailer on base so that I could explain to them about a new idea that I had for a new efficient magnetic motor. They just laughed at me and did not take me serious.

When the Vietnam War ended early in 1976 I had the chance to get out a early with an honorable discharge so I left the Navy.

I then went to Ricks College in Rexburg Idaho and my major was business finance. But my real interest was always and still is physics.

While at Ricks College I took the exam to become an Insurance Broker and a Stock Broker and passed both and started working for Farm Bureau Insurance selling all kinds of insurance bonds and annuities. I was still going to school and sold more insurance in the State of Idaho than most of the other agents; and thus ended up being asked to run the Driggs Idaho Insurance office as the broker in charge. I then quit this job after graduation and moved back to Colorado and;

Enrolled in the University of Colorado getting my GRI (Graduate Real-estate Institute) designation (equal to a two year degree) and took the test to become a Real Estate Broker and passed. I was able at this time to buy properties using creative finance and even taught creative finance classes.

As the economy was a little bit bad as the bottom had dropped out of the Real-Estate market and I had purchased some property on main street in Olathe Colorado, I turned this into a board and care home for

the mentally ill. After doing this for about 6 years I moved to Las Vegas Nevada; and met the late "George Mitzel". George had owned over 1,200 gas stations up and down the west coast during the great depression and had sold them and then had built a Casino called the San Suisse on the Las Vegas Strip. Later he sold this Casino to Howard Hughes who then changed the name to the Castaways; then Mr. Mitzel had used these funds to purchase 700,000 acres of land out in the California Desert near the Nevada Boarder and when I met him he was in the process of fighting with the BLM over who really owned this land as the BLM had seized it. I had no back ground in land law at this time but I had met another law professor, the late "Charles Crum". I spent a lot of time traveling with Charlie to the Federal Archives at the UNLV in Las Vegas Nevada and other places as we researched the legal land issues going back to the founding of this country in 1776. After much study on these land issues I became the foremost expert in the world on pre Civil War legal land concepts.

Part 2

. On or about 1988 I had received a letter of credit from the Chinese to sell and deliver to them 30,000,000 worth of fertilizer (ground up rock material out in Winnemucca Nevada) and after having some problems fulfilling this contract, I met the late George Grazadie (known as a famous mob attorney) and became his partner in this venture, but we failed to ever deliver on this contract. After the deal went south and as I had become good friends with George, I started working with George without pay, doing pro bono legal briefs that became the Sage Brush Rebellion number two. Yes we won at this time.

While working in George's law office I met a guy who was an contractor (if you know what I mean) who gave me some very damning papers that exposed Harry Reid's criminal activity; which I exposed on the Lue Epton Talk Show; and I also met the late Douglas Noland (who was hired by George as a mining expert to testify in federal court cases). Doug Noland was also an Alchemist and a scientist. His father was a Rosicrucian who had worked out at area 51 and when I met Doug he also had worked out at area 51 under a top secret clearance.

At this time as I became friends with Douglas Noland he asked me to do his legal briefs to save his mining claims from the Harry Reid BLM attacks that were coming out of Harry Reid Environmental Research Center in Las Vegas. I therefore wrote all of the legal briefs (with George helping) that then forced the BLM to surrender and stop their attack against all of the miners and ranchers.

After saving Mr. Noland mining claims, I learned that he had actually found the mother load of Platinum out in the Nevada desert. He had many claims but the claims of most interest were the 200 claims that were 20 acres each out somewhere near Winnemucca Nevada. There was also a man who was Doug's friend named Jack Carter who also had filed on some mining claims right next to Doug's. Now, I found out and it was proven to me that there was on average about 3,000 ounces of Platinum in every square yard of soil on most of these claims (no grinding of rock was even necessary). This was truly the undiscovered mother load of Platinum. It is not even very far from the famous Comstock Load near Carson City. I really had and still have no interest in this Platinum project as I have other things that are more interesting to me and now that Doug has died I have no problem letting someone else know about this find. I mention it here as there is literally trillions of dollars worth of Platinum on this 2,000 acres. In fact there is enough Platinum on these claims to back the whole U.S. Monetary Supply with something of real value and this means that this knowledge has National Security Ramifications. I have no financial agenda now at this point in time except for pointing it out to you and if you want my help in the future to do something with this information I would love to help you. If you are interested in having someone go out there to do a start up program under your funding program, I would help you in any way possible.

During this period of time I was on the Lue Epton talk show (Lue was a movie actor who appeared on the Kojack show with) as a co host guest about 300 times. I really upset the powers to be during this period of time as I exposed a lot of Harry Reid's corruption. I arranged for thousands of protesters to protest Harry's Endangered Tortoise Scam and filled the Cashman Field with about 10,000 angry people who all protested; and during these activities I was directly responsible for the unelecting of five Clark County Commissioners; as we had Veterans from the Veterans of Foreign Wars helping to stuff over 600,000 political letters. Also during this period of time I myself ran for the Clark County Commission and lost to Erin Kenny by a few percentages. Also during this period of time I was introduced to Erin Russo (famous movie director) who was running against Harry Reid; and Mr. Russo lost this Senate Election by only 2%. I would meet almost daily at the Blue Berry Hill on Flamingo Road in Las Vegas with Lue and Erin as we planed our overall election strategies'.

As I worked with Douglas during the late 80's I started doing my own talk show and my co host was Rod Remlin. I was broadcasting on the World Wide Christian Radio (my show was called the David Hinkson Show) out of Nashville Tennessee. I was on the air right after the famous and late Bill Cooper's show (who wrote the book "Behold The Pale Horse"). I therefore had the honor of having Bill (ex Navel Intel.) on my show many times and we became very good friends. I also interviewed many other interesting guest during this period of time (for example I interview Leo Wanta, Ted Gunderson and many others - note I do not like Ted). I also interview a man named David Hudson who talked about how he had discovered "Mono Atomic Gold". I then shared this Mono Atomic Gold information with Douglas. Doug then showed me four five gallon barrels of this mysterious white powder that he had collected as it had stuck to his filters when he was doing a leach mining project. Doug then became obsessed with trying to turn the White Mono Atomic Gold into Yellow Gold; and after six months of trying to get it done with me providing moral support in his laboratory, I finally witness Doug turn some of this White Powder Gold back into regular Yellow Gold. I have therefore now worked on my own to turn Yellow Gold into White Powder Gold and White Powder back into Yellow Gold. I now believe that I'm the only person on this planet who now maybe knows this whole secret process, but again this is not my current interest.

In 1989 I discovered that I had Cancer. My focus now became working on medical concepts and I started a company which I named WaterOz (see WaterOz.com). I thought of the name WaterOz (Water and Ozone) after I started manufacturing Ozone Machines officially for spas; but I discovered that most people wanted them for medical purposes. I therefore sold a thousands of these Ozone machines while making no medical claims. I in fact became an expert on most Ozone theory and concepts.

My personal mission statement at this time was that I believed that we needed to process and do toxicity tests on every mineral on other Periodic Table to see if we could find some new medical concepts. During this period of time as I was still living in Las Vegas my official testing was done by Larry Wayne Harris who had just retired from the CDC in Atlanta Georgia. Larry had been on the Lue Epton talk show and had met a Mr. Rockwell on said same talk show (who I believe is a contractor). Mr. Rockwell had invited me and Lue Epton over to his home to see some technology and he at this time showed us the original Rife Frequency technology that was invented by the famous Royal Rife and my comment to him was why is this not in a Museum. I was really impressed and at this time and asked him how he got this equipment and he stated that he had been an assistant of Mr. Rife's. I knew this was a lie as Mr. Rockwell was my age and Mr. Rife had been assassinated in the late 30's.

Then a few weeks later Mr. Harris called me and asked me if I would go out to dinner with him when he arrived in Las Vegas and I said yes, but we never got together for dinner as Mr. Harris was arrested for having Anthrax when he arrived to meet Mr. Rockwell; as Mr. Rockwell had the FBI and CIA waiting for him at the McCarran Airport in Las Vegas; and then I saw Bill Clinton talking about Mr. Harris on National TV.

During the year 1993, I wrote four main thesis papers concerning physics concepts. The most interesting one was that I believe that I finished the Unified Field Theory that was never finished by Albert. As I did some testing on some of my concepts I discovered a concept that I termed to be a Unipole Magnetic Track that was designed to rotate (a race way of magnetism with all of the poles aimed the same direction) and this concept was very similar to the Unipolar Magnetic Field that was invented by the late Nicola Tesla, but Tesla's Unipolar concept did not rotate. After attaching a series of magnets onto an aluminum wheel I discovered that I could make this wheel rotate forever using just magnetic fields driving magnetic fields; creating horse power without the need for any fuel. I named this concept the GALT Motor at this time. The main problem with this concept was that it wanted to levitate off of the table and at this time I realized I had created a device that would push against dark matter and levitate (see JohnSearl.com) and the acronym for this levitation became S.T.I.W.L

By 1995, I decided to move WaterOz to Grangeville Idaho so I purchased a farm in a remote location and built a factory there.

As I did my own clinical testing on my different WaterOz mineral products that were made differently than all other products on the market I learned and proved some very interesting things; for example, I could now remove the common cold and even the symptoms in less than four hours using a combination of my minerals in solution. Then I learned that this same formula could also be used to remove all Nitrogen Breathing Pathogens and even Parasites (including the brain eating ameba); and this means that it could be used to protect against all biological attacks even on the battle field. Therefore the concept of have these minerals on the battle field has military application. For example:

1. Copper is normally listed with lead as toxic and is known for being able to kill all Nitrogen Breathing Anaerobic Pathogens and Parasites. I found that I could put Copper into a non toxic form and then it could be used to 100% stop the plagues. Copper in this form has now been proven to cross the Blood Brain Barrier (Silver does not) as it can penetrate everywhere that there is moisture through the entire body system.

2. Zinc also crosses the Blood Brain Barrier and my Zinc product 100% stops all sexual replication of all Nitrogen Breathing Pathogens; and can therefore be used by the Military to stop a plague in its tracks.

3. Calcium made correctly also crosses the Blood Brain Barrier and will flush out the Acidic Neuro Toxins that actually cause the sickness and death giving you more time to save the person who is affected. These three products for example can each be pressed into very small pills that could be taken directly onto the battle field and they can also be sent everywhere in the world to stop all Viral infections (including Aids).

I enrolled in the United States University of Naturapahé in 1998 and by the year 2,000 became a doctor of Naturapahé early. The reason that I wanted this degree was not to make money or open a local business as I just wanted the credentials to do clinical testing with and for the Doctors Without Borders overseas. In 2000, I heard about a Doctor Gold who had fled from the FDA to Saint Petersburg Russia to practice medicine. Mr. Gold had been interviewed by a reporter named Kathy Keeton who wrote for the Penthouse magazine and in her story she told about how Mr. Gold had found a new cure for Cancer using a product called Hydrazine Sulfate (which is used in model rockets). Then Kathy got Cancer and was then cured by Dr. Gold and then Kathy died unexpectedly during a liposuction operation. So when I traveled to Russia the first time, I visited Saint Petersburg Russia to meet with Doctor Gold.

I spend some time in Russia and the Ukraine working directly for Doctors who worked for the Doctors Without Borders doing some clinical testing on T.B. cases using Silver in a Nebulizer (as Silver kills Viruses and stains) and some other medical conditions with Ozone Gas.

I had spent so much time in Russia between 2001 and 2002 that I applied and received an Annual Russian Visa (\$400.00).

My original interpreter during the beginning of my work in Russia was Urey and then I meet a man named Roman Ponomarenko while lecturing in Xharcove Ukraine. Roman is a very ambitious business man and computer programmer who speaks perfect English and who in fact graduated from the University of Kiev with a masters degree in English. Roman really loved the United States and has always had the dream of coming over here.

On or about October 22, 2002, I gave a lecture to 150 Russian speaking doctors at the Symposium Infectious Disease in Xharcove Ukraine. My Interpreter was Roman Ponomarenko. I spoke for over eight hours covering my new concepts for treating and mitigating infectious diseases.

As Roman spent so much time with me and learned so much about my new medical concepts we both decided that we wanted to build a WaterOz in Russia; and therefore and I went with Roman to the U.S. Embassy in Kiev and we secured him a U.S. Visa; so that he could travel and come visit my WaterOz operation in Idaho.

Part 3

. On or about November 3, 2002 Roman Ponomarenko and I arrived in Idaho and we got some samples of products together to be taken back to Russia to be tested in the official Russian testing laboratory. Roman then traveled with a Chris John Patriot (undercover confidential informant) over to the North West Laboratory to have a pre test done to make sure the product would be perfect that he was taking back to Russia.

Then a three days later we both flew to Minnesota and I gave a lecture to some of my WaterOz distributors. Then we flew to New York and again I gave a lecture to some of my WaterOz distributors. Then Roman flew back to the Ukraine and I flew back to Idaho.

On or about November 12, 2002, I got a call and an email from Roman saying that the sample WaterOz products had been sabotaged as there was no minerals in the water that was tested by the Russian testing laboratory and we both assumed at this time that the Northwest Laboratory had sabotaged all of our samples.

On or about November 21, 2002, my home was surrounded by forty federal agents with machine guns as they kicked down my front door.

At this time I was taken to Moscow Idaho where I was told I had structured transactions to avoid reporting; and that some of my labels were more than 10% inaccurate and then I was released on O.R. as they said I had no past criminal record. I later learned that my office manager Geri Gray who used to work for Ted Gunderson (retired FBI Bureau Chief) had withdrawn less than \$10,000 from my account for her cash box to help cash payroll checks while I was in Russia. This activity was not even a crime as this law even exempts payroll withdrawals in cash; and I was not even the person who withdrew these funds as I was overseas with Roman. As far as the labels not complying with the FDA we at this time I knew for a fact that the Northwest laboratory had falsified our tests for FDA compliance.

Then on or about January 3, 2002, Joe Swisher who owned the Northwest Laboratory called my secretary and she transferred the phone to me at my home and at this time Mr. Swisher told me that he wanted \$500,000 in cash and 50% of my WaterOz business and he would not testify against me about Sodium Cyanide being in my WaterOz products.

I cursed at him and hung up the phone. Then the next day Mr. Swisher mailed a 16 oz bottle with my WaterOz label on it that was filled with of Sodium Cyanide in the U.S. Mail to the Kellogg Testing Laboratory in Kellogg Idaho. This evidence was now physical proof of his blackmail attempt.

On or about April 3, 2003, I got a call from a Deputy Mueller (now fired for being a dirty cop) who said they had information about my home being robbed. I then drove to the Sheriff's office and at this time they arrested me again and I was not told why. Now I sat in the Boise Jail for two full years. During this period of time I was civilly sued about eight times as undercover agents tried to steal my business and cash flow. Most of these attacks were provably orchestrated by the late Ted Gunderson from Las Vegas.

On or about December of 2005, I was put on trial for the labels not being accurate and bogus structuring charges which did not even apply to me. Then right after this trial they served me with another indictment and in this indictment they accused me of hiring a J. S. to threaten federal officials. I later found out that J. S. was Joe Swisher. During this trial I was not allowed to tell the Jury about how Mr. Swisher had sued me while I sat in jail for two years; or had mailed Sodium Cyanide to Kellogg Idaho, or the whole black mail scheme; and I was also not allowed access to his medical records that would have proven that he was actually in a coma in the VA hospital when he said that I hired him to murder federal officials. The federal agents all knew that he was in a coma and they knew I was overseas.

So as you can plainly see I have done absolutely no crime and have now been put in prison only to be robbed by some out of control supposed federal agents and their paid lackeys.

For me to have been guilty of this crime I would have had to have forged the foreign stamps in my passport and sneaked back into the U.S. and then have gone into the VA Hospital and then sneak up to a man who was in a coma and ask him to kill. So the real theory of there case is that I hired a man in a coma who was later wheelchair bound on kidney dialysis and had blood pressure over 180 and couldn't even drive a car let alone be a hit man because? I never knew that this country kangaroos people just like I was told that Stalin did. Note that a retired Highway Patrolman named Kevin Hagen also came to court and testified that I hired him to be a hit man and then immediately went out in the parking lot of the Federal Building in Boise Idaho and put a 45 caliber gun in his mouth and pulled the trigger. What did these feds say or do to this man to get him to lie and then kill himself. Also they tried to get a friend of mine name Tim Scoffed to come and lie against me and he also was reported to have committed suicide on the rail road tracks West of 15 near Las Vegas. What kind of organized crime organization could put these kind of attacks together?

Now I have I have been in touch with Joe Swisher many times and he is very sorry for what he has said and done and he now has allowed my team to record him seven times. We have also arranged for Joe to work with the Appellate Attorney that originally won my case to create an affidavit of actual innocence for me. Hopefully this will be done in the next few weeks.

Now Joe spends his time calling and writing the department of Justice to trying to get me some relief from what has been done to me.

I have applied for a Pardon and Commutation and in two and half years I have not yet been rejected and maybe this is a good sign as many others have been.

I have written President Obama three times offering to give him my different energy devices and the WaterOz concepts to mitigate infectious diseases. I have also written Mrs. Clinton, Mr. Gore, the Department of Energy, Department of Defense, ninety nine Senators and three hundred Congressman with no response.

I have wanted to contact the Russian Embassy and try to get them to help me as they were actually my alibi as I was in their country when they said I did all of the crimes here. Roman also interpreted for me when I was meeting with the Surgeon General of his country and Russia.

I have kept in touch with Roman and he is now working in the Ukrainian Senate and wants me to come back to his country as he has promised me citizenship and has stated that he has talked to the different Senators and they have agreed that they are interested in my Green Conservancy becoming the power company for the whole country using my energy devices; as he really believes in me. So as you can see I really don't need much from anybody if I could just be allowed to leave and go somewhere where they don't railroad people to prison as political prisoners.

In the past I have never mentioned or talked about physics or energy devices while I was doing this clinic work overseas. I have only tested new concepts on cancer and all infectious diseases including Gangrene. Now I have securely mailed and drawings have been delivered to many locations overseas as I want my work to be given to mankind if something happens more to me.

Many times over the years I have been accused of working for the agency but I never have. In my mind I was working to help the republic by exposing corruption while trying to bring real medical concepts to the forefront to help mankind.

Now while in prison, I have spent my time writing Thesis Papers and drawing mechanical patent drawings for 14 years.

I have also now learned over 9,000 Russian and Spanish words and therefore will be able to speak these languages fluently in the future with just a little bit of practice.

I have other emails that I want to send you directly but I need an email address and a phone number that you will answer as I can not go to your web site to apply for your assistance in the normal manner. I need your help and I need you to make an exception and help me help you by helping me to begin this dialog. I have a whole business plan and concept to share with you and I know that you will be interested in what I have to offer as my inventions all have military and National Defense ramifications. I will continue to try to call your office so that we can talk.

Now that you have read a little bit about my past history, I would like to start out now explaining some problems that I know that I have with moving forward with manufacturing is new green energy device (the GALT Motor/Transformer).

PROBLEMS

In 1973 a man named Joseph Newman invented a new magnetic motor. I met Mr. Newman in 1980 and even test drove a vehicle that he had put his motor in. I can therefore state that I saw it work. I do at this time think and know that my magnetic motor is much better than his as my motor is more practice; but here is the problem. Mr. Newman has not been able to get a U.S. Patent for his device now for over 35 years. Mr. Newman has even sued the U.S. Patent Office (see Quigley v. Newman - Quigley was the Patent Commissioner) demanding that he receive a Patent on his motor. The U.S. Supreme Court then ruled that Patents are political and the U.S. Patent Office does not have to grant a Patent to anybody they decide they don't want to give one to.

The underlying reason I discovered that the U.S. Patent Office will not now issue Mr. Newman a Patent is that they refuse to grant a Patent for any device that is deemed to be a perpetual motion device. In fact every College and University in the world now teaches that there is no such thing as perpetual motion and that you can not violate the laws of Thermal Dynamics or even Over Unity concepts; so it seems to be a fact that there is a world wide effort to bar and/or stop any concept that is deemed to be perpetual motion. If you look at the U.S. Patent Law you will find that you can not file a Patent in another country without first offering it to the U.S. Military and that is why I'm trying to reach your office.

Now here's my problem; some of my green energy devices would be classified as perpetual as they violate the laws of Thermal Dynamics and the the rest of my inventions are more efficient than any other energy concept on the market. Therefore I really do not believe that the U.S. Patent Office would ever grant a patent for my best inventions.

In fact we could use one of my seven green energy devices to totally solve the Global Warming Problem, if you really believe there is a real problem. I personally do not believe that this Global Warming Concept is based on real science as this concept is filled with bad science; but I do believe that burning all of these

millions of barrels a day of oil will eventually become a problem, as we keep raising the amount of fuel that is being burned; and one problem that is never address is the fact that we are lowering the overall oxygen levels in our atmosphere. I also believe that the banking powers to be really use this overall green agenda to try to increase control and taxes over the the people.

Therefore, as we can now lower the overall cost of all energy across the board in every application these green energy inventions would have very important economic beneficial effects on each country that we decide to help.

So I called Roman Ponomarenko (Ukrainian Senator) up and sent him some emails and asked him if he thought that the Ukraine would be interested in buying their Electrical Energy from me. Roman then told me that; "when Putin annexed the Crimea the Ukraine lost her coal mines; so now we are purchasing our Electricity from the surrounding countries." I then asked him; "how much a month do you spend?"; and he stated; "that he thought it was about \$80,000,000,000 per month" (they pay Russia \$25,000,000,000 a month in the winter for their Natural Gas). So my counter offer was that I would provide the same amount of electrical energy for the whole country at a price that is 50% less (\$40,000,000,000) and that I would then share part of this money with his Ukrainian Federal Government as a tax (if they provide protection for our utility company). Roman thought this plan was a really great idea and the last thing he said to me is "Dave come back we need you"!

I talked to the Idaho Power Company in Grangeville Idaho and asked the CEO (named Fitzmaurice - who was just appointed to be the Country Judge by the Governor) if they would be willing to buy Electrical Energy from me for a 10% discount and his response was "Yes". I asked him how much they spend a month and he told me that it was about \$5,000,000.00 (small power company that buys power from the Bonneville Electric Company on the Columbia River).

In fact every body that I have talked to immediately is interested; so as you can see this would not be a difficult concept to go out and promote. We are not trying to sell GALT Transformers as what we are trying to do now is only sell Electrical Energy (not Transformers) to the Grid, for a slight discount while at the same time protecting the Grid from CME and/or an EMP attack; which both effect national security. I have named my transformer that has a spinning armature "GALT" (Geometrical Aliened Lateral Torroid). You will find that this is a very interesting acronym as Ann Rand wrote a book called "Atlas Shrugged" in the 30's, and the main hero who was a fictitious character in her book saved the world with his GALT Motor and his name was "John Galt." Therefore this acronym is a great name for this new invention and overall concept.

GALT: The GALT Motor is actually a Transformer and a Motor all in one. This is because the Rotor rotates creating torque in direct synchronization with the line phase; while at the same time producing the extra Electrical Energy directly from the permanent magnets.

An example of how many Kilowatts of Synchronized A.C. can be produced are as follows: A GALT 1 can be made with one Coil, two Coils, four Coils or even six Coils (as three phase). A GALT 1 (with four Coils) is physically about 9" X 9" square and about 13" tall and can produce about 88 total KW's (each of the four Coils produces 22 KW X four Coils = 88) and will earn \$3,100.00 per month at .05 per KWH. This is a lot of A.C. Wattage for its overall size. If you increase the size of the GALT by just 50% you now have a GALT 1.25 that is 10" square and about 14" tall and now could produce about 352 KW (each Coil now produces 88 KW) and now you would earn over \$12,000 per month at .05 per KWH feeding the American Grid. Then it really gets fun as a GALT 8 is physically about 44" square with six Coils and will now earn over \$1,000,000 a month at .05 per KWH. Note that nobody is now paying .05 per KW to buy Electrical Energy except up in Idaho where the rate is the lowest in the country; for example the Nevada Legislature just passed a new law mandating a .09 price per KW. Of course when money is earned using Solar or Wind to feed the Grid and/or a Utility companies they will pay a much lower amount because the energy is intermittent and shuts down when the sun sets or the wind stops blowing. Our GALT transformer produces it's energy 24/7 and this allows us to receive an even higher pay rate for our produced electrical energy.

Industries that use a lot of Electrical Energy can now be directly sold electricity at their location of use for a much lower price; while extra energy produced can be sold into the Grid system; and this would allow them to compete on the world markets as they now can manufacture their overall products at a much lower price. I have many ideas. But note that the GALT 1 would be a good size for a single home as it also provides enough electrical energy to now power a gravel pit or even a Tesla Car indefinitely without the need to ever plug it in again; and there will no longer be any need to even have a large battery capacity. These GALT transformers could now be installed very easily at a very low cost without any

modifications to the any vehicle that is already designed to run on electrical energy; for example Diesel Locomotives, the Queen Mary, Caterpillar Bulldozers. For the Military we could now create Drones that never need to land for fuel that can be armed with laser weapon systems; Tanks that can run indefinitely and never have to be plugged in. The possibilities are endless and would work in any application that is using an electric motor or any other kind of motor. The Military ramifications are thus endless. In fact the GALT transformer one hundred percent replaces the need for all Nuclear Energy, Piston Engines and even Jet's.

I studied Jet Engines in the U.S. Navy and I learned a lot about the Inductive Fan concept. The Inductive fan is a large fan that is now mounted directly on the front of the smaller jet engine and this fan really now does most of the thrust as the smaller Jet Engine is now used mainly for the purpose of just spinning this bigger fan. An Inductive Fan can move an aircraft forward much faster than the speed of sound (this is much better than prop systems). This means that a fighter jet could now reach much faster Mach speeds while not even consuming any fuel. Torpedoes could now be build that have endless range and can cruise at over 100 knots. Terminator Robots would never have to be plugged in. Even the Drone that you have already funded in the past might need to be upgraded to use this overall GALT concept.

I have also invented a new Electromagnetic Motor that I call a Pineapple Switched Reluctance Motor (PSRM). This Pineapple Motor is not a perpetual motion device as it now uses up to ten times less electrical energy than a standard SR Motor for its size (that is already on the market) except for the fact that my Pineapple SRM has multiple Rotors and can rotate up to speeds of 100,000 RPM's and we can then mount a GALT transformer at one of the ends of it's shaft to help to create even more torque; while getting the needed Electrical Energy; or just use a GALT Motor to electrically power it via a wire.

After we get a number of GALT's feeding the American Grid and we have a lot of cash flow the next step would be to start investing and buying machining equipment for the purpose of doing conversions. A conversion is the process where we take regular equipment that uses any kind of motor and we convert it to no longer using any fossil fuel. Of course my idea of green is when you do not even have to plug it in at all.

As we move forward feeding the Grid we do not have to upset anybody as we can let any and all current energy providers still make the same amount of money; this can be done as the only person who is going to get financially hurt will be the coal mines and oil companies; as we replace the need for all fossil fuels. Then as we negotiate future contracts we can use these huge generated cash flows to pay off the people who are economically getting hurt; but my overall goal is to move forward in such a way as to not upset any more people than possible. Our mission statement is to lower the overall cost of energy across the board to help raise the standard of living, while at the same time stopping Global Warming whether you believe it is real or not. In fact I want to own this phony movement in the future. I have now offered these concepts to Mr. Trump as he could have announced that he has made a deal to solve the Global Warming problem and then he would pick up enough extra votes to make sure he wins the election; but as of now he has written me back; but as of now he has not mentioned the GALT motor or Global Warming.

Part 5

. I wrote the following to just share some ideas with you about the Corporate Structure that I would like to put together with you help.

I have spent some time studying the different corporate concepts and have decided that we need to have more than one Corporation Structure.

COLLECTING ENERGY FUNDS USING AN LLC: We can use the LLC corporate structure to create LLC Energy Partnerships that can then be placed directly underneath of our Non Profit. For example we can have the owner of a property (that is being used to feed the Grid) become a member of one of these sub LLC's that was created underneath our Parent Green Conservancy Corporation, or the Green Conservancy could just be a member of this LLC. Then once a month the owner of this property would forward our share of the funds generated from co generation (selling energy to the Grid) to the parent corporate entity (Green Conservancy). By selling the energy and not selling the actual equipment we can

now create a cash flow that is on going. The overall construction/manufacturing cost to actually build a GALT 8 (that could earn over a million a month) is about \$2,300.00; as as you can see we would break even on our costs in just a few hours after throwing the on switch.

Of course we would let the U.S. Navy actually purchase the equipment for the purpose of maintaining the defense of this country.

OWNING AND HOLDING CHATTEL PROPERTY PERMANENTLY: We can have our Non Profit Corporation hold Title and permanently own Vehicles that are purchased as Prototypes. These Prototypes are can then held indefinitely as they are continually being used for tested, upgrading and modifying the conversion process; and they can be stored in our Green Conservancy Museum (Corporate Garage). We can also have the directors and other employees use them meanwhile for transportation.

BUYING AND SELLING CHATTEL PROPERTY: We can have our For Profit Corporation buy and sell any and all motorized vehicles that are purchased only for resale. These vehicles will all be converted to not need any fossil fuels and then resold; for example the Green Conservancy could purchase a Yacht for the purpose of converting it to not need fossil fuel.

OWNING AND HOLDING REAL PROPERTY LONG TERM: We can have our Non Profit Corporation hold title and permanently own all Real Property as these properties can be purchased and held solely for the purpose of Conservation. For example the Green Conservancy could purchase a Mansion in Florida that has a place to birth two large Yachts ships; and the property could then still be used to feed the Grid to save and conserve our environment under the concept of conservation even if we live on the property. Now a director could actually live in said Mansion or the Mansion can be rented out or used in any other corporate manner and this property would still remain untaxed by the local county taxing authority.

MANUFACTURING GALT'S AND/OR MALT'S: The Corporate entity that actually manufactures these Green Energy Devices could be a regular for profit corporation; as this entity can hire employees and run as a regular business; and any excess profit could still be donated to the Non Profit Conservation Corporation without taxation.

COLLECTING VEHICLES FOR THE PURPOSE OF CONVERSION: This type of corporate concept must be run as a non profit as people can now donate their vehicles and other motorized things and receive a tax benefit; and we can also issue tax deductible vouchers (see Heritage For the Blind); we could even issue Vouchers when they make their gifts; like a Voucher that would allow them to buy the first conversion done on a Corvette.

CONVERSION CENTERS: The Corporation that actually does these conversions can be a Non Profit Corporation or a For Profit Corporation; We probably need to eventually create two separate Corporations; but for right now to just get started we only need one For Profit Corporation to get started manufacturing these GALT Transformer/Motors. But once we start placing these units in LLC partnerships and these LLC's start earning a steady cash flow we will really need to have extra cash flow sent directly to a Non Profit Conservation Corporation (like the Nature Conservancy/Green Conservancy) as only the Non Profit Conservation Corporation taxing concept allows money to be donated or given from any source while any and all Donors gets a full 50% deduction (regular non profits only allow the donor to take a 30% deduction). This means that any extra profits that are ever earned within any of our For Profit Conservation Corporations and even profits that are just donated for conservation purposes (see Nature Conservancy.com) can be donated to the Non Profit Conservation Corporation and no taxes will be due on the transfer of these proceeds.

In summary it would seem to me that we really need to start out creating a For Profit Corporation (i.e. GALT Motor Company) for the sole purpose of manufacturing the GALT Transformer/Generator; and then we can create the Non Profit Conservation Corporation (i.e. Green Conservancy) next as needed.

It is very interesting to note that the best overall business plans are being done by the many different non profits that are already in existence; and if you want to know the overall best way of setting up one of these non profits all you have to do is study the others that are in existence.

Are you starting to see how important the creation of this GALT really is?

Part 6

. If anybody is wondering what got me started in thinking and making Transformers it all started back in 1992, when I was doing the David Hinkson talk show. I mentioned just one time my invention called the R.E.E.C. (Radiant Electrical Energy Conversion). This device is in fact a Nuclear Battery that I had figured out how to build and then I worked with the late Douglas Noland to build a test model as he had some Uranium.

For some reason talking about this Nuclear Battery seemed to generate a lot of interest on the show as all of the lines stayed lit up. One of the callers who called in stated that he wanted to meet me. He was very persistent and spent a lot of time calling my corporate offices and he would never give up; and he finally demanded that I meet with him as he stated that he had a gift for me. I finally gave in and drove from Las Vegas to Saint George Utah and had lunch with him. During this nice meeting it seemed to me that he was asking a lot of questions to see if I really understood certain concepts. Finally he said if you can tell me how my gift works I will give it to you as I just want someone to have it that understands it and how important it is mankind. He went on to state that he had worked on the Manhattan Project with Albert Einstein and they had later worked together on their own on a new magnetic energy device (in the early fifties); in New Mexico; and now as he is very old (in his 90's) he wanted to give it to someone who just understood it and would do something with it for mankind.

We walked out to his old car and he opened the trunk and there it was. It had many magnets stacked in the center area and four outer coils and center coils that were each placed between the four outer coils. I stared at it for a moment and stated; "It seems to me that this device uses a stack of permanent magnets in the center to provide permanent magnetic flux into the system; and this provided magnetic flux is then directed and redirected to change direction within the two center pickup output coils, by energizing the four outer coils as to change the direction of the magnetic flux path within the center output coils you can cause the magnetic flux to turn on and off within the two center output coils. This means that as the magnetism is now being turned on and off within the center output coils you would now create Induction (Henries) to create Electrical Energy." He was very impressed and he then gave me the device.

After studying this device for a while I realized that it would only produce large bolts of spiked D.C. Energy and therefore was not very practice in the real world. I even hooked it up and tested it and it did exactly what I thought it was going to do. So I lost interest in it for a couple of years. Then, I had the Idea of creating this same device with two sides working together as I figured that if we had two sides working together we could now get a real A.C. Sine Wave out of it.

MALT: I decided to name this new device MALT (Motionless Alternator) as it had no moving parts. The MALT we built now had five coils mounted on it; four smaller coils that are used to control or wag the permanent magnet; and one large output coil that creates the extra wattage from the Henries. This MALT Transform has no moving parts. I really like this design and concept and it would also be really great if we could manufacture Micro MALT's; for example they could be put into a pacemaker or even a battery so that the battery stays charged forever. As there are no moving parts this would be a great way to have forever energy in areas where no maintenance could ever be provided (like in outer space with satellites). The only problem that I found with this overall concept is that magnetic steel can only hold 20,000 Gaussens before it saturates and it takes 50% of this magnetic flux in the steel to just control the magnetic field from the permanent magnet. This means that only 10,000 Gaussens can now be used to wag the magnets to create the Henries and 10,000 Gaussens can be used to create the extra wattage; but this is still more effective than most other transformers that are now on the market; as they only run at about 3,500 Henries (or use about 30%). The reason that no body uses more than 30% of the potential magnetic flux in any transformer is that there is a heat build up problem. We had a full prototype built and it melted in the fire when the WaterOz factory burned down.

The MALT is very similar to the MEG that was Patented by Tom Bearden. The MALT now can be seen working as Bob Sandberg now has a Y tube video showing a type of MALT lighting up a light bulb. He can email it to you if you have not already seen it.

GALT: The GALT has a rotating Armature in the center and this Armature only has to rotate at 600 RPM to create 60 HZ. With quality bearings on each end of the Armature this transformer/motor can go for

decades with little or no maintenance (on the bearings) as there is not a lot of stress placed on these bearings (a heat sensor can be placed to register any potential heat build up on the bearings). One advantage that the GALT has over the MALT is that this design uses the magnetic flux from the permanent magnets to actually drive the magnetic steel up to 100% magnetic saturation; and this allows us to now make and use up to 40,000 Micro Henries to create Alternating Current (20,000 Gausses each direction = 40,000 Micro Henries). Also the geometrical design of the GALT now allows us to use, direct and amplify two square inches of magnetic material material at 13,200 Gausses into an area that is only one inch square; and this is the concept that allows us to bring the GALT Torroid to magnetic saturation. These two concepts mean that there are no other motor or transformer concepts in the world that can make as much mechanical energy or electrical energy (A.C.) for its overall foot print or size as this one. If the GALT Armature is rotated at faster speeds the wattage will be increase in direct proportion to the increased RPM's or speed.

Most transformers on the market can only run at about 3,500 Micro Henries; as using too many Micro Henries on a smaller steel core can cause a major heat build up problem; and this means that we are now able to drive our GALT (and even the MALT) to levels that will cause an extreme heat build up problem and the question now is how to solve this problem?

HEAT BUILD UP PROBLEM: When Henry Ford first started manufacturing the Model T the other car manufacturers were actually using a Tesla Coil (that was wrapped on a solid steel core) to spark their spark plugs and these coils then had to be cooled by pumping cooling oil through them and then through a small cooling radiator. This heat built up problem was caused by the Eddie Currents that are created in all Electric Coils applications. Some of the manufactures at the time then started to using laminated steel cores in their Tesla Coils.

But Henry Ford had a better idea, as he then put together a bundle of Bailing Wire as the Steel center Core in the center of his Tesla Coil; and then he wrapped Copper Wire around this Bailing Wire Bundle. He also discovered that if he used even a smaller gauge of Bailing Wire it would run even cooler. Therefore, you can cut the Bailing Wire into desired lengths and then dip them in shellac and then when they are dry you can put them together to make a bundle. Using this concept it is now possible to run our GALT (and/or even the MALT) up to maximum magnetic saturation and Henries and have almost no heat build up. This is why I redesigned all of my concepts to use these bundles of Bailing Wire only where the coils are mounted.

Part 8

. As I'm in prison I have had to give my POA to some that I trust to represent me in this future project. It would now be very nice if I could give a POA with limited power to totally control this new entity that we are about to create; and this new POA could then take care of all of my business pertaining to the For Profit GALT Motor corporation and/or the Green Conservancy.

As I was attacked for no good reason by federal agents in Idaho, I'm not sure if I really would ever feel safe going back there to live; but maybe with your protection I might be safe there. I just want you to know that we still have some infrastructure that is usable if we decide to get started up there; if not it might be good if a Trustee could now help our new group pick a new location for us to move forward in. In other words I would appreciate the appointed Trustee helping us to decide where we are going to start manufacturing in the beginning.

If we are going to start out creating the GALT Transformer/Motor Company or the Green Conservancy first (without making the minerals like the Copper) we really do not need a very large loan to get started as we really would only have to manufacture the first large GALT unit or maybe four or five medium size GALT's to then be able to fund rapid expansion. In other words the GALT Transformer will create so much cash flow so fast that it would really be self funding after the first unit is placed and we start co generating A.C. wattage even in Idaho on our property.

Here is a realistic break down of how much money I believe would be needed to the Green Conservancy started.

1. \$5,000.00 - Attorney and Accounting Fee's - money used to create the initial Non Profit and handle other minor problems (for the first few months) associated with a start up like applying for a business license and Tax Deductable Status.
2. \$25,000.00 - Garage and office rent (for a full six month period of time).
3. \$25,000.00 - Labor - we need just one full time machinist who can run the machining equipment and assemble the first GALT Transformers (for a full six month period of time).
4. \$500.00 - Drill Press - new or used (used to drill the holes in the Aluminum that hold the bearings).
5. \$500.00 - Band Saw or CNC Machine (used for cutting the Aluminum sheets that hold the bearings).
6. \$10,000 - Computer controlled laser cutter - or water cutter - can be new or used - this equipment could be leased or purchased.
7. \$5,000 - Shop Utilities (for a six month period of time).
8. \$10,000 - Misc labor including a secretary and office equipment if it is needed.

As you can see we really don't need a lot of funds to get things moving; and it would be possible to get everything ready to start production within 30 days for less than \$250,000 with a good a buffer; and the entire \$250,000 could be spent over a six month period of time until we get the first GALT Transformers plugged in and generating cash flow and then we could either pay the whole loan back right away or start making monthly payments.

Then this GALT 8 will generate over one million per month within the first 30 days to facilitate ongoing self funding.
