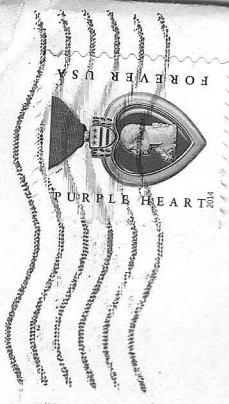

Brother, I have a letter PM'd 21 FEB and as recieved, a blessing, on 27 FEB. You need not be concerned that there is little excitement on any given day. Your sharing a blessing as received and enjoyed here! Husbandry truly a gift from GOD. I had the blessed privilege of growing up ranching and farming in NE Iowa. We were generally blessed in that we had soils and the moisture that the crops needed to produce well.

I found today's, 28 Feb. "Sunbeams" in the devotional to be a good message relating well. I pray it blesses you as it does me.

I am privileged to share with you the letter: "The Just Shall Live by Faith" of October 2012, #123. "Faith" (pen name) was a wonderful help as she prepared and distributed her message each month for years. I was certainly blessed. Time and age precluded here continuing today but the record is clear for this wonderful servant of the Lord. I pray that you and our friends enjoy her "on-point" faith message in that issue.

You are speaking to a true believer. All the while that I grew up our chickens were free range. We, for years, raised about 100 roosters, and they had the run of the place, that is until they went in the freezer or immediately in the frying pan. Our hens that laid where they saw fit, were always around, as well. In those days eggs did not come from huge confinement laying houses. We gathered the eggs and about once per week took the case however full to sell the eggs at the produce company. They candled them and they went to the grocers and to peoples' tables.

As we lived out of the garden and on the animals that we raised we also had to take precautions for keeping the chickens, our animals and the wild critters out of our garden. We surrounded the sweet corn in a fence about 6" off the ground hooked to the electric fencer to keep the raccoons from destroying the sweet prize they coveted almost as much as we did. [Smile!!].

Between my father and my uncles, my grandfather, we had upwards of 300 to 400 head of stock cows and the resultant calves for years. We did not have time nor energy for cooping up chickens or such and then having to keep their confinement clean while making those poor creatures unhappy. I'm sure you understand. We had to keep up with our row crops on 1200 to 1500 acres and bale 25,000 bales of hay each season. None-the-less, had it been entirely my choice that is what I would had preferred to do all of my life.

I love to read of the particulars that you have been learning as a result of caring for the goats, chickens and managing your place. It is truly a blessing having the Lord show how wonderful is creation truly is.

Your story of the "Fox" is a reminder; When I was about 12, my dad was called by my uncle, my mother's sister's husband as the Fox was enjoy-in far too many of the many chickens they were ranging on hay ground. We had lots of experience with hunting and trapping Fox, so we had to put

our skills to work to salvage uncle Carl's chicken operation. We were successful. [SMILE!!].

When I was small we had domesticated geese and ducks. The geese were "Watch geese". That was a problem for me when I was 3 to 4 years of age. If I left the protection of the yard fence, I had to be fast going to where my father would let me in a building, or I would be goose attacked. I did not really like the geese, but one thing etched in my memory was when my mother was dressing two geese for the table. She was working on the outdoor portch and on the old table that sat out there the dead geese were lying there with their heads drooping off the table. I will never forget that scene. The ducks were not so dangerous or making such an impression.

One day at a time, the LORD ever present, ever guiding our every step through it all. How thankful we should always be.

Several years ago I learned of people surveying youngsters in the early years of school. I found it sad. Many had no idea where Kentucky Fried Chicken came from nor that it was even the product of a bird. The few who had any idea that milk came from [generally] cows was about the same. Room for improvement!

I'm sure that our friends in the Lone-Star State are going to enjoy "Faith's" musings in #123. They have been known to enjoy some of those things that are of a historic perspective. Would you agree?

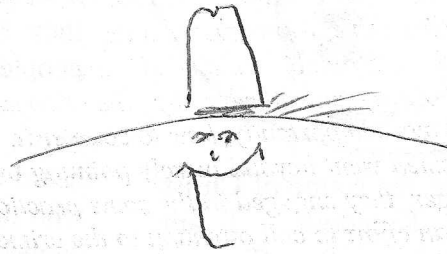

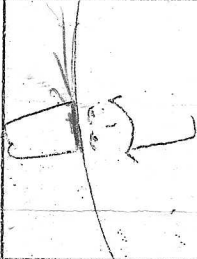

UNLAWFUL PRISONS and ILLEGAL IMPRISONMENT

I am not a person qualified to write about imprisonment, but I will use the words of others. We face the problem – howbeit from a distance – every month when we hear from prisoners by mail and are exposed to just some of the difficulties and injustice they face, most of which are far greater than most ordinary people in this nation can imagine.

Last year, Pat Shannon from The American Free Press wrote an article about the Montana Freeman. You've probably heard about them, even if you may not be familiar with exactly who they are and why they're famous. Or, maybe it's infamous, depending on whom you are. We're going to include Pat's article herein, and then include excerpts from a letter to us from one of those Freeman who has been in a prison cell for over 12 years and has no idea when he'll ever be released. He is a Christian and a Patriot, and one of those who has *overcome him by the blood of the Lamb, and by the word of their testimony; and they loved not their lives unto the death.*

The Untold Story of the Montana Freeman

With the passing of Leroy Schweitzer last month (September 2011) in Colorado's super-max federal prison in Florence, questions loom as his family awaits the results of a private autopsy.

Over halfway through a 22-year sentence, Schweitzer had been a model prisoner and had never harmed anyone to be put there in the first place.

Why was he still under lockdown 24 hours a day, seven days a week, next to such notorious killers as mob hit men and alleged "Unabomber" Ted Kaczynski?

Memories are stirred when looking back on these events.

The few of us privy to the Freeman's side of the story, compared to the millions deluded by media propaganda, knew that Attorney General Janet Reno had unfairly targeted these people. More importantly, we knew why.

Nothing like the disparaging media portrayal of "armed and dangerous," the Montana Freeman were businessmen and ranchers, some even millionaires and one the mayor of Cascade.

They embodied true Americanism by demanding government adherence to constitutional law and had little patience with the large majority of Americans that willingly endure the inconveniences of government interference in their lives.

The ensuing 81-day siege at the 960-acre Clark Ranch in central Montana was provoked by an unwarranted sneak attack by the FBI and not a frontal assault by these law-abiding citizens who had never swung a punch or been accused of shooting anyone.

Following years of in-depth legal research, Schweitzer and Dan Petersen, both referred to as "leaders" (mistakenly, because the Freeman were never an organized group), began to educate others locally. Soon, however, many students came, from several states.

Their legal instruction included the fraud committed against American citizens by the Federal Reserve System, and more importantly, how to counter it.

But the Freeman went beyond merely pointing out this evil. In their anger, they engaged in the same practice of creating funds in an effort to call attention to the crimes of the Fed and, perhaps, bring it down.

They did this by suing federal judges and others while securing what they believed to be "perfected liens" that they converted into certified bank drafts, which were then used to pay off government debt, mainly farm foreclosures and IRS liens.

Feeling the heat, the FBI attacked on March 25, 1996. Agents and their paid informant lured Schweitzer and Petersen into a phony copy machine purchase, then stun gunned and beat them into submission. Twenty-two other men and women went into seclusion at the Clark Ranch outside of Jordan in central Montana.

It was then the media propaganda blitz began, driving the Freeman to fear being jailed or killed. On June 13, 1996 they finally agreed to walk out of the ranch into awaiting handcuffs, lengthy court hearings and jail. Only Petersen and Russ Landers remain incarcerated to this day.

In 1996, during this writer's first visit to Jordan, Mont., the Freeman showed the evidence of 38 instances where Schweitzer had signed drafts, drawn from funds created from unchallenged summary judgments, and not only paid off liens but received in many cases five-figure government refunds for overpayment.

The bank drafts were obviously "money," at least as legitimate as the thin air creations by the Fed.

That's why the federal government considered these men dangerous—not because they might have owned guns and not because they were a physical threat to anyone. It was the Freeman's knowledge—and their passing it on to others—that created the Fed's fear of exposure of its fraudulent system.

Considering the current outrage at the inflation caused by the Fed's creation of trillions of dollars of credit money for the ultra-wealthy, it is fair to assume that the Freeman may have arrived on the scene just a little too early.

Our friend, Russell Dean Landers, mentioned above, is one of those Freeman still in prison. We have many other friends, as well, not Freeman, who are in the pathological prison system wasting away their health and their lives while their children and grandchildren grow up without them for no good cause — except to enrich others in power. Prisons are for profit, and all the more so now that they are being privatized. The following words were written by Russ in a recent letter to us:

"If the people were privy to the whole truth, they would find out that every time a man or woman is convicted, sentenced and sent to prison in America, the internationalists (banksters) are enriched by the "penal sum/'dollar' obligation" on the prison Bond. This has been expanded to \$Trillions in Amerika. That is why the crime rate has been declining and still the incarceration rate has been sky-rocketing. Tens of thousands of people who never should have been imprisoned have become the victims of this evil.

"In 1940 there were less than 4,000 federal prisoners. Today they admit to 217,000 (the LIE), and hundreds of thousands of people have been brutalized by this evil in the last 40 years.

"Some states, such as California, Texas, and North Carolina have become "prison-business states." This is ALL coming out in the open. It makes Stalin's gulag system and Hitler's Concentration Kamp system look like a kindergarten picnic by comparison — GROSS EVIL! This is one of the reasons why Amerika is under the judgment of Yahweh. There is no other way to correct such evil!

"I do not have to say a single thing; it will soon all be exposed how the "golden calf/fiat (fed/slave) usury beast system" has exploited the people with mega-\$trillions

of "charges." From parking tickets to life sentences, it's all about penal bonds. All so-called crimes (labeled "criminal" which are not a crime) are treated systemically as a source of \$revenue\$, credit for the "system."

"Every so-called judgment of conviction/obligation is treated as collateral which qualifies the State Treasurer, or United States Treasurer, to sell a "Bond," i.e., Treasury bond, which is borrowing power.

"The STATE Treasuries' can fractionalize the face value of the judgment FOUR times. They sell those through the US District Court where they sit for that \$credit.

"The FEDERAL courts can fractionalize, or I should say, the U.S. Treasurer can, for TEN times the face value of the so-called "criminal" (not a synonym of crime) judgment. In 1991 a federal court criminal judgment was worth approximately \$7 million per charge, per year of sentence. Put another way, a 10 year sentence, one charge, was worth \$70 million fractionalized value to the U.S. Treasury.

"Reagan set all of this in motion with the "Crime Bills" of 1983-84, and Nancy's "Just Say NO," "DARE", and the War on Drugs. That is why he looked so fiscally responsible and successful (cooked books). He and his administration set up the scheme to lock up millions of Americans to fund their "Communist/Fascist" agenda. These are ALL proven and provable FACTS, not a mere theory in the whole mix. It is even now ALL coming out. The whole fraudulent communist system has been sucking off the lives of the falsely imprisoned. MOST of the so-called "criminal" statutes used to imprison people have no basis in "CRIME" at all, and in fact are not valid for prosecuting the people. All fraud. All gross, insidious exploitation of largely innocent people. It is ALL one huge LIE! Reagan did this in California first, which escorted him to the Whitehouse to do it to the whole country. Do NOT forget he was a card-carrying COMMUNIST IN THE 1950'S. Does a leopard change his spots?

"The American people, like the German people of the 1930's, allowed this whole thing, while denying the God of Abraham and waving the flag for prosperity without devotion to righteousness.

"This EVIL goes on all around us, as Fidelity, A.G. Edwards and such notorious "golden-calf" traders sell bonds daily that are collateralized by everything from parking tickets to the array of criminal (more often than not, not about "crime") shakedowns by the bankster cultured communist shysters on the Potomac, and scattered four ways to the wind from there. They are trading in "living souls" right here, on every corner in Amerika.

"I and about 18-20 others out of the alleged 217,000 federal prisoners are secreted away here in Terre Haute, alleged Counter-Terrorism Unit, aka Communications MNGT Unit (CMA) as we are

legitimately "discharged" (due our liberty) and are being unlawfully held, to avert EXPOSING the fraudulent system. All for naught, as the "Pandora's Box" is already open and we need say nothing - it is ALL spilling out, regardless of us and our knowing. The bridge over the LIES has been discovered and has no place to hide. It is REVEALED for what it really is. *May God bless those who sound the trumpets!*"

God always knew, don't you know, that this is what happens when men have the power to incarcerate other men. Men are not righteous or just, as is He. This was never his way of correction. God's Law requires restitution when someone has been wronged. In the case of murder, rape or kidnapping where there can be no restitution, He requires the life of the offender so that He himself can judge him in the Divine Court. God's way is to correct and restore. Man's way is to punish.

But we have gone way beyond the problem of unlawful punishment. Our justice system profits so hugely from this system, as Russ says, that it is in the business of sentencing and incarcerating men in prison who have *never committed a crime against another person*. The following is the first part of another article regarding imprisonment published in the Free Press, August 24, 2012. It is a terrible story that I hesitate to pass on, but it is, nevertheless, a kind of revelation that may help some of our sleeping people to awaken.

Training Ground for Eric Holder's Fast and Furious Cover-up

If an award was given out for the individual who worked the hardest to kill himself, that award would have to be given to Kenneth Michael Trentadue. In his cell at the Oklahoma City Federal Transfer Center on August 21, 1995, he patiently tore his sheet into dozens of strips, tied them together into a noose, attached it to a vent grate, and

made his bed like a good little boy. He then proceeded to hang himself.

Unfortunately, his handy work wasn't up to par, and the noose broke, whereby he first hit the sink, "ricocheted" to the metal desk, hitting his head, bouncing again, hitting his head on the wall, and scraping skin off his back. Being half-conscious, he got up and fell again, hitting his head on a metal stool. Being determined to kill himself, he then cut his throat ear to ear with a plastic knife or tube of toothpaste, but this didn't do the job, and so tried to hang himself again, this time being successful. Not to be outdone by anyone else, all of this was not only accomplished, but accomplished in record time. Everything occurred within sixteen minutes, including tearing the sheet into strips and forming the noose.

At least that's what the U.S. Government said happened to him.

Well they didn't tell his family all these strange circumstances that led to his death until, well, three years later... Marie Carter, the acting warden of Oklahoma City Federal Transfer Center, phoned Trentadue's mother at 3 a.m. to inform her that her son had just hung himself with a bed sheet. And, like all good acting wardens, she offered to immediately cremate her son free of charge. Mom said "thanks but no thanks" and informed the Good Samaritan Marie that one of her other sons was a lawyer and they'd get back to her.

When the family got Trentadue home, they would find his body beaten and gashed from head to foot – literally – as there were even bruises on his feet. Along with his throat being cut ear to ear, there were three wounds to the head, all fracturing his skull. There was also a strange impression on his throat, which, for anyone who has handled what are called cable ties (and as law enforcement uses them for handcuffs – Flexcuffs), knows, the impression on Trentadue's throat was made from the ridges on a cable tie being pressed and tightened around his neck.

It was obvious to the family, including Jessie Trentadue – the lawyer in the family – that his brother was beaten and murdered. But what wasn't obvious was why the Government was trying to cover it up.

What they would come to find out after a sinuous journey of lies, deceptions, stonewalling, and cover-ups from the Bureau of Prisons, FBI, and eventually Eric Holder, was the following: Kenneth Michael Trentadue, in the aftermath of the bombing of the Arthur P. Murrah Federal Building on April 19, 1995, was murdered because the FBI thought he was the elusive John Doe #2 and wouldn't admit to it (at least until they said John Doe #2 didn't actually exist, contrary to dozens of witnesses). What the Trentadue family has sought since they saw Kenny's mangled body is justice. Where does one find justice? At the Department of Justice, of course.

Unfortunately for the family, at the time, Eric Holder was the Deputy Attorney General under Janet Reno, and later Acting Attorney General.

And we all know how Eric Holder is about administering justice.
