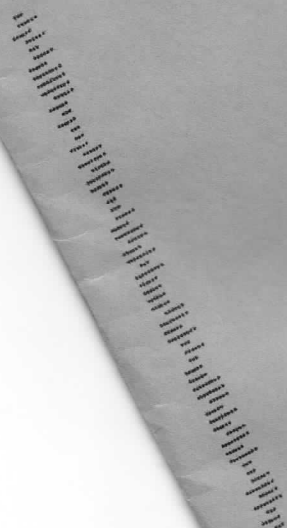

Greetings Brother Rudy & Erin,

My previous ltr today, was terribly rushed - as most of my ltrs are in the midst of well over 1000 hours of urgency & emergency obligations every day which only grow daily. But I can slow down a little here to address or clarify a few matters now that today's mail has gone & I can almost relax a bit as this will go out tomorrow.

1) I note your business size card of P.P.s has Grace Kahl & Scott Ford. They have been in my prayers since their & Gordon's ordeal occurred when mine did ussy back in 1983. For some years I was in close contact w/ Yorie's Mom, but not since decades ago. I recognize only 1 or 2 or 3 other names on your card. The card is a great idea. For 9-12 months it's been on my top priority list to get a new business card designed & printed re my kidnapped status & outreach, at VISTA-PRINT.COM. But alas, this project along with many hundreds of others that are top priority has slipped more away from me as each day passes. Whether I'll ever get to this, is unknown. I need at least 80 more of me, just to break even each day & keep the

overload & backlogs from increasing.

② I know nothing about you. Would you tell me more please, about you & your history, what you have achieved, your aims w/ your P.P. project, etc.

③ If I were to guess who sent you an email about me I'd guess my Christian friend KEN MASAT. Can you confirm?

④ Supporter: I began with several hundred in 1983 - people who actually knew me. More than 70 of them use my visitors lists twice - now I get 1 or 2 visits a year if I'm lucky. So, 35 years of the abuses of prison have torn apart my support system, not to mention many deaths of family & friends, & internal sabotage from a couple of evil betrayers/destroyers just 4 years ago. So, I do have some degree of a support system, but it is, at best, in tatters and, instead of serving my cause for freedom, expression & exoneration & my various needs, it tends to suck out of me the one thing I need most & can't ever buy or replace or get back - which is TIME. That is for the most part; I will say also that we now often make a dent in the goals of progress - but very few & far between, & mostly ineffective.

⑤ Anyone can learn about my story by going to my main website at www.free-lazar.org

Calif prisoners DO NOT have access to the internet or direct Email. But we are allowed, by law, to have someone outside facilitate one for us. Mine is operated by a friend, Sam MURAM,

So anything I input to it or anything I wish to know about or "see" that's on it, Sam must ~~then~~ upload or download & send to me. I am personally COMPUTER-ILLITERATE & WEBSITE/INTERNET IGNORANT for the most part - those didn't exist when I last had freedom in 1982-83.

⑥ I also have Facebook (1300 FB "friends") but \pm none ever write, tho they promise to & waste a lot of my time thereby. This is operated by yet another elderly friend, a fellow Christian, SON SENA.

⑦ Both Sam & Sen have established their own or my own EMAIL addresses for me, but, because they must undergo re-printing every ^{week} email & send it to me by US snail mail, & they must re-write (word process) my email I wish to send out & then send it, we discourage email use - & try to reverse it \pm only for entities that absolutely ~~that~~ aren't willing or geared to use snail mail, such as the news media, or business organizations or legal/government agencies, etc.

⑧ TELL ME: In what way, in what form, do you "PUBLISH MY VOICE ONLINE TO TELL MY STORY"? - By "voice" do you mean it literally, my recorded ~~voice~~ speaking by phone, or do you mean figuratively, just to "be heard" by printing what I say online? If the former, that would be an amazing 1st! Something I've tried to do for 35 years - long before the internet existed, via reporters, etc. Years ago, my dear, late friend JACK McLANE (most highly decorated policeman in AZ history) scheduled me OVER,

to be interviewed on his radio show, but at the last minute, CSE cancelled it - totally illegally, but we never got it re-set up nor was CSE ever (yet) held accountable - that broadcast may have resulted in my exoneration & freedom. If you do or can do something like this, whether radio or online feed, that would be FANTASTIC. I'm fairly articulate (tho 35 years of incarceration - torture probably has caused a few flaws in my skills as a speaker under interview).

(9) HAVE CALLS TO YOU: Calif has its own oppressive system different than many other states & feeds: (a) No ^{CALLINKS} ~~CALLINKS~~, (b) No debit phone cards, (c) I may get one 30 second call to you from the infamous criminal phone ^{SCAN} ~~SCAN~~ Company GTL (=GLOBAL TEL LINK), just to tell you you must open an account w/ GTL for me, or we may not even get that. If that, thereafter, you must open a phone account w/ GTL & put \$ on it that is drawn from as I call you. I think its \$20 minimum. Calls have an occasional INTERRUPT-KRASSMENT recording that cuts into our call to tell you again the call ~~may~~ may be recorded; & also at 15 minutes all calls are auto-terminated (w/ a 60 second & 30 second interrupt warning). (10) POLITICAL PRISONER:

2) This is one of the worst, most outrageous 2d AMENDMENT ^{P.P.} cases in US history & should be recognized as such

by NRA & all gun rights organizations & individuals

(b) This is probably the ABSOLUTE worst 1st AMENDMENT P.P. cases in US history - I fully served a wrongful murder sentence on May 1, 1992 & have been held in prison illegally since then for 25 extra years (3x the murder sentence again) Solely for speaking out against CSC & SA/police corruption in my case (so others) & for filing lawsuits, petitions & publishing the proof of the SA/Coroner/police/judge/defense attorney corruption & ~~corruption~~ corruption on my website. They've (1) taken my life, (2) destroyed my life; & (3) tortured me relentlessly in many ways, including physically; (4) had set me up to be murdered 13 documented times - & other times as well, (5) Kidnapped me all these years -- all for my standing up & standing out to expose their crimes.

(c) No other case in Calif history (I've researched 1000s & 1000s) & probably no other case in Calif history is so corrupt with "BRASSY errors" (= planted evidence, destroyed exonerating evidence, altered evidence (to convert exonerating into inculpatory), forged writings, manufactured evidence, suborned perjury etc - All 100% PROVEN NOW (See "35/52" document on my main website - but virtually no one ever goes there to see it - how can we get traffic there or otherwise get exposure to this?).

(d) No other parole case in Calif history has ever come close to what has been the norm in my case for 25 years since my parole was MANDATED BY LAW, SENTENCE Completed on May 1, 1992:

1st degree murderers with lifelong egregious crime histories are being released on parole in record numbers by the Calif parole board (=CPA) & this, for \pm 7-10 years now, who have served as much as 10 years less than me, while I was acquitted of 1st degree murder & (wrongfully) convicted of 2d degree which carries 10 years LESS prison time than 1st degree - & I have NO crime history, not even a ~~500~~ J-WARRING ticket, in my life. FIGURE THAT! How can that be? Its political prisoner kidnapping. Each time my next parole hearing gets close again, right before it, criminal person guards write false reports, petty reports like "outside on the yard when it wasnt my turn to be" - or "raised [my] voice in talking to the law librarian" - etc - which are ~~100%~~ 100% false, & these have been used for 25 years to deny me parole saying those prone "Am a danger to society." (Even tho the statutes Am sentenced under say it doesnt matter if Am a danger to society - I still must be released on May 1, 1992. (But I've always been a mayor, outstanding leader/benefactor to society, since a young lord told them they locked me away, with no exception).

⑪ INNOCENCE:

I shot a crazed violent maniac in self-defense as he kicked down my locked bedroom door on my home, to kill me w/ a meatcleaver. That's not a crime. I stopped shooting when the danger from him ceased. Then I called police & ambulance to come & help. He was alive when they arrived on his feet. They (police) assumedly killed him or helped kill him. I'm just as innocent as if I'd have had no involvement & was 1000 miles away.

THERE IS NO CARRIABLE CASE IN US HISTORY.

⑫ WHAT DO I NEED:

#1 TIME. If I could somehow buy 10,000 more hours each day - I'd spend my last dime & I'd spend millions of dollars a day to have days that were 10,024 hours longer - or 2x that or 3x that... I could easily use one of these hours. I still couldn't catch up. In 35 years backlogged on urgent & even emergency projects & issues that I began to tackle 35 years ago when the nightmare began & every day since then I've tried as EACH DAY brings between 20 & 100+ new obligations or tasks to tackle to hope to get my freedom & health & survive. I could write 20+ songs a day if I had the hours - the inspiration & music in my head & lyrics are there - but lost forever because there's no
OVER

time to write them; I could invent several new things EVERY
DAY, as the ideas are there - but not even enough time to note
them all on paper. Just keeping the record of ~~what~~ each
days most extreme events that need a detailed record for
court actions or other important reasons - now take more than
24 hours, so they don't get written - verified. I could list 100,
of other things like legal cases & books backlogged, unread for
20+ years - no time. I get 1-2 & occasionally 3 hours of
sleep a night - for decades now. No doubt a death schedule -
but trying to catch up or stay even. I'm astounded to hear
prisoners say "I've got nothing but spare time on my hands," &
beholden that the public thinks that image is accurate & never
THOUGHTS of the reality that EVERYTHING in prison takes from 10 or 30x
to 10,000 x longer to achieve than all of you out there -
whether its getting a shower, eating a meal, making a phone
call; things as mundane as taking weeks to hunt up a few
inches of scotch tape that's absolutely necessary or 3 weeks or
3 months to hunt up a paper clip to spend 10 hours carving
a sewing needle out of it to mend my fallen sport shoes
or pants or holy socks. - & then the guards find & steal
them. Start all over again. Big truck; takes me 1-3
years to find legal documents you out there can pull up easily
online in 5 minutes or less - I could list 1000s of things like
this. So I need PEOPLES TIME; I need COMMITTED people

who will not suck 20-50 hours out of me, to orient them to what I need only to suddenly abandon & be gone forever. I need a team of committed people who will devote even a mere 1-3 hours PER MONTH to writing legislators, the governor, CSC, BAH etc in a tree of people - a phone tree to call & email too. People to help bring traffic to my FB & websites. People who will wordprocess documents, who will make a few phone calls, FAX or send a few emails NEARLY. People who will contact the media REGULARLY (AR 02, Antenna, 20/20, 60 Minutes, Frontline, PBS, 48 Hours, etc) & radio shows, who are willing to learn that PERSISTENCE & PERSEVERANCE are the keys to this campaign, every week & month, at least a meeting or 2, & without that IT WILL FAIL - due to the competition. People who would be thrilled to contact some famous music & acting ~~celebrities~~ celebrities for my cause (some of whom I used to know, like Bruce Springsteen, Ted Nugent (the best a real A--), etc. This list could go on for 200 more pages. Someone to help LEAD THIS TEAM, while I direct them. Someone who would WORD PROCESS ^{PERTINENT PARTS OF} this letter into a document explaining what people can do to help - so I don't need to write this all out again & again (20x, 50x etc to the next person who asks). Someone w/ just a little internet/research SMART who would succeed at online finding of those 1000s of lonely, purpose-deprived senior retirees & widows & widowers who would LOVE & COME ALIVE AGAIN from having

a renewed purpose again in life of helping to free this innocent
political prisoner to free me up to help 10s of 1000s of other people
w/ my innovations, inventions, leaderships, programs, business plans,
employing 10s of 1000s etc etc etc. You see, this list
could go on hundreds of pages. I could do all this when
free when there was no internet or smart phones. Surely a team can
do this now. So that is #1 = I need people THE to
erect this TEAM to do these things.

#2) I need copies of documents made from time to
time. ~~Also~~

#3) Someone who will either research & or just
download & send me legal cases & other info that's
available online. (The law libraries in Calif have been
reduced to a criminal hoax & fraud - they are close to
non-existent here & 98% non-functional even when rarely
opened).

#4) (THIS SHOWS BE #1): Someone who will organize &
CAREY THEE a protest rally, perhaps at my trial courthouse
or the Calif state capitol, exposing the frauds & the BPH
criminal kidnap scam w/ guards who feloniously write the
false petty reports to keep me in prison PERPETUALLY & PERMANENTLY.
It is a more serious crime than murder, as it CONTAINS both
murder & torture - my now reduced lifespan cannot be reversed.
That is murder by BPH agents & CAL guards. Had this been

carried out in 1989 as I had tried (I never really tried to get someones to do it) I'd have been freed w/in 6 months - if not 60 days. This kind of protest might be small because it requires people physically attending, but it could redistructurally be as big as 100 or 150 people on site, & then expand it online to my 100s more supporters - which I'd hope would network to 1000s & 10s of 1000s. They need to see the Proof of the fraud - of all the trial seams etc. (See 35/52 on website) et al.

#5) I need big ticket fundraising; about \$2 million for (a) a PR Campaign by a professional PR team & (b) a crack legal team w/ guts who won't back down. I figure, about \$1M each, tho maybe more for the PR team. With this, I would be freed.

#6) Every INDIGENT prisoner (which I am) needs \$ - for food, shoes, clothes, a few other basic needs (ink pen, paper, maybe books, literature, glasses, comb/brush etc etc. For 35 years it has been my tenacious policy to never beg for \$ from INDIVIDUALS, whether friends, family, church members or family, et al. But I do not turn down something offered, I just don't believe in asking. I also have no qualms about asking online to the general public for donations for legal defense fees & other needs. I also have not objected to friends asking for donations on my behalf, though


I do not INVITE those requests. This is not about misplaced "PRIDE" - it is about being polite as I was raised to be, & about not putting others on the spot, not being a "noob," and maintaining my self-respect & some degree of independence. Right or wrong, it is my policy. From time to time some caring people donate \$ which allows me to get specially approved food & needs packages - which I gladly accept, but will never ask for unless just invited to.

I hope you can & will help me. I'm so saddened to see Yorie & Scott are still in captivity. When I last spoke to Joan (Yorie's mom), she was hopeful of his release via legal channels; I was more realistic, tho I never told her, hoping I was wrong & that she would prevail. I had hopes in TRUMP but those have been dashed for the most part.
