Greetings Rudy & Erin,

It's always to you & yours.

You are both so EXCEPTIONALLY astute & selflessly caring, and amazingly efficient, that I feel I've neglected to ask you more about your own backgrounds & such. If you could send me a bio, I'd be very grateful.

Let me explain the enclosures here. Eventually they can be put online, but not just yet, ^{SOME OF THEM,} for reasons I'll explain here. Before I go further here, ¹ let me instruct that names in the letter, as well as names & other info on the 2 attached affidavits WHICH IVE HIGHLIGHTED IN BLUE PENCIL, need to have those blue bits of text REDACTED such as by a heavy black mark overlay so that the "blue" names & dates etc don't show ~~to~~ when this is all posted online. This is because I don't have permission yet from 3 people involved to put their affidavits online or otherwise to make public. And I wish to protect them & their right to privacy by this precaution; until I get their permission - which I'm waiting for an answer on now from [redacted]. As to [redacted] he will probably never give this permission because parole board internal affairs (IA) scoundrels intimidated him into backing off on his affidavit and he's now living in significant fear of CSCA/BPH reprisals unless he backed down - so he did. But, as long as you can just redact (black out) all the parts I have in blue, before you post them online, then go ahead and post them,

ie, the [redacted] affidavits. You can post them now, if you have those text pieces just blacked out. (If you see any other place I may have missed that has their name, please black it out just - as I did all this in a rush, skimming.) I left one letter (digit) or partial digit of their names showing so your audience can see there are names there that we've redacted, though I don't know if you wish to try to be that technical in your redaction efforts. I also redacted dates and cell #s, for the same privacy reasons. It's true case stuff could still determine who [redacted] is by the surrounding info, but they may not be willing to go to the trouble of doing so, and without something more concrete, they are not likely to retaliate against him for standing up.

[2] THE TRUE FACTS page, you may post now, as ~~it~~ is. It's a simple, accurate 1-pager, a good nutshell overview/synopsis of my case in general. (If you haven't already posted this from my website).

[3] As to the remaining 2 documents to ROSEN & PECK; There is a situation with both of these, whereas they CANNOT YET BE POSTED because one significant point in each of them; They both are based in part on the [redacted] affidavit. [redacted] will likely give me his permission to ~~see~~ post his affidavit, so I think it's best you sit on them till I get that permission. If I want to send them to you, they will get forever buried in ~~ten~~ tens of thousands of pages of piles & piles & piles of papers I'm buried under. So, please hold these until further notice on the [redacted] affidavit. Note

also that the [redacted] affidavit is missing from my ltr to ROSEN. That's because you can take the copy from the PECK letter & paste it to the ROSEN letter - because its difficult to get copies of documents here, such as these. Once [redacted] gives me his permission, I will pass that on to you & you can post both ROSEN & PECK documents at that time. In the mean time you can read them & get a sense of whats going on on those fronts. Note that (a) Neither PECK nor ROSEN ever responded, which shows what type of true characters they are, evidently with scoundrelous motives. And (b) As to all the other people & agencies listed at the bottom of each ltr, with a "cc" - I have not yet sent those copies because I've not been able to get the copies nor the manpower (~~time~~^{TIME}) to do that. Possibly someone who reads this can help me with getting copies & mailing to each of them. Then they, too, will have no excuse for inaction. (For the purpose of the OIG (OFFICE OF INSPECTOR GENERAL) is specifically to rectify CSER corruption but they almost never do anything but jerk us around - and ROBERT BARTON who was just head of the OIG, just changed hats - now he is a BPN Commissioner in the seat to deny parole to men like me).

[4] In case you are wondering why I didnt just redact the names & info from the affidavits myself, as I wanted you (& other you may share them with personally - just not worldwide - publicly) to see for yourself these are real people & really are authentic. Complete affidavits - & to ~~have~~ have a "safety copy" record them in your hands in case all my copies get destroyed - which would have often done.

[5] LATE ENTRY: I just found yet another document I have a copy of which you can post online PRESENTLY. ENCLOSED: Letter of 3-2-18 to the Calif Attorney General; probably the most corrupt agency of the Calif. government, maybe next to CSCE, or maybe worse. This AG & its armies of state attorneys have for decades been the "defense attorneys" for criminal CSCE/CCPOA guards. When guards & other corrupt CSCE officials are sued for outrageous crimes including rapes, torture, murder etc of prisoners, they are almost always represented by the Calif AG. Like attorneys the MSBA has to defend their kingpins & hitmen, dope dealers, human traffickers, etc. Here, the taxpayers actually pay the AG's armies to defend them in their many crimes.

I realize some of my more conservative friends may chastize me (or worse) for what they will regard as a harsh & scathing confrontation directly to the AG, accusing them of even murder, but the FACTS are just that and decades of deploration to the AG has only fallen on deaf ears. Plus, in order to successfully run litigation against the AG, they must be INFORMED of these crimes by CSCE staff, put "on Notice" & given the opportunity to cease & remedy. So this ltr does all that - to no avail.
