Greetings Rudy & Erin,

God's blessings to you & yours.

For this trip I'm enclosing 4 brief documents. All can be posted online. A few words concerning some of them will be helpful, if you can post this info also. In enclosing the docs in this order, the mailroom staff or guards might sometimes disorder them differently:

1. My ltr of 1-26-16 to BAH, explaining why it would be IRRESPONSIBLE to let another one of the BAH criminal psychologists "evaluate" me to provide them another opportunity to fraudulently falsify psych reports against me again. (3 REASONS HERE: 1) TO AVOID THEIR FRAUD SCAM
2) I DON'T GAMBLE
3) PENDING LITIGATION REQUIRES I AVOID THEM.

For my exercising this right to not be drawn into the criminal game, you (RUDY) saw the retaliatory punishment the BAH panel hit me with in the 2 most recent transcripts.


2. AFFIDAVIT OF PETE COCKROFT: These xerox copies cut off the very bottom of pp 1 & 2 where Pete initialed those pages. You can see the very top of his initials. I often have affiants initial every page of their affidavits so no one could later falsely claim that pages were switched. (9) Mr NAPPI, a violent maniac, was not only the prison librarian employee, but he was also an attorney in the state of New York - and he had some problems with his vicious behavior back there. (I've forgotten exact details). At one point, Nappi threw a stapler against the wall sort of at me, and some other items too, in his rage. He obviously was not trying to hit me, but to make

a statement of violence threats. As usual, there was no genuine forum for a remedy in case. Had I filed complaints w/ the full info of his "off the rail" behavior at that time, they would have thrown me in the hole, written me a false "CYA" ("Cover Your A--") AVR = standard procedure, etc. But almost countless prison employees, almost all guards except a few other genre of employees who the guards have created w/ their macho status to join in their targeting campaign against me.

RE: EXERCISE OF RIGHT TO NOT CONSULT WITH ANY BPH FAD PSYCHOLOGIST

Sir or Ma'am:

This is my formal notice to you that I will not be attending a BPH FAD consultation with you, nor speak with you; this letter will serve that purpose.

While I am one of the most cooperative **people on earth**, it would be the height of irresponsibility for me to talk with you for several reasons, mainly these:

I have the right to engage the services of a private, non-CDCR/non-BPH psychologist for purposes of this hearing, and I elect to do so.

Among my reasons for that decision, is that after having A FULL LIFETIME of a completely clean, excellent mental health history prior to prison, and parole-favorable reports for all prior parole hearings, upon my naively undergoing the new BPH "FAD" psychologist consultations for the past couple hearings, both psychologists (James Murphy and Susan Hoyt), each committed dozens of acts of criminal fraud in materially falsifying their reports and committed SEVERE ethics violations in the way they conducted the consultations. This is now a matter of record and indisputable. They invented false, negative social and psych histories out of thin air, in addition to reiterating and expanding on prior false reports with no valid foundation to justify doing so. They even claimed I stated things where I said no such thing, and the subjects had not even arisen. These false reports were reviewed in depth by neutral, highly respected psychologists, Dr. David Antion, PhD, and Dr. Melvin Macomber, PhD, and both found both reports to have been fraudulent, fabricated, dishonest, and unethical through and through. (See their rebuttals). So, it is HONEST DOCTORS of your own field, who have agreed with me in my assertions.

I acknowledge that YOU may be different, maybe totally honest, ethical and competent, and would conduct an honest and fair consultation and evaluation. The problem is I HAVE NO WAY TO KNOW THAT -- and could never know until it is too late, as it was with Murphy and Hoyt -- so far, batting a 100% score that they were of a mercenary genre with a personal agenda to destroy my due parole and reputation with their libels and slanders.

ALL I SEEK IS AN HONEST, FAIR EVALUATION; but the past record shows CONSISTENTLY that the odds are greatly against receiving that from a FAD psych; and I don't gamble and shouldn't have to enter this as a craps shoot. I'll engage my own. (And pending litigation prevents my consulting with a BPH-FAD psych at this time)

AFFIDAVIT

1 I, the undersigned, Pete T. Cockcroft, Being first put under
2 affirmation, attest that:

3 1.) My name is Pete T. Cockcroft, and I am a prisoner of the state of
4 California, CDC number H86887. I am presently incarcerated at Calif-
5 ornia State Prison-Sacramento (CSP-Sac) ["New Folsom"], on B-Facility,
6 Cell B-211.

7 2.) This concerns another prisoner named Lazor, CDC number C-73842
8 also at CSP-Sac on B-Facility, Lazor and I share the same law library.
9 which we both frequent regularly.

10 3.) On Friday March 2, 2012, both Lazor and I were in the library
11 The law library "use" area is very small & confined, with a maximum capacity
12 of ten-to-twelve prisoners; I was seated very close to Lazor on 3-2-12.

13 4.) The law librarian, Mr. Arnold Nappi, dashed from his office and
14 began fiercely yelling at Lazor for no apparent reason; making a partic-
15 ularly punctuated and repetitive point of threatening Lazor with force-
16 ful removal from the library, banning him from the library for some
17 period of time, and that he would write Mr. Lazor a "Misconduct Report"
18 (also known as a CDC-115RVR) against Lazor, while it was crystal clear
19 Lazor, was not engaging in any misconduct or rule breaking activity;
20 unlike Mr. Nappi, himself who was extremely loud, disruptive, and
21 verbally assaultive, using numerous curse words, including but not limited
22 to: "shut the fuck-up", "I don't give a shit", "you dumb fucking inmate",
23 etc. etc...

24 5.) In fact to the contrary, Lazor, remained remarkably peacefully
25 calm and non-engaging, and mature in his demeanor and response
26 to Mr Nappi, it was clearly evident that Lazor needed to respond to
27 Nappi, as the only way to avoid Nappi's obviously escalating wrath and
28 acting on his increasing threats, Lazor calmly attempted to state in

1 response that Nappi ~~is~~ had mis-perceived the matter that has Nappi
2 so riled up and that Lazor hasn't done the act Nappi was accusing him
3 of. Lazor even continued to politely refer to Nappi as "sir" even under
4 this heated abuse in front of a library full of other prisoners, For this
5 Nappi increased his shouted ravings, screaming to Lazor to shut the
6 fuck-up, or one more word, and he'd push his personal alarm, have Lazor,
7 forcefully removed, written a misconduct report - obviously false -
8 and so on. Lazor complied in obvious exasperation.

9 6.) Mr. Nappi's conduct as I observed it was extremely disrespectful
10 towards Lazor (and disruptive to the entire library users) which is
11 in violation of prison regulations (disrespect towards others); but
12 much more, it was inciting, not only his targeted person (Lazor), but
13 negatively charged the whole library atmosphere with a pro-violence,
14 and aggressive abuse ambiance.

15 7.) On another occasion, Mr. Nappi, became hostile and verbally
16 abusive and disrespectful towards even me for merely requesting if
17 he would reboot the computer I was using that had frozen up on
18 me. He snapped at me loudly yelling at me not to talk to him but to
19 instead talk to the clerks (who have no ability to unlock the computer
20 cabinet to re-boot it). He routinely refuses to communicate what-
21 soever to library users, but when he does it's with hostility deterring
22 us to his clerks for matters they are not allowed or able to nor
23 capable of doing (as in my case only Nappi has keys to open the
24 computer cabinets). When I pointed this out he began cursing at
25 me in a loud abusive manner, for making a purely simple request.

26 I attest, under affirmation and subject to penalties for perjury,
27 that the foregoing statements herein, are all true of my own personal knowledge
28 This affidavit hereby is made on March 7, 2012, at CSP-Sac Prison in

Hello, I am writing this letter on behalf of my friend Free Lazor whom I have known for 17 years.

In that 17 years I have been at 3 prison yards with him including this yard where he is currently my celly. In the time I have spent with him I have observed a complete lack of criminal mentality. Even when we were on a general population level 4 yard at Centinella where I first met him he managed to avoid involvement in prison inmate politics and immerse himself in his legal work and rigorous studies. He has always shown kindness, respect and sympathy for others and a devotion to personal qualities such as integrity, a love of truth and righteousness. Needless to say such a person has not with strife and grief because of a disposition that is in direct conflict with the general mentalities that dominate prison yards.

In the years that past between the times we meet again the kind of person I have seen him to be has indeed suggesting an integrity to his disposition. I have seen no signs of a criminal mentality in him and it is obvious that he is simply out of place here in prison.

I became his cellmate because I knew he was a safe person to be around and in the time I have spent sharing a cell with him I have been at ease and comfortable. He spends all of his time in wholesome endeavors such as music, groups, college and number one in release from prison. He constantly fights for his freedom thru litigation and because he uses litigation

as a means to uphold certain rights, liberties, and correct what is wrong he has suffered retaliation and unfair treatment which is often the case and curse of an inmate litigator. I have personally seen and experienced it myself and it is a well known and documented phenomena.

If you just look at and consider the man in front of you it is obvious that what you have before you is not a criminal and poses no risk to society and it would be of no benefit to keep Lazor in prison.

No amount of time can undo what has been done and the past is not an accurate representation of what you are now though it is the events that change us and cause growth. But it is what we do right now that reveals who and what we are. Lazor deserves his freedom.

This is my honest testimony on my friend Free and it is my hope that you who read this carefully consider the truth I have written.
