Dear President Trump,

After listening to you address the Nation, I feel pride in America again, a feeling before you came along, I have not felt for a long time. So I would like to take this opportunity to reach out to you and ask for your help in undoing a terrible wrong done to my son David.

About 15 years ago the FBI, IRS and Justice Department decided it was time to silence my Son, David R. Hinkson for his audacity to challenge the Government and yes to even sue some of the Government officials. This brought a consolidated effort to "bring him down" and indeed they did. They resorted to the most common charge of choice, to solicit the murder of the Federal officials that He was suing, yes only suing. Thinking He had the right to do so under the Constitution. It wasn't very smart of him to do this, but he has a condition called Auspurgers Syndrome. This is a form of autism where David is brilliant in scientific ways but lacks the human skills to interact with others. If only he had known what our Government was capable of doing to whistle blowers or dissenters but he lives in his own world and had devoted his life in helping the sick and perfecting his minerals. David had developed a way of making liquid minerals and was manufacturing them in Idaho at the time.

The Justice Department put him in prison after a trial where the Judge (Richard C. Tallman) became a knowing participant in the violation of David's Constitutional rights. This Judge made sure David didn't receive a fair trial. He lied during the trial, HE TRULY WAS A 'BLACK-ROBED PROSECUTOR and a careful look at the transcripts would show this. However, this Judge ruled to suppress much of our evidence without letting the jury even hear it. This Judge made law as he decided it was, ignoring the Constitution. This Judge was and is on the 9th circuit court and had to step down just to try David.

David was charged with 11 counts of conspiracy to commit murder. He was found not guilty on all but 3 counts. The only witness against him was Evan Joe Swisher who had told David that he wanted half of his business or he would testify that David had asked him to murder. Judge Tallman, knowing full well that David was not guilty and knowing that the testimony of Evan Joe Swisher was perjured (later he was convicted of perjury for these same lies.) And knowing that David was not even in the Country at the time he was supposed to be propositioning Mr. Swisher to murder. Mr. Swisher was recovering from heart surgery at the time this was supposed to have taken place and couldn't even get out of his wheel chair. Judge Tallman forbade our Attorney to disclose these facts to the jury. Then he sentenced David to 43 years in prison. Yes 43 years, and not satisfied with this, he recommended Maximum Security with 23 hours a day in isolation lock down with no human contact. THE QUESTION

HERE IS, WHAT DID DAVID DO, TO MAKE SO MANY PEOPLE IN HIGH PLACES IN GOVERNMENT, WANT HIM DEAD!!! David was not only, not guilty but no crime was ever committed.

David is a gentle business man that has invented a method to put the essential minerals back into the body through his mineral waters. His mistake was to think that he could sue agents in various government agencies for harassment. This is truly a conspiracy that goes way back to the beginning of David's trouble with the IRS, Justice Department and FDA.

I ask you to look into this appalling matter before "Justice for All" becomes a thing of the past. All David wants is to be given a NEW TRIAL. We have been trying to get a new trial for all these years but the Government knows that he will not be found guilty if he receives a new trial, as so much more evidence has come to light, and so they fight this. All David wants is to resume his life's work helping others. David's case is on the internet, case No. CR-04-0127. And case No. CR-02-0142.

Enclosed is David's story, please don't ignore it. Please find time to investigate the corruption in our own FBI, IRS and Justice Department. David's story is only one story of so many wrongs committed by our own Government to those who dared to descend or to exercise their 1st amendment right of free speech. David has now been in prison for over 14 years. He had 5 children went he went to prison, who now have grown up without any supervision and so another generation of grief and pain.

A plea for help from David R. Hinkson

As I sit here in prison I reflect on the past 14 years. My Story is a shocking abuse of the judicial process. To date, my family and I have spent over 4 million on lawyers attempting to defend me. I ask you to look at my web site d-hinkson.com, and should you want more information, my father's phone number [REDACTED] has studied what has happened to me and he has all the documentation. He can tell you the entire shocking story, how they stalked me, made up crimes against me, threw me in jail, would not let me have a bond hearing, used perjury and forged documents to convict me. He has a 600 page dossier of the government corruption regarding my case. I appeal to you to look at the shocking things done in my case, I have been in solitary confinement, I have been chained at the ankles, waist and wrist, totally, defenseless my head was cracked open requiring five stitches on April 25th, 2005.

Please investigate these terrible crimes against me. Please read the whole story. My case is the "poster child" case. I am now 62 years old and I am the father of 5 children, one of whom is very disabled. I have no criminal record and I am innocent of these charges. I have never even been accused of any crime in the past.

The last 12 years before my convection, I had been doing medical research. I started a company that manufactures health dietary supplements. I was working on curing many ailments including AIDS, Tuberculosis and the common cold. My work is needed. I have worked in clinics overseas doing clinical studies on viral solutions. I also found a new treatment for TB and sickle cell anemia. See my web site wateroz.com for more information on my company and products.

I failed to file my tax returns; however the maximum punishment is about one year. I was out of the country and working overseas from June through November 2002 when I was supposed to be hiring a hit man to kill a federal judge. I was not in the country but the Judge; Richard C. Tallman wouldn't let me prove it. I had several "alibi" witnesses but the Judge wouldn't let them testify. He told my lawyer to move along to other areas. He wouldn't let the jury see my past port that proved that I was out of the country.

When I was being arrested, I had a tape recorder in my pocket that was turned on. I was not read my rights, but the Judge said that it was nonconsequential that the FBI agent lied about this.

In my case, there was no evidence that a crime had even been committed, no Mens Rea, no element of a crime presented in court, just hearsay statements by the con man that forged his own DD-214 which he had previously used to defraud the government out of VA medical and disability benefits. No discovery was allowed to let me know what was coming so that I could find out what my accusers were saying against me. The Judge violated every civil right I thought I ever had.

The informants in my case also told the Grand Jury in 2001 and 2002 that I had murdered Art Bell's son (late night talk radio show host), yet his son is alive and well today: also the agents told the Grand Jury that I was head of two militias and was a machine gun dealer. I have never been to a militia meeting: I have never owned or fired a machine gun. They even said that I think I am God and live in a compound with followers who put "hits" out on people. I have not had a chance to defend myself. Just vicious rumors used to stir up the passions of the Grand Jury against me so the US Attorneys could manipulate an indictment out of them.

I appealed my conviction and I won the appeal 2 to 1 for a complete reversal of the conviction. However the government appealed my win and asked for an Onbank hearing. (11 Judge Panel). They heard my appeal on December 15th, 2008. They ruled 5 to 6 split against me. My Father and Attorney have gone on to appeal many different appealed but the government does not follow their own rules. Like 3 Judges are suppose to view the appeal but they just stamp it denied and send it back.

Please look into this matter, please help me to resume my life, and please do not let a crooked system destroy another innocent man. I have been in prison for over 14 years now as they hold me for 2 years while they searched for someone to testify against me.
