Hello, my name is David Hinkson;

I have listening to you for many years from Prison, you truly are the great one (Denali). I have been very impressed with your efforts to proceed with an Article 5 Convention of the States, as this really needs to get done. I have noticed, that most people have never actually read the U.S. Constitution. Back in 1988, I also noticed Article five; and at that time, I also took notice of The Seventh Amendment, and Article Four Section Four.

I also, myself, used to do a talk show between 1988 and 1995, called the "David Hinkson Show," on the WWCR and other frequencies. I interviewed many interesting guests during this run as a Host, i.e. Right Way Law and Bill Benson (who wrote the book the law that never was), and in fact I interview many of the same guests that spoke on Coast to Coast when Art Bell still had control.

I never went to law school officially like you, but as I type over 120 words per minute, and as I was trying to broker a deal to sell some fertilizer to China, met the late George Grazadie and at this time, we I became partners in this venture. In the end, I ended up working as a volunteer, as un-licensed Paralegal with George Grazadie (1988 - 1993). The late George Grazadie was really a conservative Christian man, even though he was the real so called Mob Attorney that represented the Stardust (see the movie Casino). George graduated from the University of Law in Chicago, as All Capone had actually set aside funds to pay for his god son's college. George, used to go to Uncle Al's home on many Sundays for Sunday dinner, as his father was Al's Enforcer. George used to have a real original hand painted picture of Al Capone hanging on his wall in his office. Note that now his Junior Partner is still alive, and practicing law in Las Vegas (Scott Cantor).

I also became good friends with the late Charles Crum, who was a retired law professor, as he actually lived with me in my home for 7 years, as I was running a board and care facility; he died when he stepped out in front of a bus.

During this same period of time I met the Late George E. Mitzel, who used to own 1,200 Gas Stations and an Oil Refinery on the west coast during the World War II era. George E. Mitzel had sold his Stations and Oil Refinery, and built a Casino on the Las Vegas Strip, called the San Suisse. Then George Mitzel, sold his Casino to Howard Hughes (then known as Castaways), and used the funds to purchase the Valley Wells Ranch. The Valley Wells Ranch was over 750,000 Acres of land (30X40 miles square - see TV show Bonanza). This Ranch was in private ownership since the 1700's, and there is even a Yates Family Cemetery near the Yates Wells Off ramp (off of 1 - 15), right past the CA Boarder.

The BLM stole this land in a similar manner, as the current Bundy fight, and they also in my opinion, used Acetone Swabs to erase the Microfiche. Before Mitzel death, he willed me this Ranch. The BLM still won't give it back.

So, in conclusion he re, I ended up working with George Grazadie, George Mitzel and Charles Crum, as I became the foremost expert on land issues. I did have a head start in some of these concepts, as I had a degree in finance, and I was an actual real-estate broker, licensed in three states during the early 80's. At this time I now also have a degree in Naturapathe, and speak fluent Russian and Spanish.

I ended up in the middle of a fight over these so-called public lands (not unappropriated), as I worked with these people to save the Valley Wells Ranch. George Grazadie taught me how to do legal research in the Clark County Law Library, and Charles Crum and I went to the Federal Archives at the UNLV in Las Vegas to do our research. We studied even the Spanish Land Grants and how real-estate was owned and claimed before the Civil War. So, at this time, it is my opinion that I'm the foremost expert in the United States on Pre Civil War Land Law. Maybe I'm a Denali of Pre Civil War Law.

Therefore, I ended up actually doing the Sage Brush Rebellion Briefs against the BLM. These briefs actually won, as the federal government surrendered. We won, as in all reality, they did not want to have the correct argument brought or heard in court. These Sage Brush Rebellion Briefs are now still available for your preview, if you would desire to see them. I also did the Legal Briefs for Bobby Bericini (see Lido at Stardust) to save Clyde the Orangutan (see movie "Any Which Way But Lose").

In summary about these Sage Brush Rebellion Briefs, I was able to prove that the Federal Government never owned or even had the right to own or even control any of the public lands in question (see the Bundy Fight); in fact I can prove that they do not own Yellowstone National Park.

Maybe, this is why this agency is now called the Bureau of Land MANAGEMENT. In these Legal Briefs, I used arguments and concepts, like the Equal Footing doctrine, that states that anything that is given to one state, must be given to all states under equal footing. Did the State of California, Texas or even Maryland, ever give up 88% of their lands in a grant of Statehood? "No!" As the Tenth Amendment would have estopelled this. In a Supreme Court Case in the 90's, titled, "New York v. United States" the U.S. Supreme Court has stated that even "with consent," a State can not agree to any scheme or surrenders any her rights/privileges, pursuant to the Separation of Powers."

Before the Civil War, ownership of land was based on what is called an "Abstract of Title." This concept was protected by the Seventh Amendment of the Constitution, which states that "that in any controversy that exceeds twenty dollars, the right of a "Common Law Trial" shall be preserved." Note, that no where in the Constitution was the United States Government ever officially granted the right to claim or control these so-called public lands, except for the lands known as the District of Columbia" (see Article 1 Section 8, Clause 17). Note that pursuant to Article 1, the only lands that the U.S. is shown to be able to claim are for needful forts and dockyards. Even the Department of Interior, was originally created for the sole purpose of managing and regulating lands, within only the Interior of the District of Columbia, and/or territories that are still owned or controlled by the United States (see Puerto Rico). So, we now, we have the Federal Government keeping and/or claiming 88% ownership in any state that Joins the Union.

Also, before the civil war land was originally claimed by filling a Deed Pole. A Deed Pole, is a deed, whereas you deed yourself the property in the name of our Savior Jesus Christ; as Jesus, who really owns the property. Now, if any person has laid a prior claim to your property, or has a previous right to your property, you are entitled to have this dispute settled via a court, that can only be venued in the Common Law (see 7th Amend.). These concepts are lost, but I have found a case where even after the

Civil War, a D.P. Claimant was arguing with a new Pat. Claimant who had gotten a U.S. Patent, and the de-facto U.S. Supreme Court, officially ruled that the Deed Pole was superior to a Patent. In my opinion, all of the Laws that were passed prior to the Civil War are still valid and take precedent over post Civil War Law. It is my opinion that the Buddy's actually own the land in question, as the BLM does not and has no real legal right or title to these lands. The Buddy's are thus actually protected by the Seventh Amendment, as this controversy exceeds twenty dollars. If you doubt what I have to say about this issue, than I would challenge you to answer my Sage Brush Rebellion Brief, that was done for the late Douglas Noland; as is available for your purview.

This, is where it gets a little bit interesting. Note here, that there are two separate and distinct constitutions. The first created constitution was created by the original 13 Republic States, under their power to create treaties (as a Common Law Treaty). The actual venue for these Republic States, was solely in the Common Law (not Statute Law.)(see 7th Amend. and Article 4). This is why, the Seventh Amendment specifically states that all "controversy's that exceed 20 dollars, shall be venued [only] in the Common Law). The second constitution was created in 1913, by the progressives, as it is a document that was pledgerized, to become the new Corporate By-Laws, for this new phony progressive scheme/Corporation, that is now known as the "United States Constitution/or the U.S. Constitution".

So, really there are two different and separate and distinct Constitutions. What this really means is that the Organic Original Constitution for the United States of America, was the Document that actually created the Ten Miles Square, and controlled all such activities therein; as it did not create a National Government (outside of the 10 miles square).

We also note at this time that all Writs are in fact Common Law instruments, and all Motions are Statutory Law. There was never a constitutional amendment that guaranteed, that the "right of a Motion of Habeas Corpus, shall not be suspended." This guaranteed right states that the "Writ of Habeas Corpus shall not be suspended". To now cancel the Common Law Habeas Corpus, and replace it with a Statutory 2255 or a 2241 Motion, violates the guarantee of a Republican form of government (see Article four Section 4 & 7th Amend.); in both said constitutions (pledgerized text and organic).

Do you really think that the founding fathers, just forgot to put a citizenship clause in the Constitution? Did we really need to have the 14th Amendment created to have Citizens? Note that only a few states have ratified the 14th, 15 or 16th Amendments (see the law that never was). In fact it was a U.S. Supreme Court Case called Union Pacific Railroad that stated, that the so-called creation of the 16th Amendment, never canceled Article 1 Section One. What this means is that the 16th Amendment (that was never properly ratified), really never gave the U.S. the power to even create an IRS, let alone collect taxes from the citizens of within the Sovereign States.

But the Sovereign States have all been Sini Died (Latin for the sun has now set), as they were replaced by the United States Corporations as Sub Corporations. Therefore, there are now two of every state that was created before the Civil War. I.E. There is the California and Texas Republics and the State of California and Texas; and there are even two separate state constitutions. But in the States created after the Civil War like Nevada, there is only one of them, as they were created after the Civil War.

So, here is my question for you. You state that you want to have an Article Five Convention of the States. Which Constitution are you going to use, as both are worded the same. Really, to get rid of all of this fraud, you really need to bring back the real Republican form of government, and cancel the U.S.

Corporation. I have noticed that even when I joined the U.S. Navy, I gave the Oath saying "I swear to honor and uphold the Constitution of the United States of/for America and protect her against all enemies domestic and foreign." I just did not realize that I was committing treason as I graduated from Book Camp, as I was now working for the domestic enemy. But I have repented of this crime.

So, now in all reality, as you can not be a citizen of a Corporation, the people of this land now have no citizenship. There has been an ongoing scheme, from the beginning to steal the wealth and enslave the people and this scheme was created and was funding by the bankers and their stoolies.

We now live in a country where you can not own any real-estate, as the Corporation owns it. The lands in every state were stolen by the Carpet Baggers under Abe. If you buy a car you get a certificate of title. I want a Title not a Certificate. How many Lentil Beans o you have, if I give you a Certificate of Lentil Beans? Note that the word "OF" is used to achieve all of these schemes. Certificate of Title; State Of California and even the Churches have been "OF" (OVED). Now when you go to the Recorders Office you are appointing an Attorney In Fact, as you have the Notary Stamp put in place; and you pay them a Transfer Tax, as they stamp there corporate seal on your document and then most deeds have your name in all upper case letters (see the U.S. Styles Manual), to make sure that you are an inadament object with no birth right to God. What I'm trying to tell you is that everything is a fraud and it has been created using fraudulent concepts. The U.S. Styles Manual proves this. I have been able to now do a Deed Pole and remove my property from their venue.

. Also, I discovered that all of Title 16 was never made into positive law, as the de facto, U.S. Congress never even voted on it, and that all of Title 18 was never even voted on by Congress. I have the ability to discuss any and all of these topics, including the fact that the United States is now a de facto corporation. I can speak about these things in great detail and I am now attempting to make some statements for you, that I I thought you will find interesting.

While I was doing my own talk show, I also co hosted on the air in Las Vegas with Lue Epton. Lue, was a movie star, and played the bartender in the Kojack series. Lue introduced me to Erin Russo (movie director), and when Erin ran against Harry Reid in the early 90's, I was his campaign manager. I used to attack Harry Reid every day five days a week. I also ran for County Commissioner and lost.

It would seem that I have always had the gift of understanding how things work. When I was only 17 years old, I took an aptitude exam, as I wanted to enlist in the U.S. Navy. I scored over 90% on the subjects of Physics, Electronics and Mechanics. I then ended up working and being stationed and worked at HSL-30 Norfolk Virginia, working Anti-Submarine missions. I was an ADJ AN. Specialized in Helo's. SH 2F Model.

New Subject.

In 1993, I actually built and created a real GALT Motor. It is just like the GALT Motor that was talked about and described in Ann Rand's famous Book, titled "Atlas Shrugged". The acronym GALT actually stands for, "Geometrically Amplified Lateral Torrid." Note here, that it was just a coincidence, that the name ended up being the same.

I thought that this would a topic of interest for you as I have heard you talk about EMP and CME and the fact that we need to now somehow get our National Power Grid Protected. We really are out of time. The GALT would be the best and most cost effective solution for this problem. Right now as a

political prisoner in federal prison, I have gotten an actual GALT Generator built and demonstrated, from here. If you go to Y-Tube and type in "GALTgenerator" and see the fourth pic down, you will see an actual GALT Alternator working. This video was created and Narrated, by the late and great Bob Sandberg, right before his death. We hope to have a better video, that can be seen for your preview soon. The GALT Motor, also makes free horse power as it creates the free A.C. Energy. Note that every university in the world is now teaching that there is no such thing as perpetual motion, and that you can not violate the law of thermal dynamics. I also know that the U.S. Patent Office will not let any device be Patented if it is claimed to be perpetual. So, we really need some political help to get the Patent secured. So, for now my plan is to fee the Grid. At GALT with a two foot Rotor will generate over 1,000 Horse Power and earn about \$250,000 a month at .05 per KWH.

I have never let the opinion of others slow me down, as I understand how things really work, and I knew the concept for the GALT land the Electric Jet Engine, would work even before I had them built. The GALT Motor could also now be used to provide Electrical Energy and even charge an Electric Car while you drive it; so now there will not be a need to plug the vehicle in. The GALT would also replace need for the Nuclear Reactors in all of the Subs and Aircraft Carriers, so there are many military ramifications.

In 1993, I also tested a new Electric Jet Engine (D.C), that makes its own power as it runs; and to slow it down you have to separate the self feeding circuit. This Electric Jet Engine would also replace the Internal Combustion Engine in all Motor applications, including Jet Engines in all Air Craft. We now will not need to have large battery's in the electric cars of the future.

I have written President Trump a couple of letters, to tell him about my GALT Motor. I had Bob Sandberg, try to get a Venture Capital Loan from the In-Q-Tel.org (CIA Lender); and we got no response back. The problem is that no one really believes that a person in prison could have invented these concepts. I know believe that I have all of the missing Tesla Technology. I also believe that the powers to be, really do not want the cost of energy to go down. New Subject.

In the past I created a business called WaterOz, for the sole purpose of having a product that I could sell on my Radio Talk Show, to pay for airtime. But things got a little bit out of control, when I discovered that the Copper was and is the real product that will remove and kill all Viruses and Parasites, within two hours. I used to give out free samples of these WaterOz products and I collected over 1,000 testimonials. Then the FDA decided to put me in prison to shut me up. Well, as I had broken no laws, they brought in a man name Swisher, who testified that I had hired him to be a hit man, to kill federal officials. Note, Mr. Swisher was actually in a coma in the VA Hospital when he said that I did this crime. Also, my passport showed that I was actually in Russia. So, they hid my alibi and his medical records. They transported me to Boise Idaho, for this roast. In summary here I have never done any crime and I'm very proud of all of my past work and achievements.

While I was in Russia, I went to see a Doctor named Doctor Gold, who had fled the U.S., after he found a new cure for Cancer. He is now practicing medicine in St. Petersburg Russia. I then spent many months and even years, doing clinical studies in Russia and other countries and gave a series of lectures on infectious diseases, while working with the Doctors Without Boarders. My last lecture was in Xharcove Ukraine as I spoke about infectious diseases at the Symposium of Infections Disease in the Baltic States.

Now, from prison have gotten further testing done on this none toxic Copper product, and have discovered that Cancer has now removed Cancer from three different patients. In the past, we also had a report that the Copper product had abated a condition of Sickle Cell. I learned that Copper, Zinc, Calcium and Magnesium are the only elements that can be found in all of the fluids through the entire body system; and as such the Copper now has the ability to travel across all boundaries; including the Blood Brain Barrier. For example, I had a cousin who had a lung infection and I had him drink some of the Copper product and within two hours his lung infection was gone. It would seem that it was able to enter the lung via the flem that is secreted into the lung cavity in order to neutralize the Acidic Crystalline Nuero Toxins that are being secreted by the Pathogens. We even saved a Doctor that had a Brain Eating Ameba, that he acquired while working in Africa for the Doctors without Boarders. At this time I no longer would promote drinking any "Silver Water" as I have learned that it does not cross the blood brain barrier or even the spinal barrier as it really stays localized and stains the cells; and Silver does not kill any Parasites.

In the past, I was able to give out thousands of free samples. Therefore, if a show like yours, for example, were to offer free samples of the Copper, we would mail out literally a million free samples and when the people, test the sample for themselves, and see their own miracle, in just a few hours, they might order more. We don't have to make medical claims as we just promote a test study.

While working with Lue Epton, we used the income from the steady sales to pay for his air time. I feel it is only right to continue to support the show that got the customers, especially as there is a large profit margin in this concept. We can keep the price down and still support or friends.

Also, I had the idea of doing a Crowd Funding projects for the GALT. We could then give your show 20% of the money that is collected for advertisement. This 20% would include the standard 10% fee that is now being charged by professionals in this field. It is my opinion that having 15 million listeners who believe in your word, is worth more than any so called expert in any field. In the past I have always had a reputation of being honest and I don't play any games. I don't need to teach the world the truth about their democracy as I have learned to just be quiet. But I assure you at this point in my career, I have no intention of letting the world continue to suffer from these diseases, that I know that I can cure and abate, and have the Global Warming Story shoved down our throats. I now know what needs to be done and I have a mission and we will get it done. My overall goal is to now help the people of the world with these two main concepts.

One of the things that we could do is as people to donate just one dollar to a fund to maybe, a harden the Grid campaign, build the first large GALT Motor, Rebuild the burned down WaterOz Factory. We could even offer people the right to enter into a Co-Generation contract with our non profit, called the Green Conservancy. In summary here, I would now like to use the GALT Motor and the Electric Jet

Motor to seize the Global Warming Agenda, even if I don't believe in the science as it is now taught. I would like to help you do your Article five convention of the states and rid the planet of infectious diseases. Just a few goals for the new year.

Now under this new U.S. Supreme Court ruling, known as Dimaya, it looks, like I could be released soon. Therefore, if you have any interest in my story or even interviewing me I would be honored to communicate with your from Prison. I have a lot of ideas and I would like to share them with you. I would also like to tell you about the other five inventions that I did not mention in this letter.
