Dear, Mr. Hannity.

The reason that you should now read my letter in it's entirety is that I will tell you about the real GALT Motor, that we now have actually working and can actually see it violating the Lenz Law; on Y-Tube. I also have some business proposals to cover at the end of this letter. I appoligize for the length of this letter.

Also, I saw you in the Movie "Atlas Shrugged," and I wanted to tell you that I thought you did a great job. I heard that you are also Ranite; so I assume you are. Therefore, I believe that like me, you overall liked the concepts of the late Ann Rand. Note here that the word "GALT" is now our real acronym. "G" = Geometrically; "A" = Amplified; "L" = Lateral; "T" Torroid. Note, that Nicola Tesla originally named his Transformer, the "Torroid". Torrid, is therefore the correct name that was supposed to have been used.

I have wanted to tell you about my seven different energy inventions, and offer them for your preview for over 10 years. But, up to this point in time, I have not been able to reach you, or even get your attention as I'm in prison. Therefore, I now reach out to you again. I did speak on the John Wells show, last month, and he like my ideas.

My close friend, the late Bob Sandberg, forwarded emails to you in the past, but you never responded. Now Bob has died and my new friend Rudy has told me that he would forward this letter to you.

I don't want to go into much detail here, as to why I'm in prison, but you need to know that if you have any questions, Rudy has a website, "lonestar1776," that highlights my whole story, and even a book about me that my fathers wrote. At this time, I just wanted to tell you, that I'm a provably innocent political prisoner, who was denied all evidence of innocence. For example, My Passport showed, that I was in Russia and the Ukraine and the witness who lied against me was actually in a Coma in the VA Hospital, when he said I hired him to kill Federal Officials. They hid my passport and his medical records and they are still hiding these items, as I write you this letter. This lying witness was later actually prosecuted for Stolen Valor and theft of Government Property; as he had claimed was Rambo, and a Korean War Veteran. He now stands convicted of the very same testimony that he used against me in court, and the U.S. Supreme Court has now ruled, that it is ok to wear a Purple Heart, as long as you don't economically hurt anybody in the process. Overall his provable lies gave me a sentence of death by time. Up to this time, the Ninth Circuit has wrongfully ruled against me every step of the way, and some of the very same Judges that ruled against President Trump's travel ban, created a whole new legal standard that they now call the "Hinkson Standard," just for me; as I'm very special. Note the creation of a new Legal Standard violated the Ex Post Facto Doctrine of the Constitution, as only the U.S. Supreme Court has the right to create or amend a any Legal Standard.

Note, now that under two U.S. Supreme Court cases referred to as the "Johnson" and "Dimaya" cases, the Ninth Circuit will now have to release me, as these new court rulings have now made all of my supposed crimes (that I did not do), not crimes of violence; and that means they now must un-stack six stacked sentences into just one. Therefore, my Successive 2255 is now pending in the Ninth Circuit, and the same Judges that did this to me, now have to make a decision again; but they truly are corrupt, as they make wrongful law from the bench and have

shown that they have no intention of following the constitution, or even common decency. They really are guilty of kidnapping and attempted murder against me.

I only needed to tell you a little bit, about my past history, so that you would understand that I actually know some physics and science.

PAST HISTORY: When I was 16 years old, I attempted to join the U.S. Navy in Montrose Colorado. I was told that if I got my GED first and scored high enough on the aptitude test, I could join when I turned 17. I therefore went to Western State College in Gunnison, and passed my GED and then I took a series of aptitude tests. I scored over 98% in both Physics and Science, and this showed that I had a fairly good understanding of these subjects. I later went to the Jet Mechanics School in Millington TN.

I ended up being stationed at HSL-30 Norfolk VA, in a squadron that was assigned to look for Russian and Chinese Submarines. At this time I studied all of the Magnetic Anti Submarine Warfare Concepts. At this time I walked into the GE Trailer, (on this base), as I wanted to explain my new idea, for a new Magnetic Motor. These Technicians just laughed at me.

After getting out of the Navy, I went to college at the University of Colorado and studied finance. I then became a Real-estate Broker. At this time I also ran a Board and Care Home for the Mentally Ill. I finally sold all of my properties in Colorado and moved to Las Vegas in 1986.

In 1993, I ended up I owning three Laundry and Dry Cleaning plants in Las Vegas, and I actually got accounts to wash Bed Spreads for most of the Casino's on the Strip. My specialty at that time, was using chemicals in a new way to remove stains, that no one else could remove. I guess you could say I became an expert in using chemicals for this purpose.

I also became friends with the late Lue Epton. Lue had a great talk show in Las Vegas. I used to go to Lue's Radio Studio in the Vegas World Casino, and I ended up being his Co-Host for four years. It became the Lue Epton and David Hinkson Show. Lue introduced me to Erin Russo (famous movie director). I later acted as Erin's campaign manager when he ran for the Senate against Harry Reid. Lue and I used to really go after Harry Reid every chance we got. I even exposed the Tortoise Scheme, that Harry was conducting to steal future off ramps. We ambushed Harry twice, live on the air. Harry Reid is a criminal and he really does not like me.

I used to listen to Art Bell on the Radio, as I worked late, and in 1993, while doing some Laundry, out in the Nevada Desert, I glued some magnets (used Auto Bondo) on some round aluminum disks, as I built and tested my own version/concept of this new Electric Magnetic Motor. I actually got the Rotor to create over one horse power from the magnets. At this time I could see that I was actually violating the laws of Thermal Dynamics and Lenz Law. Note that every College and University, and every book of physics in the world now teaches that this is totally impossible. But the one thing that you must remember is that Nicola Tesla, never had access to any of the Magnets, that are available today. In fact, it was not until the early 1988's, that these new magnets became available. This is why the early Cell Phones were called Brick Phones, as they were very thick; and the reason that they were thick, was because the Magnets in the speakers, were thick; now they are about as thin as a piece of paper.

I thereafter, tested five other energy devices and made them all work. I would love to tell you about all of them if you have some interest in hearing about them, but note here that they will all seem impossible, as that is what I do, I get what is deemed to be impossible, to actually work. For example, one of my favorite inventions, I named the "Electric Jet Engine". It makes its own Electricity as it runs, using the standard rule, called the "Right Hand Rule". This is the concept that is used in Car Starters today.

In 1989, I started doing my own talk show on the WWCR (World Wide Christian Radio

Network). But the problem at this time, was that I had no way to pay the \$10,000 a month air time. So, I had an idea for a new Type of Silver Water, that I could sell to raise these funds. I moved forward making this Silver Water. My idea, was to create an Plastic Pod, that had Silver Bars in the Bottom area and had Platinum Coated Niobium screen in the top area; and then use High Voltage to run the current in reverse, of the normal process. I was really trying to make a new clear Silver product, that had particles that were smaller and better, than the competition. At this time, I also built these same Pods to make Colloidal Copper and Gold. This whole scheme went south, when I discovered that you can not use Electricity to make a Silver or any health product, as they are toxic and Heavy Metal. But something interesting came out of these tests. I was able to heat 1,400 Gallons of distilled water to Boiling, using only .000001 Watts of Electrical Energy. I had in fact designed a working "Cold Fusion Reactor." Therefore, I now stopped testing Cold Fusion, and proceeded to use chemicals to make the Copper and Silver Waters instead of using Electricity.

At this time I created a new company called WaterOz. We made a variety of these mineral waters and collected thousands of testimonials. We also manufactured thousands of Ozone Machines, and sold them on the air.

I knew that Silver is known to kill all Nitrogen Breathing Pathogens; but I learned that Silver does not cross the Blood Brain Barrier, and can stain the tissue causing a disease known as Angeria. I, at this time, no longer believe that consuming a Silver Product is effective; in dealing with these Nitrogen Breath Pathogens.

This, is when it got a little bit interesting, as I discovered that Copper Water would actually replace Silver Water; and could be made totally non toxic. Note here that consuming heavy metal Copper can cause a disease called Wilson's Disease. So, making a new non toxic Copper product would be really very interesting. Copper totally kills all Nitrogen Breathing Pathogens (Viruses) and all Parasites (including the Brain Eating Ameba); as it actually crosses the Blood Brain Barrier and even helps the Liver as a Co-Enzyme, to digest Proteins. Then, I learned that there some diseases are actually caused by the Liver not being able to properly digest Proteins. We have not at this time finished doing these tests, but we are looking for people who have this condition, as we would like to finish these tests. During these past Clinical Trails, I never had any idea that Copper might be a new treatment to abate Cancer. Now, as we have been making it available to a few Cancer patients, we have been having 100% results removing Cancers. This is a very important concept, as Copper will go everywhere through the entire body system where there is moisture; and this means that we might have a new way to deal with Cancers that are impossible to reach or deal with, like Eye Cancer or Lung Cancers.

Therefore, these minerals and my overall mineral concepts have been tested and now have been sold all over the world for over 25 years. We have never had any complaint filed against us.

Now, you can go to YTube and type in GALT Generator (fourth pick down), to actually see our newest Motor test. We will have a better picture, showing it working soon. So, I have many ideas that you might be interested in.

In the past, I used to give Lue a percentage of all of the Bottles that were sold on his show; as this was very easy to track. For example you can use a "Promo Code". These generated funds amounted a very large amount of money being generated, as there is a good profit margin in making Health Food Supplements. One of the reasons for my success was that I would bring the price down, below any competition in the market place. We need to have a better mouse trap.

I also don't mind sharing the income ongoing, as I feel it is only fair to share the proceeds

with the show, ongoing to show support. To just pick a show clean and move on is not the way that I want to do business. I want to be a supporter and support an ongoing business relationship; while we actually help people. So, I have many ideas. These ideas are really interesting, as you and I share in many of the same beliefs and concepts.

NEW IDEAS: In the past, I used to offer a free product, like a bottle of the Copper Water, and then would ship out about 50,000 bottles (only charged one \$1 for Handling and \$1 Postage). Then about 25% of the people would just place an order for a \$24 bottle, and the others would place an order after they actually tested the product. I like to ship enough of a product for free, so that they will actually be able to have the results that will really get them on board. Like, for example, if they consume about one ounce of the Copper at 6,400 PPM's it will remove the Common Cold and even Aids and Malaria in two hours. That is a test that really gets them on board. So, overnight we would end up, with literally a million dollars a month being earned, every month thereafter. Now you might understand, that I do not mind paying for advertising.

. I liked marketing the Heath Food Supplement Products, as they really helped people, and people would also keep ordering them every month, and this would generate the funds needed for expansion.

Note that the WaterOz Zinc product, 100% stops all Sexual Replication of all Viruses, in only 15 minutes. This testing was originally done by "Larry Wayne Harris" at the CDC. I had the idea of creating a new Company called the Green Conservancy; therefore we already created it. Our mission statement for this corporation, is to save Mother Earth, by removing the use of fossil fuels; everywhere, In essence I want to seize the Global Warming Agenda and make it our new and personal movement; even though this movement is based on totally fraudulent science. We have the GALT!

Now I have read a book called "Bit Coin for Dummy's." In this book they talked about different people giving out a free Token, as a Bit Coin, if they donate a small amount to someone's Crowd Funding Project; and they were able to raise literally 150 million dollars; like an ICO Offering. So, we would in all reality be helping to create a new monetary money supply, that is actually backed by something of real value, while we raise the needed funds to build our factory and buy the equipment that we need to move forward. If I was on the street, I really would not need any help from anybody. But as I'm a political prisoner in prison, I really could use some help getting these projects moving. There is plenty of money to be earned in the field of Energy and Medicine. For example if we were to build a GALT that has only a two foot Rotor in it, we would generate over \$250,000 per month at .05 Per Kilowatt Hour; and our total cost to construct a unit of this size is approximately \$6,000.00. Our overall Green Conservancy mission statement, is to lower the cost of energy, to economically help every country; to create millions of good jobs and to stop the burning of fossil fuels and to protect the Grid (from EMP and/or CME).

If a show like yours were to indorse any one of our Crowd Funding projects, millions of people would just pitch in a dollar, and we would raise the needed funds to move forward very fast. Then, of course I would be willing to sign and agree to give your organization a permanent percentage of the income, to your show for advertising. The standard fee schedule for a Crowd Funding Expert is about 10% of the Gross that is collected in an offering. Therefore, if we were to agree to a flat 10% for the Crowd Funding, and an extra 10% to pay for advertising, the amount that would be paid to your network would be a large ongoing sum. I even had the idea of placing some of the GALT's at different Radio Stations to pay for air time. The GALT is great, as every month they have to pay us for the energy. Therefore, if we have a contract to share in the proceeds, this would be great for all parties concerned. I have already talked to a couple of interested Utility Companies and two different Reservation Chiefs about entering into a Co-Generation Contract, to share in the monthly energy income. The bottom line, is that this is an easy sell and everybody that hears about it is immediately interested. They actually get very excited. I like talking about things that sell themselves.

Anyway, the GALT Motor can be used to actually Harden and protect the Grid; lower the overall cost of energy to the consumer; and provide Green Energy, without the use of any fossil fuels; and create millions of green jobs. I have heard you offer to help people get employment in the oil boom; as you seem interested in helping your audience with these kind of concepts. I would like to now, even offer some people who donate to our Green Conservancy, a Co-

Generation Contract, whereas we share in the income in the near future. Maybe they can even provide a location. Our overall mission statement is not to sell GALT Generators, but to sell the energy and this would earn us a monthly amount. We will use the large cash flow to keep our expansion plans in high gear. We have a whole world to make Green.

Therefore, GALT Motor and the Electric Jet Engine, both can be used to replace all of the Internal Combustion Engines, that are in existence everywhere in the world; in every application. Note that the Electric Jet Engine would replace the currently used Jet Engine totally. And between these two inventions, mankind would no longer have any need for Nuclear Energy. We will help shut down all of the Nuclear Reactors everywhere in the world; including Japan.

One of my plans when I get released, is to build a series of Conversion Centers; everywhere in the world. I have many ideas. For example this technology can be used to replace the Nuclear Reactors in the Naval Subs and Ships. We can create a whole new class of weapon systems for the armed services. Drones with endless range, armed with new Laser Weapon systems. Moving forward with this technology is very important, because there is about to be a rush of competition to see who starts to use it first as this is what I will get done one way or another.

The bottom line is we have literally a Billion things to convert on this planet, as we can convert every piece of machinery in the entire world; all while creating millions of jobs in the process. I'm ready to get started as soon as possible.

I know for a fact that the U.S. Patent Office will not let anyone Patent any device that is claimed to be Perpetual Motion (see my friend's website "JosephNewman.com"); therefore, I could, either use some political help in securing a US Patent, or we will have to take this technology and Patent it overseas; but for now we can enter into contracts to protect my concepts. I now have written President Trump about the GALT Motor, even before, he announced that he was running for office. I know for a fact that President Trump would be interested in all of my technology; we just have to show him that this is real. I have also applied at the "In-Q-Tel.org" organization. This is a front for the CIA. Check it out. They have not responded to me.

I have a dream and a vision. I know that I have to work with a Talk Show again, as that is how I became so successful in the past. I have Hosted over 1,200 Talk Shows. I have now, already been in touch with seven talk shows, just recently; even from prison.
