HELP NEEDED TO LOCATE PERSONS WHO WERE WITNESSES AT LAZOR'S TRIAL

It would be a big help if anyone could locate the following individuals who had some connection to Lazor's trial and conviction, and could be helpful if they only knew he is still lingering in prison 35 years later. Los Gatos, California, last known location.

MORE INFO ON LAZOR'S CASE

- 1. No one in California history, 1850 to date, has ever been kept in prison like this, for so long, who was ACQUITTED of First degree murder, and has zero crime history and much to the contrary as a stalwart member of his community.
- 2. Two independent judges, 10 years apart, independently have researched his case record and stated in court orders that this case was one of apparent genuine self-defense.
- 3. Lazor was a pillar of his community and had fought against crime all of his adult life.
- 4. Following his efforts while in prison in 1984 to have his prosecutor arrested and jailed for framing him for murder, he began being targeted by prison guards for brutality, sexual harassment, violent murder, 33 years of ongoing false misconduct reports, torture, forced drugging like USSR/China prisoners, and came close to dying 13 times. It was doubtful if he could be brought back from total starvation and dehydration by his captors, and abused in 100's for other ways like no other prisoner in Cal. History.
- 5. Other than the self defense shooting He has NEVER, NOT ONCE IN HIS LIFE committed even the slightest act of violence, and not even a mildly anti-social nor destructive act against anyone or anything from birth to the present.
- 6. He would have been butchered to death on 1-10-83 had he not acted and shot the rage-filled violent attacker, Allred.
- 7. His supposed "Defense Attorney", Wesley Schroeder, worked ver hard and effectively with his prosecutor and police "buddies" to frame him and send him to prison.
- 8. His mandatory release date from prison with his sentence fully served was May 1, 1992.
- 9. Maliciously, behind Lazor's back and without his knowledge, in secret hearings Lazor was not allowed to attend, Schroeder colluded with the prosecutor in the presence of the judge to secretly WITHDRAW ALL JURY INSTRUCTIONS OF INVOLUNTARY MANSLAUGHTER, and standard required SELF-DEFENSE JUSTIFIABLE homicide verdict instructions, and totally blacked out all reference to SUDDEN QUARREL IN or HEAT OF PASSION on all VOLUNTARY MANSLAUGHTER VERDICT NSTRUCTIONS, thereby removing them from jury consideration whatsoever. This meant the jury was NOT ALLOWED TO CONVICT HIM OF INVOLUNTARY nor VOLUNTARY MANSLAUGHTER. (2-3 years, or 4-6 years sentence respectively. Nor were they able to ACQUIT IN SELF-DEFENSE WTHOUT INTENT TO KILL. All 3 of these were promised to Lazor that this was the very reason for having a trial to reduce any sentence.

10. The jury was left with the choice of convicting Lazor for either 1st or 2nd degree murder. The jury acquitted him of 1st degree, and settled on their only other choice of 2nd degree murder

Lazor would ask of the dispatchers Joan and Harriet 3 things:

- 1) If you could come to know, absolutely, with 100% certainty of Lazor's innocence after given the truthful facts, a) Would you care? b) Would you cooperate in doing something about this injustice?
- 2) I would ask that they go to his website <u>www.free-lazor.org</u> and diligently read first the 35/52, and thereafter the letters, affidavits and declarations of support about his character, credibility, life history, and what he did for society, etc.
- 3) To deeply ponder what it means to have his whole life stolen by this fraudulent farce of a "trial", not only these 35 years since you last saw him, but also his whole future which now could never come close to being what he had planned for this life. And to consider all he had invested for his future, and now having bypassed all the potential joys, and irretrievable experiences of his youth. All was completely and permanently destroyed by this frame-up and theft of his entire life. And now the system mercilessly set aside his next Parole Hearing for
